(f) Discussed increasing signing authority to \$50k

Read comment from Phil DeZutter in support of having employees of elected boards report to TM.

If the committee decides to recommend that all employees report to TM, then similar changes would need to be made in other sections, for example, Section 4(g).

3. Discussion with Select Board Member Brett Simas on issues he feels need to be addressed:

- Town Manager model makes sense for Upton.
- Views TM as CEO. Enhances the operation of the town.
- Employees of Elected Boards should be under the supervision of a person who has expertise in overseeing employees and who can provide daily management of staff.
- His opinion is that all town employees should be under purview of TM
- A professional should oversee employees including disciplining and performance reviews.
- TM can provide coaching, training, setting goals, etc. to all town employees.
- \$25k signing limit is okay
- Provide voters information to make an informed decision about changes that could be made to reporting structure

Committee discussed inviting elected boards to meet to discuss issues related to employees.
