

## TOWN CLERK'S REPORT.

UPTON RECORDS, 1930.

### WARRANT FOR ANNUAL TOWN MEETING, FEBRUARY 3, 1930.

*Worcester, SS.*

To the Constable of the Town of Upton, in the County of  
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday, the third day of February, 1930, punctually, at six o'clock forenoon, then and there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, three Selectmen, Town Treasurer, Collector of Taxes, Auditor, five Constables, Tree Warden and one Trustee for the Public Library (to fill a vacancy caused by the removal from town of David Berman), all for one year; one Assessor of Taxes, one Member of the Board of Public Welfare, one Cemetery Commissioner, one School Committee and three Trustees for the Public Library, all for three years; all on one ballot.

The polls shall be closed at four o'clock in the afternoon on said day of meeting.

In accordance with Section 1, Article 1, of the By-laws of the Town of Upton as amended February 12, 1923, the remaining articles of this warrant will be acted upon at an adjourned meeting of the Town held Saturday afternoon, February 8th, at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and act thereon.

Article 4. To see if the town will vote to authorize the town treasurer, with the approval of the selectmen, to borrow money in anticipation of revenue of the present municipal year.

Article 5. To see if the town will vote to appoint a committee of three to get estimates of cost for the purchase of a piece of land and the erection thereon of a building to house the road equipment, tools, etc. owned by the town and report at some future town meeting, or act thereon.

Article 6. To see if the town will vote to appoint a committee of three to get estimates of cost of a suitable piece of land for a town dump and report at some future town meeting, or take any action thereon.

Article 7. To see if the town will vote to appropriate the sum of nine hundred (\$900.00) dollars to build a cement bridge over Mill brook on Grove Street, provided the County and State will each give a like amount or more, or act in any manner pertaining thereto.

Article 8. To see if the town will vote to appropriate the sum of two hundred (\$200.00) dollars to buy uniforms and other equipment for the Police Department, as petitioned

for by Fred W. Wood and others, or act in any manner pertaining thereto.

Article 9. To see if the town will vote to place four street lights on Fowler Avenue, and appropriate seventy dollars for the same, as petitioned for by Guy E. Davidson and others, or act thereon.

Article 10. To see if the town will vote to appropriate the sum of five hundred (\$500.00) dollars for the removal of rocks, filling of mud holes, grading and improving the children's playground at the George S. Ball school, as petitioned for by Maude E. Hilliard and others, or take any action thereon.

Article 11. To see if the town will vote to appropriate the sum of one thousand (\$1,000.00) dollars to provide an adequate water supply for the High School, or take any action thereon.

Article 12. To see if the town will vote to lease the Town Farm for a trial period of two years and board inmates in other institutions, as recommended by the Finance Committee, or act in any manner pertaining thereto.

Article 13. To see if the town will vote to appropriate from available funds any sum of money to pay outstanding debts, or take any action thereon.

And you are directed to serve this Warrant, by posting up attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the post offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE ANNUAL TOWN MEETING,  
FEBRUARY 3, 1930.

COMMONWEALTH OF MASSACHUSETTS.

*Worcester, SS.*

Pursuant to the foregoing warrant, the legal voters of the Town of Upton met in the Town Hall in said Upton, on Monday, the third day of February, 1930. The meeting was called to order at six o'clock A. M. by the town clerk, who then read the warrant and the officer's return thereon.

TOWN OFFICERS.

Article 1. The selectmen having appointed Henry E. Allard, Edwin A. Chamberlain, William J. Gorman and Harry C. Snow election officers, they were duly sworn to faithfully perform the duties of the office by the town clerk.

Cards of instruction and specimen ballots having been posted as the law directs, a package said to contain 1000 official ballots, to be used at this election, was delivered to the ballot clerks.

The ballot box was then shown to the voters present to be empty, the index being set on 0000, it was locked and the keys thereof were given to Herbert A. Bagley, constable in attendance at said meeting.

The polls were declared open at six o'clock A. M.

The following persons having been appointed by the selectmen to canvass the vote, Eleanor B. Adair, Margaret A. Gurry, George G. Newton and Edwin W. Sadler, they were duly sworn by the town clerk.

At the close of the polls, the register on the ballot box stood at 602. The check-lists were compared and showed that 602 had voted.

To the Voters of Upton:—All Departments and Committees of Upton have been granted hearings by the Finance Committee, at which practically all of them have submitted reports, covering the year 1929, and budgets of their requirements for the year 1930. The 1930 requirements of each department and committee have been given careful consideration, and in the right hand column of the following tabulation are the recommendations of the Finance Committee for 1930, which are put in the form of Motions which are hereby made

to be presented at the Town Meeting in February. In the two left hand columns are the appropriations and expenditures for 1929.

## PROCEEDINGS OF THE ADJOURNED TOWN MEETING, FEBRUARY 8, 1930.

The meeting was called to order by David J. Moroney,  
Moderator.

### REPORTS OF TOWN OFFICERS.

Article 2. Voted: on motion of Samuel B. Young, to  
accept the reports of town officers as printed.

### APPROPRIATIONS.

Article 3. Voted: that the appropriations as recommend-  
ed in the report of the Finance Committee be taken up and

acted upon separately. Voted: to make the following appropriations:

Voted: on motion of Eben T. Hall, to appropriate the sum of two hundred (\$200.00) dollars to be used for repairing town buildings and removing watering-trough in Central Square.

In voting on the appropriation for Forest Fire Warden, Mr. Charles L. Woodman, District Forest Warden, spoke urging the need of equipment to provide better protection for the woodland of the town. He said that of Upton's 10,000 acres, 6,000 were woodland, much of this fit for nothing else, and might be worth \$200 to \$500 per acre if protected from fire. When questioned, he said that an appropriation of \$2,000.00 would buy a portable power pump, hose, truck and accessories, the needed equipment for the fire warden.

#### BORROWING MONEY.

Article 4. Voted: that the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the municipal year, beginning January 1, 1930, to an amount not exceeding in the aggregate \$30,000.00 and to issue a note or notes therefor, payable within one year, and debt or debts incurred under this vote to be paid from the taxes of said municipal year.

#### BUILDING FOR ROAD EQUIPMENT.

Article 5. Voted: to appoint from the floor, a committee of three to get estimates of cost for the purchase of a piece of land and the erection thereon of a building to house the road equipment, tools, etc., owned by the town and report at some future town meeting. The following committee was appointed: Eben T. Hall, Benjamin C. Wood, Samuel B. Young.

## TOWN DUMP.

Article 6. The motion as first made to appoint a committee of three to get estimates of cost of a suitable piece of land for a town dump was amended to read "town dumps, one in each village."

Voted: to appoint a committee of three to get estimates of cost of suitable pieces of land for town dumps, one in each village, and report at some future town meeting.

Voted: that the same committee appointed under Article 5, serve also for this Article.

## CEMENT BRIDGE ON GROVE STREET.

Article 7. Voted: on motion of Eben T. Hall, to appropriate the sum of nine hundred (\$900.00) dollars to build a cement bridge over Mill brook on Grove Street, provided the County and State will each give a like amount or more.

## UNIFORMS FOR POLICE.

Article 8. Fred W. Wood made a motion that the sum of two hundred (\$200.00) dollars be appropriated to buy uniforms and other equipment for the Police Department. The motion was lost. A rising vote was taken: Yes, 53; No, 55.

## LIGHTS ON FOWLER AVENUE.

Article 9. A motion to pass over the article was defeated, Yes, 25; No, 56. Voted: to place four street lights on Fowler Avenue and appropriate seventy dollars for the same.

## PLAYGROUND AT GEORGE S. BALL SCHOOL.

Article 10. Voted: to appropriate the sum of five hundred (\$500.00) dollars for the removal of rocks, filling of mud

holes, grading and improving the children's playground at the George S. Ball school.

#### WATER SUPPLY FOR HIGH SCHOOL.

Article 11. Voted: to appropriate the sum of one thousand (\$1,000.00) dollars to provide an adequate water supply for the High School.

#### LEASING THE TOWN FARM.

Article 12. Mr. William T. Teachout spoke at length concerning different methods of caring for the poor. He gave a survey of conditions here and throughout the State, proving his statements with statistics and comparisons. Only four other towns in the State are running a farm for so few inmates as Upton. He presented the following motion: "Moved: that the Selectmen be authorized to instruct the Board of Public Welfare to have the inmates of the town infirmary cared for in some approved institution and make such disposition of the Farm for a trial period of two years as they may deem most advisable."

Much discussion followed, Charles Childs and others speaking. A rising vote was taken: Yes, 28; No, 59, defeating the motion.

#### RETIRING NOTE.

Article 13. A motion to retire the indebtedness of the town was amended to retire the note due in 1932.

Voted: to appropriate from available funds the sum of three thousand (\$3,000.00) dollars to pay the note due in November, 1932.

On motion of George G. Newton, a rising vote of thanks was extended to George W. Knowlton, Jr., for his gift to the town of a road grader.

Voted: to raise the sum of \$62,410.60 by taxation.

Voted: to adjourn and dissolve the warrant.

Parents and others are requested to carefully examine the above lists and if any errors or omissions are discovered report them at once to the town clerk, that the record may be corrected, as it is of importance that the records of Vital Statistics should be complete. Herewith are extracts from the General Laws, Chapter 46.

GENERAL LAWS, CHAPTER 46, SECTION 3.

(As Amended by Chapter 231, Section 1, Acts of 1925).

Every physician, or hospital medical officer registered under section nine of chapter one hundred and twelve, in this chapter called officer, shall keep a record of the birth of every child in cases of which he was in charge, showing date and place of birth, the name, if any, of the child, its sex and color, the name, age, birthplace, occupation and residence (including the street number, if any, and the ward number, if in a city) of each parent, the maiden name of the mother and the name of the physician or officer, if any, personally attending the birth. If the child is illegitimate, the name of, and other facts relating to the father shall not be set forth except upon written request of both the father and mother; provided, that if an illegitimate child shall have become legitimate by the intermarriage of his parents and the acknowledgment of his father, as provided in section seven of chapter one hundred and ninety, prior to the mailing or delivery of any report herein required, such report shall read, in all respects, as if such child had been born to such parents in lawful wedlock. Said physician or officer shall, within fifteen days after such birth, mail or deliver to the clerk or registrar of the town where such birth occurred, a report stating the facts hereinabove required to be shown on said record and also the said written request, if any; provided, that if said report is not so made within forty-eight hours after such birth, said physician or officer shall, within said

forty-eight hours, mail or deliver to said clerk or registrar a notice stating the date and place of the birth, the street number, if any, the ward number, if in a city, and the family name. Upon presentation to him of a certificate of the town clerk stating that any such birth has been duly reported, the town treasurer shall pay to such physician or officer a fee of twenty-five cents for each birth so reported. Any physician or any such officer violating any provision of this section shall forfeit not more than twenty-five dollars. The said town clerk or registrar shall file daily with the local board of health a list of all births reported to him, showing, as to each, the date of birth, sex, color, family name, residence, ward and physician or officer in charge.

GENERAL LAWS, CHAPTER 46, SECTION 6.

Parents, within forty days after the birth of a child, and every householder, within forty days after a birth in his house, shall cause notice thereof to be given to the clerk of the town where such child is born \* \* \*.

Blanks may be obtained upon application to the town clerk.

#### TOWN TREASURER'S STATEMENTS.

There is deposited in the Milford Savings Bank, known as the Knowlton School Fund, in trust with the Town Treasurer as trustee, \$26.48, to be used by the School Committee to defray the extraordinary expenses of the Knowlton School Building.

There is deposited in the Milford Home National Bank, known as the Ella (Whitney) Risteen Fund, in trust with the Town Treasurer and School Committee as Trustees, one thousand dollars, (\$1,000.00) the income to be divided between the two pupils in our public schools who make the most progress during each year. The amount of this Fund, Jan. 1, 1931, \$1,013.75.

There is deposited in the Worcester County Institution for Savings, known as the Charlotte A. Batchelor School Fund, in trust with the Town Treasurer as trustee, five thousand (\$5,000.00) dollars, the income to be used for the Public Schools. One hundred and twenty-five (\$125.00) dollars of this income was used this year.

There is deposited in the Milford Savings Bank, known as the Charlotte A. Batchelor Library Fund, in trust with the Town Treasurer as trustee, five thousand dollars (\$5,000.00) the income to be used for the Public Library. Two hundred fifty (\$250.00) dollars of this income was used this year.

There is deposited in the Milford Savings Bank as a nucleus of a fund for a library building, as voted by the Town, February 7, 1925, the sum of \$2,088.29.

There is deposited in the Milford Home National Bank, the sum of five thousand (\$5,000.00) dollars, known as the "George W. Knowlton Fund." This Fund is subject to withdrawal by the Town Treasurer. The income only to be used to help the Townspeople who are in distress.

There has been drawn on this fund this year, \$125.00. Total of this fund as of Jan. 1, 1931 is \$5,555.72.

#### LIBRARIAN'S REPORT.

##### TO THE TRUSTEES OF THE UPTON LIBRARY:—

The librarian herewith submits her annual report following which are library statistics and the catalog of new books.

During the year books have been purchased and added to the "Dr. Carpenter Alcove" as required.

The money collected for fines, amounting to \$10.52, has been paid to the town treasurer, as the law requires.

During March a set of pictures showing Costumes of Europe and in October pictures of the Yellowstone National Park were on display at the Library. Both collections were loaned by the Woman's Education Association of Boston.

During "Book Week" in November there was an exhibit of about fifty new books for children. State Reading Certificates were issued to: Alice Cobbett, Phyllis Wiggin, Margaret Walters and Howard Leland. Honor Certificates for reading twenty books, five of which were non-fiction, were given to Evelyn Fiske, Beatrice Prentiss, Dorothy Taft and Henry Stearns.

The branch library in West Upton was discontinued in September.

The new stack that has been placed in the library gives an opportunity to re-arrange the present collection of books and allows some room for growth.

For the many children who use the library there is needed a table and chairs the proper size for their use where they might have their magazines and look at their books.

As the new book-case makes the stacks rather crowded and a table for children would take up floor space in the reading room, the need of a centrally located library building where there would be space both for stacks and a reading and reference room is apparent.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS.

TO THE SCHOOL COMMITTEE OF UPTON:—

I take pleasure in presenting to you my tenth annual report.

### ATTENDANCE.

School opened in September with the largest attendance that there has been for some years as will be seen by the accompanying table.

There has been an increase of 56 pupils since 1926, or 18 per cent, but as the additional pupils have been well divided among the different grades, no serious crowding has resulted.

## REPAIRS.

This year the roof at the Knowlton schoolhouse has been repaired and the eaves have been reflushed to prevent the backing-up of the water and consequent leaks which have been discoloring and destroying the ceilings for a considerable time. The water from the roof now drips upon the ground and as soon as possible a strip of cement should be placed around the building to deflect this water away from the foundations.

The basement of the Ball Schoolhouse has been repainted by Mr. Crooker. Through a special appropriation the High School has been finely equipped with electric lights.

The buildings are in good repair outside but, to keep them so, there will be needed soon the following:

Repairs to walk from the street up to the High School, completing to the place where repairs were made two years ago.

A coat of paint on the stairs, trimmings, etc., at the Ball School.

Inside there is still need of desk replacements and re-finishing at both the Knowlton and High schools. The Knowlton schoolhouse is the only one without electric lights and these should be put in as soon as funds are available.

## WATER SUPPLY.

We were very fortunate in getting a very copious supply of water at the High School after drilling to a depth of about 125 feet. The well filled to about 20 feet of the surface and thus far there has been no difficulty in pumping the water with the surface pump which we already had. If this is possible at the close of one of the most protracted droughts on record it would seem safe to assume that the supply can be kept up during normal times.

### HOUSEHOLD ARTS ROOM.

We are indebted to the Upton Women's Club for a gift of \$100.00 toward the equipment of a household arts room. This sum together with a balance from the appropriation for the high school well, which the Town voted to use for this purpose, and a small amount from the school appropriation has made it possible to partition off a room in the basement and equip it for the purpose of teaching cooking and sewing to the girls. It should be added that it would not have been possible to complete this room without the expenditure of considerably more money but for the work of Mr. Crooker, who has done all the painting and much of the carpenter work. Mrs. Hall has also put in much time and has secured a very adequate equipment at a very small cost.

Mr. Robinson, in his report, explains the plans for the use of the room.

### TESTS.

Last spring the New Standard Achievement Tests, form V, were given and the results showed, on the whole, good progress in the school work. The tabulation of results follows:

## TEACHERS.

Mr. Atkinson, who has been principal of the high school for six years, resigned during the summer. He was a very efficient teacher and administrator and left his school in good condition, both in spirit and achievement. We were fortunate in securing the services of Charles M. Robinson, who has a record of successful experience and who has taken up the duties with excellent promise of success.

Upton is much more fortunate than most small towns in its comparatively small change in teachers from year to year. Except Miss Campbell, who took Miss Prendergast's place last September and who has excellent preparation for her work, all our present teachers have been with us at least two years. Mrs. Dearth, the inspiring teacher of English, is now in her twelfth year of service; Miss Urban, conscientious teacher and efficient principal of the Ball School, has been here eighteen years. Miss Walker, seventeen years; Mr. Stanley, eighteen years; Mrs. Goodrich, nine years; Mrs. Brokaw, ten years; Mrs. Alexander, eleven years. The others have been with us from two to five years each. All these teachers are progressive and rendering excellent service.

## SCHOOL SAVINGS.

In April, 1926, the present plan of school savings, sponsored by the Grafton Savings Bank, was begun. While the weekly percentage of depositors—which is obtained by continual stressing and stimulation—is not as large as some schools have, a very large percentage of all the pupils have accounts and deposit with a reasonable degree of regularity;

the methods now used will help some to establish habits of frugality. Below is a tabulation of percentages and amounts:

The total is \$485.11 more than was received from the same sources during 1929. The town appropriated \$25,000 for schools. Subtracting the \$9,736.16 leaves \$15,263.84, the amount that comes from local taxation.

## DRAWING.

## MISS BALL REPORTS:

"The drawing apparently goes along in its quiet way, trusting that its impressions may leave a good and lasting influence for greater usefulness and beauty appreciation.

"There are two significant facts about the pupils in the elementary grades. 1. There are pupils of all types and abilities; 2. There are no reliable clues as to what occupation they will follow when leaving school. Present education is attempting to meet these conditions by (1): trying to meet every pupil on his own level; (2): fostering habits and skill which are valuable to all, regardless of professions or trade.

"The present art teaching indicates a supposition that every person does have esthetic interest and that these interests, developed, provide great and dependable satisfaction.

"Design is the important factor in the elementary school work and ought to enter into every problem, not once a week or twice, but at all times. If a margin improves the looks of

a paper, it should make its appearance on all papers and not only on the papers done in the art class.

"Testing for art judgment is being considered in all art courses. The test subjects comprise: furniture, utensils, textiles, clothing, architecture and painting. These subjects were selected from the common objects in everyday life. All art work should tend to help pupils to put into practice this judgment.

"My plea is that the teachers may recognize the real value of art and be able to correlate it with any and all school subjects.

"I trust the coming spring will find us ready and willing for an exhibition to be put on at the close of the school year. This will not be especially prepared but an effort to show good honest work accomplished through the regular time allotted to such work in the school curriculum."

#### MANUAL TRAINING.

##### MR. STANLEY REPORTS:

"Because of the limited time available for this work, it has to continue on practically the same lines each year. We vary the articles constructed but the same exercises must be taught in the usual order. The seventh and eighth grades each have one afternoon in two weeks. We can accommodate sixteen boys at the benches but there are nineteen boys in the seventh grade. This makes matters rather difficult as some boys have to wait at their benches until they can get a chance to use the tools. However, we have a fine large room. The only thing we need is electric light for cloudy days and we have had more cloudy than fair weather on the days the boys have Manual Training.

"The classes are interested in the work and I feel encouraged with the results obtained. Our work-shop is always open to visitors on Manual Training days. We have welcomed some callers during the past year and cordially invite any or all to visit us while at work on any Thursday afternoon."

"In May and June we had a drive for annual examination of teeth by their dentist, 47 pupils received Dental Certificates.

"On June 3, in connection with Child's Health Day a Tercentenary Pantomime was given by pupils from all grades on the Play Grounds.

"On June 19, our pre-school clinic was held. Eighteen children were examined by Dr. Susan Coffin, assisted by Mrs. Helen Hackett, R. N., Public Health Consultant, Mrs. Eleanor McCarthy, Dental Hygienist, Mrs. Evelyn Smith, Nutritionist, Miss Edith Holcomb, R. N. and the school nurse.

"Advice was given to the mothers about general care, forming good health habits, diets and care of teeth.

"Defects were noted, and parents were asked to have same corrected, if possible before entering school. These cases were followed up by Miss Holcomb during the summer vacation, and continued by school nurse."

## REPORT OF THE HIGH SCHOOL PRINCIPAL.

---

### TO THE SUPERINTENDENT OF SCHOOLS:

I hereby submit the annual report of the Upton High School for the year ending December 31, 1930. This report will be confined mainly to the school since I came on September 1.

### MEMBERSHIP.

School opened this Fall with a slightly larger enrollment than last year. As the main hall would not accommodate all the students, the twenty-four eighth grade pupils were put into Room 2 for their home room. This provided a separate seat for each of the 81 pupils in the four high school classes. Downstairs, the seventh grade has 28 pupils, while the sixth consists of 38 boys and girls.

### ATTENDANCE.

We have been fortunate in having very little sickness so far this school year, thereby reducing absences to a minimum. As there is no denying that absences cause retardation in school progress, no pupil should be absent unless absolutely necessary. The following are the percentages of attendance for the past four months:

## DOMESTIC SCIENCE DEPARTMENT.

The high school is deeply indebted to the Women's Club for their generous donation to the new Domestic Science department. With this as a beginning, a room was built in the northeast corner of the girls' basement. Part of this space was formerly used as a coal bin, but this coal was moved to a new bin.

We are also very grateful to Mr. Crooker, who, with his helper, painted the walls, floor and tables; built the sink, blackboard and bulletin board; and did numerous other necessary tasks in making an attractive and useful room.

The electric range used by the cooking classes was donated by the Worcester Suburban Electric Light Company.

In planning the Clothing and Food Courses, we have had the expert advice and supervision of Miss Coss and Miss French, instructors in the Framingham Normal School. From this school we are given a student teacher for two days a week, which has been ample time to arrange classes for not only the 7th, 8th and 9th grade girls, but also all upper grade girls who wish to elect cooking.

We are extremely fortunate in having as teacher for the first half of this year, Miss F. Doris Gorman of Milford, who has submitted the aims and details of her Clothing and Food Courses:

"The aim of the Clothing course is to present a few practical clothing construction problems to the pupils.

"The girls who are to have Food lessons, first make their uniforms—aprons, caps, holders and towels. This project gives an opportunity to introduce basting, hemming, back-stitch and outline stitch. The class is then ready for a course in mending and darning, followed by a more advanced problem such as slips, pajamas and simple dresses.

"The 7th grade in following this course as closely as possible, have made towels, table runners and needle books.

"The Food classes are all planned on the meal basis and emphasis is given to the nutritional value of the dishes prepared as well as instruction in their preparation.

"The 8th grade prepare various dishes suitable for a well balanced breakfast and, at the end of the breakfast unit, actually serve a breakfast inviting one outside guest to their meal. After completing the breakfast unit this class will study suppers in the same way.

"The Freshmen and upper class girls study luncheons and serve a luncheon at the close of their first unit and will take up dinners for their second project.

"The objectives of the instruction in the food classes are:

1. To develop skill in cookery.
2. To give the girls a knowledge of properly balanced meals.
3. To teach the girls how to set the table and serve a meal attractively.
4. To train the girls in good housekeeping habits."

Parents and friends are cordially invited to visit any of these classes which are held all day Thursdays and Fridays. All who have inspected the room have remarked concerning the marvelous way in which the basement and coal bin have been transformed into an attractive, useful domestic science room.

#### RECREATION.

A few new playground facilities were added this Fall. A volley ball court was constructed for the girls and a new volley ball purchased for their use. A new soccer ball was also procured for the boys. The outdoor basket ball goals and backboards were repaired and a new goal was installed, thus providing ample opportunity for both boys and girls to play basket-ball.

A girls' basket ball team has been organized under the direction of Miss Campbell, and games have been arranged with high schools in several surrounding towns. The girls use the town hall for practice two afternoons a week, while the boys have practice the other three afternoons.

The selectmen have graciously given the high school the use of the town hall for the afternoon practices, and charge but a nominal sum when heat and light are required for games. As the town has no school gymnasium, I would recommend that provision be made in the school budget for taking care of heating and lighting the town hall for the high school pupils during the winter months of December, January and February. How much better it is for these young people to be learning clean sport under proper supervision than to be hanging around the street corners with no definite purpose.

#### ELLA WHITNEY RISTEEN AWARDS.

It is with great pleasure we announce that Mrs. Ella Whitney Risteen of Hartford, Conn., formerly of Upton, has donated one thousand dollars, the annual income of which is to be divided between the boy and girl in the graduating class who have shown the greatest improvement in the four years of high school. I quote from Mrs. Risteen's presentation of the gift:

"I am of the class of 1883. Forty-seven years is a good while to have been away, carrying out the principles we learned here in school.

"For a long time it has been my earnest wish to express in a tangible form my appreciation of, and the affection for, my native town of Upton. In pursuance of this desire I now present to my Alma Mater, the Upton High School, this check as a Scholarship Prize Fund, the income of which is to be divided into two equal parts. They are to be known as the

Ella Whitney Risteen Scholarship Prizes, and are to be presented at Commencement, annually, beginning next year, 1931, to the young woman and the young man, who, in the judgment of the faculty of the Upton High School shall have made the most outstanding record of progress during the full course.

"Advancement and progress do not always mean, to me, the winning of the greatest number of 100 marks or A's, according to the system used in marking, but conscientious effort, hard work and general achievement,—these to me are the most telling standards.

"It is with sincere pleasure, Mrs. Hall, that I present to you, as chairman of the Upton School Committee, this check for one thousand dollars, to be used as stated."

In closing I wish to express my appreciation to the school committee, the superintendent, teachers and parents for their hearty cooperation during the past four months. It has been indeed a pleasure to work with a group of people who are all trying to make the Upton High School a great factor in the improvement of the young people of this community. We are endeavoring, not only to impress some fundamental knowledge on the minds of our students, but we also have at heart that much more important duty of molding the characters of these future citizens.
