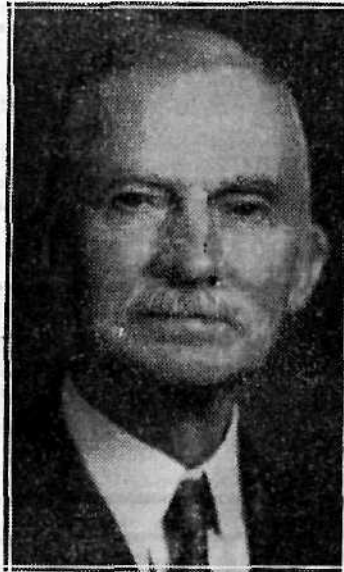

TOWN CLERK'S REPORT.

WARRANT FOR ANNUAL TOWN MEETING,

FEBRUARY 6, 1939.

THE COMMONWEALTH OF MASSACHUSETTS.

Worcester, SS.

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the Town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday, the sixth day of February, 1939, punctually at seven o'clock, A. M., then and there to act on the following articles, to wit:

Article 1. To choose all necessary town officers for the ensuing year: Moderator, Town Treasurer, three Selectmen, Collector of Taxes, Auditor, Road Commissioner, five Constables and Tree Warden, all for one year; One Assessor of Taxes, One Member of Public Welfare Board, One Member of the School Committee, One Cemetery Commissioner and Three Trustees of the Public Library, all for three years.

Also to act on the following question in accordance with Chapter 127, Acts of 1938, "Shall an act passed by the General Court in the year nineteen hundred and thirty-eight, entitled 'An Act to authorize the placing of the office of chief of police of the town of Upton under the civil service laws' be accepted?"

All of the above to be voted for upon one ballot.

The polls shall be closed at six o'clock in the afternoon on said day of the meeting.

In accordance with Article 2, Section 1 of the By-Laws of the Town of Upton the remaining articles of this warrant will be acted upon at an adjourned meeting of the Town held in the Town Hall, Saturday afternoon, February 11, at two o'clock.

Article 2. To hear the reports of all town officers, and act thereon.

Article 3. To hear reports of any committees appointed by the town.

Article 4. To raise such sums of money as may be necessary to defray town charges for the ensuing year, or act thereon.

Article 5. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1939, and to issue a note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 6. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2000.00) for further improvement of Mendon Road, said money to be used in conjunction with any money which may be allotted by the State or County, or both, for this purpose; or take any action in relation thereto.

Article 7. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2000.00) for improvement of Pleasant street, also known as Northbridge Road, said money to be used in conjunction with any money which may be allotted by the State or County, or both, for this purpose; or take any action in relation thereto.

Article 8. To see if the Town will vote to raise and appropriate Seven Hundred Dollars (\$700.00) for Chapter 90 Maintenance; said money to be used in conjunction with any money which may be allotted by the State or County, or both, for this purpose, or take any action in relation thereto.

Article 9. To see if the Town will vote to raise and appropriate Fifteen Hundred Dollars (\$1500.00) to be used under the direction of the Selectmen for materials, truck hire, and administration of WPA projects, or take any action in relation thereto.

Article 10. To see if the Town will vote to raise and appropriate Five Hundred Twenty Dollars (\$520.00) to be used toward the settlement of an Industrial Accident Board decree in the case of Laura Walker, administratrix of the estate of Samuel Walker, against the Town of Upton, or take any action in relation thereto.

Article 11. To see if the Town will vote to raise and appropriate the sum of One Thousand Three Hundred and Ninety-two Dollars and Twenty-four Cents (\$1392.24) for 1938 unpaid bills, of Chapter 81 highway work, or take any action in relation thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of One Hundred Fifty-two Dollars and Forty-five Cents (\$152.45) for 1938 unpaid bills of Chapter 90 highway work, or take any action in relation thereto.

Article 13. To see if the Town will vote to adopt a system of checks and balances to prevent a recurrence of overdrafts in town departments as petitioned for by Malcolm C. Temple and others, or act in any manner pertaining thereto.

Article 14. To see if the Town will vote to raise and appropriate a sum of money for the purpose of appointing a night police officer for patrol purposes, said officer to be ap-

pointed by the Selectmen, as petitioned for by LeRoy W. Prentiss and others, or act in any manner pertaining thereto.

Article 15. To see if the Town will vote to raise and appropriate a sum of money for the purpose of installing steam heat and modern toilets in Grand Army Hall building, as petitioned for by Harrison E. Bates and others, or act in any manner pertaining thereto.

Article 16. To see if the Town will vote to change the name of West Street, now commonly called Glen Avenue, to Glen Avenue, from Main Street opposite Mechanic Street, around Zachary pond to Pleasant Street, or act in any manner pertaining thereto.

Article 17. To see if the Town will vote to raise and appropriate One Hundred Dollars (\$100.00) to be expended under the direction of the Selectmen in the purchase and setting of an appropriate blue spruce community tree on Upton Common, Central Square, as petitioned for by William T. Teachout and others, or act in any manner pertaining thereto.

Article 18. To see if the Town will vote to appoint a committee, comprising the three members of the School Committee, the Chairman of the Finance Committee, the chairman of the Board of Selectmen, and two members to be appointed by the Moderator, to make a thorough study of school housing accommodations and report at a future town meeting, as requested by the School Committee, or take any action in relation thereto.

Article 19. To see if the Town will vote to raise and appropriate a sum of money for the necessary expenses of a special committee on school housing accommodations, said money to be used in obtaining expert advice and preparations of plans as requested by the School Committee, or act in any manner pertaining thereto.

Article 20. To see if the Town will vote to raise and appropriate the sum of One Thousand Two Hundred Dollars (\$1200.-00) to be used with any WPA allotment of money that may be received, for the construction of new bleachers, tennis courts, repairs to the baseball field, and other necessary improvements as called for in the project, as petitioned for by Howard R. Leland and others, or act in any manner pertaining thereto.

Article 21. To see if the Town will vote to establish the salary of milk inspector, or act in any manner pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate Fifteen Hundred Dollars (\$1500.00) for repairs and improvements to the Town Infirmary buildings as a result of damage done by the hurricane storm, said money to be used in conjunction with any WPA allotment of money which may be granted to the town, or act in any manner pertaining thereto.

Article 23. To see if the Town will vote to raise and appropriate One Thousand One Hundred and Seventy-seven Dollars (\$1177.00) for repairs and improvements to Town Hall building as a result of the hurricane storm, said money to be used in conjunction with any WPA allotment of money which may be granted to the town, or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to raise and appropriate a sum of money for repairs and improvements to Grand Army Hall building as a result of the hurricane storm, said money to be used in conjunction with any WPA allotment of money which may be granted to the town, or act in any manner pertaining thereto.

Article 25. To see if the Town will vote to raise and appropriate a sum of money for repairs and improvements to

the High School building as a result of the hurricane storm, said money to be used in conjunction with any WPA allotment of money which may be granted to the town, or act in any manner pertaining thereto.

And you are directed to serve this Warrant by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-Offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF THE ANNUAL TOWN MEETING,
FEBRUARY 6, 1939.

COMMONWEALTH OF MASSACHUSETTS.

Worcester, SS.

Pursuant to the foregoing warrant, the legal voters of the Town of Upton met in Town Hall in said Upton, on Monday, the sixth day of February, 1939. The meeting was called to order at seven o'clock, A. M. by Moderator David J. Moroney, and the warrant and officer's return thereon was read by the town clerk.

On motion of Henry E. Allard the reading of articles calling for appropriations and special questions was waived.

Article 1. Kenneth W. Wood, Patrick J. Slattery, Henry E. Allard and Randolph Cooper having been appointed as election officers, with Edwin B. Houghton in charge of the ballot box, were duly sworn by the town clerk.

Cards of instruction and specimen ballots having been posted as the law directs, a package containing 1300 official ballots, sealed, to be used at this election, was delivered to the ballot clerks, Messrs. Wood and Slattery.

The ballot box was shown to the voters present to be empty, the index being set at 0000. Then the box was locked and the keys thereof were kept in the possession of Constable Charles S. Kelley, who was the officer in attendance at said meeting.

The first ballot was cast by Robert K. Sweet after the polls were declared open by Moderator Moroney. Mrs. Bessie Allard was the first woman voter to cast her ballot.

At various intervals during the voting hours, the ballot box indicator tabulated the following totals: 8 A. M., 127;

9 A. M., 178; 10 A. M., 233; 11 A. M., 315; 12 noon, 360; 1 P. M., 478; 2 P. M., 546; 3 P. M., 655; 4 P. M., 712; 5 P. M., 817, and 6 P. M., when the polls were declared closed by Moderator Moroney, 967 ballots had been cast of the 1207 eligible voters.

The following persons were appointed to canvass the vote and reported at 4 P. M. to be duly sworn by the town clerk: Miss Helen A. Fay, Howard Leland, Joseph J. Driscoll, James Kearnan, Miss Grace Murphy, Mrs. Margaret Gurry, LeRoy W. Prentiss, Burton Walker, Miss Dora M. Whitney, Mrs. Bessie Atwood, Michael Shaughnessy and Eben T. Hall. After the polls closed, Messrs. Wood, Slattery, Allard and Cooper also acted as tellers.

Joseph W. Gorman and Raymond F. Lyford tabulated the vote.

The check lists were compared by the respective officials, Messrs. Wood, Slattery, Allard and Cooper, following the closing of the polls. They reported 967 persons had voted. The indicator on the ballot box showed 967 ballots had been cast.

The ballots having been counted, public declaration was made by the town clerk in open meeting at 10 P. M. The votes were recorded as follows:

PROCEEDINGS OF ADJOURNED
ANNUAL TOWN MEETING, FEBRUARY 11, 1939.

The meeting was called to order by Moderator Malcolm C. Temple, who announced that Henry E. Earl, Elm street, had presented the Town of Upton with a gavel, the wood of which was from the "Parson Wood" tree that stood for over a century in Central square in front of the Congregational church.

Dr. Earl G. Crockett, chairman of the Selectmen, accepted the gavel in behalf of the Town and suggested that the gift by Mr. Earl be suitably inscribed.

1938 TOWN REPORT.

Article 2. Voted on motion of William T. Teachout to accept the 1938 Town Report as printed with exceptions and corrections noted by Peter Robson and the Town Clerk.

Town Clerk Newton stated that under Chapter 500, Acts of 1938 on Page 100 there was a typographical error in the total of expenditures for labor which was printed as "\$917.75" but should have been "\$913.75."

Mr. Robson, selectman-elect, referred to Highway and Public Welfare department reports, as printed. He stated under Chapter 81 highway work, the town showed a balance of 35 cents remaining while the report from the office of the District Highway Engineer showed the entire \$13,500 expended. Mr. Robson also asked if there were any additional bills to the \$1392.24 for Chapter 81 highway work. It was stated this question could be taken up under Article 11. Chairman Crockett of the Selectmen informed the voters there was an unpaid bill of \$53.75 which he had received for setting bounds. Regarding the Public Welfare department, Mr. Robson inquired if there were other towns that owed Upton money which had not been recorded in the department's report.

Walter N. Davis, chairman of the Public Welfare department, replied that there were amounts due from the towns of Millbury and Grafton. He added they were inadvertently omitted. Mr. Teachout then motioned to accept the report with corrections and omissions noted.

Article 3.

SPECIAL COMMITTEES.

Chairman Crockett of the Selectmen referred to a phrase in the 1937 Town Report concerning the cutting of "100 cords of wood" at the Town Infirmary property. He asserted that investigation revealed that in addition to the cutting of wood, that brush and other clearing work were done under the WPA project.

Concerning the proposed laying out and construction of a sidewalk on Milford street for which a special committee was named at the 1937 annual town meeting, Chairman Crockett stated that the committee conferred with state authorities and were informed that the state had no money to construct such a sidewalk, but would lay out such a project.

As for blanket insurance for all Town-owned buildings, Chairman Crockett reported for the special committee, informing the voters that it would cost \$50 to make a survey on the value of said buildings according to representatives of insurance companies.

Town Treasurer Leo F. Murphy, a member of the special committee appointed by the selectmen to handle tax title property, stated that one reason for the committee not having taken action was that the cost of entering a case would amount to more in some instances than what the town would receive in return. Mr. Murphy added that some money had been collected and he believed it a more economic way.

Chairman Crockett of the Selectmen inquired why an appropriation was needed in 1939 for game warden while no money was appropriated in 1938. Game Warden Daniel H. Bates replied that no appropriation was asked for this account in 1938 as the Selectmen in office when the appointment came up for consideration had tried to appoint another person as game warden but could not do so as it was ruled illegal. Mr. Crockett then moved for the appropriation of \$25 for game warden for 1939 as recommended by the Finance committee.

Walter Stearns inquired what "Signs" meant under the budget item, "Sidewalks and Signs." William T. Teachout of the Finance committee explained that the "signs" were for designating town streets.

Referring to the appropriation requested for "Soldiers' Relief", Peter Robson took exceptions to the Finance committee's report that the care of a case in Clinton had been "dumped in our laps". Mr. Robson asserted that the case was that of a Civil War Veteran's widow whose legal settlement had been established by state authorities as being Upton.

Action of the item of an appropriation for "Town Halls and Repairs" was deferred until later in the meeting. Then the sum of \$2000 was appropriated.

BORROWING MONEY.

Article 5. Voted: on motion of Town Treasurer Leo F. Murphy that the town treasurer, with the approval of the selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1939, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

MENDON ROAD.

Article 6. Voted on motion which was made by Walter Stearns not to appropriate money for further improvement of Mendon Road. On a standing vote, Mr. Stearns' motion prevailed 97 to 22.

PLEASANT STREET.

Article 7. Voted on motion of Walter Stearns to pass over article calling for an appropriation to make improvements to Pleasant Street.

CHAPTER 90 MAINTENANCE.

Article 8. Voted on motion of Peter Robson to appropriate \$700 to be used in conjunction with any money which may be allotted by the State or County, or both, for this purpose.

WPA PROJECTS.

Article 9. Voted on motion of Chairman Earl G. Crockett of the Selectmen that \$1500 be appropriated to be used under the direction of the Selectmen for materials, truck hire, and administration of WPA projects. Chairman Crockett added that approximately \$75,000 in Federal allotments was expected to be sent into Upton to be used on projects.

SAMUEL WALKER CASE.

Article 10. Voted on motion of Town Treasurer Leo F. Murphy that \$520 be appropriated to be paid to Laura Walker, administratrix of the estate of Samuel Walker, toward the settlement of an Industrial Accident Board decree. Mr. Walker was fatally injured on August 14, 1936 while employed in the town's highway department.

1938 UNPAID BILLS, CHAPTER 81 HIGHWAY.

Article 11. After some discussion if there were more outstanding bills contracted under Chapter 81 Highway work not included in the \$1392.24 requested to be appropriated to meet 1938 unpaid bills, this sum was voted on motion of Chairman Earl G. Crockett of the Selectmen. Peter Robson, Fred W. Wood, Leo F. Murphy, Walter Allen, Eben T. Hall and Road Commissioner Henry H. Wood were among those to speak in connection with this article. Mr. Robson inquired if there was a bill of about \$100 not included in the amount asked for in the article. Mr. Murphy stated that this was the time to appropriate sufficient money to pay outstanding bills in this account. Road Commissioner Wood gave assurance that the amount requested in the article was adequate. Mr. Crockett then motioned for the appropriation of \$1392.24.

1938 UNPAID BILLS, CHAPTER 90.

Article 12. While the article called for an appropriation of \$152.45, it developed during the discussion that in addition to this sum there was a bill of \$53.75 for setting Worcester County Highway bounds on Westboro Road and \$6.00 for parts purchased from Stephen C. Bourassa, making a total of \$212.20. When asked if the total sum requested in the article could be increased to \$212.20 in a motion, Moderator Temple ruled favorably. The increased sum was then appropriated.

CHECK AND BALANCE SYSTEM.

Article 13. Walter E. Stearns motioned that the Selectmen and Town Clerk draw up a system of checking with the purpose in view to prevent, if possible, overdrafts in departmental accounts. William T. Teachout amended the motion to have the committee also include the chairman of the School Committee, Public Welfare board, and Road Commissioner. Fred W. Wood stated he believed that the present system used was sufficient. The amended motion was voted.

NIGHT POLICE OFFICER.

Article 14. Passed over on motion of Herbert A. Bagley.

G. A. R. HALL BUILDING IMPROVEMENTS.

Article 15. Chairman Crockett of the Selectmen reported that a heating expert had looked over the building and estimated the cost of installing a heating system in G. A. R. Hall building at \$790. Charles S. Leland motioned to pass over the article which was defeated. Selectman Crockett motioned to appropriate \$790 for installing steam heat. Mrs. Lois Prentiss stated she believed that organizations using the hall would be willing to pay increased rent if improvements were made to the building. Mrs. Ruth Fiske also spoke in favor of the motion. George N. O. Poirier said that if the voters were ready to make improvements to the building, they should be done in a complete manner. William R. Summers amended the motion to read to appropriate \$1000.00 for installation of steam heat and toilets. Eben T. Hall said that considerable money had already been appropriated and hoped that the motion would not prevail at this time. On a standing vote the amended motion was favorably acted upon, 76 to 35.

CHANGING NAME OF WEST STREET TO GLEN AVE.

Article 16. On motion of George G. Newton, town clerk, it was voted to change the name of "West Street", now commonly called Glen Avenue, to "Glen Avenue," from Main Street opposite Mechanic Street, around Zachary Pond to Pleasant Street.

COMMUNITY TREE.

Article 17. On motion of Peter Robson it was voted to appropriate \$100.00 for the purchase and setting of blue spruce community tree on Upton Common, Central Square.

COMMITTEE TO STUDY SCHOOL HOUSING.

Article 18. On motion of Halbert K. Struthers, a member of the School Committee, it was voted to appoint a special

committee comprising the three members of the School Committee, chairman of the Finance Committee, chairman of the Board of Selectmen, and two members to be appointed by the Moderator, to make a thorough study of school housing accommodations, and report at a future town meeting. Moderator Temple appointed William Carroll, Mendon street, and LeRoy W. Prentiss, Nelson Street. Mr. Prentiss subsequently resigned and Frank O. Ogden, Main Street, a former school committeeman, was appointed to fill the vacancy.

APPROPRIATION FOR SCHOOL HOUSING COMMITTEE.

Article 19. On motion of William T. Teachout, the sum of \$200 was appropriated for use by the special committee on school housing accommodations for obtaining expert advice and preparation of plans, the committee to make a report at a special town meeting in two months' time.

PLAY GROUNDS.

Article 20. On motion of Dr. Earl G. Crockett, the sum of \$1200 was appropriated to be used with any WPA allotment of Federal money that may be received, for the construction of new bleachers, tennis courts, repairs to the baseball field and other necessary improvements at the playgrounds. Dr. Crockett said that the project called for \$27,000 from the Federal Government if the \$1200 was appropriated.

MILK INSPECTOR'S SALARY.

Article 21. On motion of Daniel H. Bates, it was voted to appropriate \$50 as the salary for the milk inspector.

TOWN INFIRMARY BUILDINGS.

Article 22. On motion of Walter N. Davis, chairman of the Public Welfare Department, the sum of \$1500 was appropriated for repairs and improvements to the Town Infirmary buildings as a result of damage done by the September 21 (1938) hurricane storm, the money to be used in conjunction with any WPA allotment of money which may be granted to the town.

TOWN HALL BUILDING.

Article 23. On motion of William T. Teachout, it was voted to pass over this article. There was some discussion as to the amount which would be needed for the repair work; also as to whether slate shingles should be removed and relaid, or another type shingle used.

G. A. R. BUILDING.

Article 24. On motion of William T. Teachout, it was voted to pass over this article.

HIGH SCHOOL BUILDING.

Article 25. On motion of Earl G. Crockett, it was voted to pass over this article.

Town Treasurer Leo F. Murphy motioned that the money for all appropriations made during this meeting be raised by taxation and that the warrant then be dissolved. It was so voted.

Pursuant to the foregoing warrant, about 100 voters attended a special town meeting in Town hall, Friday, the Twenty-third day of June, 1939.

The meeting was called to order by Moderator Malcolm C. Temple. The call for the meeting and officer's return were read by the Town Clerk.

Article 1. Voted: on motion of William T. Teachout to raise and appropriate Five Hundred Fifty Dollars (\$550.00) for payment of certain 1937 Public Welfare Aid bills to the City of Worcester.

Article 2. Voted: on motion of Samuel F. Wentworth to authorize the Public Welfare board to expend Six Hundred Sixty-three Dollars and Sixty-seven cents (\$663.67) from the 1939 Public Welfare, Outside Aid appropriation, to be used in payment of certain 1938 Public Welfare Aid bills to the City of Worcester.

Article 3. Voted: on motion of Earl G. Crockett to raise and appropriate Twenty-five Dollars (\$25.00) to establish a gasoline and oil account for highway purposes.

Article 4. Voted: on motion of Road Commissioner Henry H. Wood to raise and appropriate the sum of Seventy-two Dollars (\$72.00) for an unpaid 1938 bill under Chapter 81 highway account. Daniel H. Bates inquired what the bill was for and Road Commissioner Wood replied it was for six months' barn rent of highway equipment, adding that the overdrafts were unintentional.

Article 5. Voted: on motion of Road Commissioner Henry H. Wood that the sum of One Hundred Sixteen Dollars and Forty-four cents (\$116.44) be raised and appropriated for payment of an unpaid 1938 bill under Chapter 90 Maintenance highway account.

Article 6. Voted: on motion of Road Commissioner Wood to raise and appropriate the sum of Eighteen Dollars (\$18.00) for payment of an unpaid 1937 bill under Chapter 90 highway account.

At this point in the meeting, Moderator Temple requested the privilege of taking up Article 9 for consideration. As there were no objections, Moderator Temple ruled that Article 9 would be considered prior to Article 7.

Fred W. Wood, chairman of the School Committee and chairman of the special School Housing committee appointed at the adjourned annual February town meeting, gave a

lengthy and enlightening report on conditions in the local school buildings, especially the George S. Ball and High school buildings, and estimated costs of improvements as submitted by various architects. The report advocated that the Town endeavor to secure a Federal Grant of money to help finance improvements.

Daniel H. Bates moved that the report be accepted and a vote of thanks given to the special School Housing committee for its work.

Article 7. Moderator Temple then stated that Article 7 would now be considered if there were no objections. As there were no objections the article was taken up for action.

William T. Teachout, secretary of the Finance committee, said that little repair work had been done at the Ball building since it was erected in 1924; that the windows at the High school building had at least a one-quarter inch play and rattled, that some panes of glass were loose, and several treads on stairways were worn.

He further stated that the Finance committee had discussed the matter and favored transferring up to Eight Hundred Dollars (\$800.00) from the reserve fund to the school department account to make repairs to school buildings.

With this method of financing the cost in view, Mr. Teachout moved that the article be passed over which was seconded by LeRoy W. Prentiss, also a member of the Finance committee. It was so voted.

Article 8. Voted: on motion of Selectman Earl G. Crockett to raise and appropriate \$3500, which was amended by William T. Teachout, that the Town appropriate \$2700 for repairs to the Town Hall building roof, and that the Town Treasurer, with the approval of the Selectmen, be authorized

to borrow said \$2700 under authority of and in accordance with the provisions of Chapter 63, of the Acts of 1939, said loan to be liquidated in equal payments, with interest, during the next three years. LeRoy W. Prentiss seconded the amendment. The amendment was voted unanimously.

Before the amendment was voted upon, David J. Moroney criticized the delay in having the Town Hall building roof repaired.

Merrill S. White, who was a member of the Board of Selectmen in 1938 when the hurricane storm took place, informed the voters that it was true that many persons made repairs to their property shortly after the Sept. 21, 1938 storm, but that the town had roads to be repaired and fire hazards to look after. He added that a contractor was engaged and made temporary repairs to the Town Hall roof which the Selectmen considered would last for a few months.

Selectman Crockett read several bids that the Board had received from contractors to permanently repair the roof.

Henry R. Hoyle and George Whittemore were other speakers on the article.

Article 10. Voted: on motion of William T. Teachout, that the special committee appointed at the annual February Town meeting to study school housing conditions, be continued, and authorized to have plans drawn to be submitted to WPA or PWA authorities in an effort to secure a Federal grant of money, and for that purpose the said committee be authorized to use certain money appropriated at the adjourned Feb. 11, 1939 town meeting.

Just before dissolving the warrant, Town Clerk Newton motioned that a vote of thanks be given to Merrill S. White

for the presentation of a goose-neck type electric lamp to the town. It was so voted.

Parents and others are requested to carefully examine the above lists and if any errors or omissions are discovered report them at once to the town clerk, that the record may be corrected, as it is of importance that the records of Vital Statistics should be complete. Herewith are extracts from the General Laws, Chapter 46.

GENERAL LAWS, CHAPTER 46, SECTION 8.

(As Amended by Chapter 281, Section 1, Acts of 1925).

Every physician, or hospital medical officer registered under section nine of chapter one hundred and twelve, in this chapter called officer, shall keep a record of the birth of every child in cases of which he was in charge, showing date and place of birth, the name, if any, of the child, its sex and color, the name, age, birthplace, occupation and residence (including the street number, if any, and the ward number, if in a city) of each parent, the maiden name of the mother and the name of the physician or officer, if any, personally attending the birth. If the child is illegitimate, the name of, and other facts relating to the father shall not be set forth except upon written request of both the father and mother; provided, that if an illegitimate child shall have become legitimate by the intermarriage of his parents and the acknowledgment of his father, as provided in section seven of chapter one hundred and ninety, prior to the mailing or delivery of any report herein required, such report shall read, in all respects, as if such child had been born to such parents in lawful wedlock. Said physician or officer shall, within fifteen days after such birth, mail or deliver to the clerk or registrar of the town where such birth occurred, a report stating the facts hereinabove required to be shown on said record and also the said written request, if any; provided, that if said report is not so made within forty-eight hours after such birth, said physician or officer shall, within said

forty-eight hours, mail or deliver to said clerk or registrar a notice stating the date and place of the birth, the street number, if any, the ward number, if in a city, and the family name. Upon presentation to him of a certificate of the town clerk stating that any such birth has been duly reported, the town treasurer shall pay to such physician or officer a fee of twenty-five cents for each birth so reported. Any physician or any such officer violating any provision of this section shall forfeit not more than twenty-five dollars. The said town clerk or registrar shall file daily with the local board of health a list of all births reported to him, showing, as to each, the date of birth, sex, color, family name, residence, ward and physician or officer in charge.

GENERAL LAWS, CHAPTER 46, SECTION 6.

Parents, within forty days after the birth of a child, and every householder, within forty days after a birth in his house, shall cause notice thereof to be given to the clerk of the town where such child is born * * *.

Blanks may be obtained upon application to the town clerk.

There is deposited in the Milford Savings Bank, \$7.99 known as the Knowlton School Fund with the Town Treasurer as trustee to be used by the School Committee to defray extraordinary expenses at the Knowlton School building.

There is deposited in the Milford Savings Bank, one thousand dollars (\$1000.00) known as the Ella (Whitney) Risteen Fund in trust with the Town Treasurer and School Committee as Trustees, the income to be divided between the two pupils in our public schools who make the most progress during each year. \$25.15 was received this year.

There is deposited in the Worcester County Institution for Savings, one thousand dollars (\$1000.00) known as the Dr. Carpenter Library Fund, the income of which is to be used for the Public Library. \$25.15 was received this year.

Charlotte A. Batchelor and George W. Knowlton established a Trust Deed at the Worcester County Trust Co., with the Bank as trustee, the income to be paid to the Town of Upton for use of Public Schools. \$219.83 was received this year.

There is deposited in the Milford Savings Bank, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in trust with the Town Treasurer as trustee, the income to be used for the Public Library. \$125.00 was received this year.

There is deposited in the Worcester County Institution for Savings, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor School Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Schools. \$125.00 was received this year.

There is deposited in the Milford Savings Bank a War Bonus Surplus Fund to be used as a nucleus of a Fund for a Public Library Building as voted by the Town, February 7, 1925. Interest received is \$68.64 and the amount of this fund on January 1, 1940 is \$2,797.63.

There is deposited in the Milford Savings Bank of Milford, five thousand dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Board of Selectmen, to be used to help the Townspeople who are in distress. \$250.00 was used this year. \$135.48 Interest was received and the balance on January 1, 1940 is \$5,345.80.

There is deposited in the Worcester Five Cent Savings Bank \$180.02 known as the "Town of Upton Memorial Fund." The Bank records show this fund was established by the late Velorus Taft many years ago, but do not state for what purpose this money may be used.

In accordance with a vote of the 1937 Annual Town Meeting to establish an "Industrial Accident Insurance Fund" with the Selectmen and Treasurer as Trustees, I have deposited \$500.00 in the Milford Savings Bank. Payment from this Fund is to be made only in accordance with rules to be established by the Board of Selectmen. Interest received is \$30.79 and balance January 1, 1940 is \$1,548.56.

FIRE HAZARD WORK DONE.

For nine months there have been between sixty and one hundred men from Blackstone and thirty men from Upton, working clearing the timber land that was blown down by the hurricane.

Practically every cart road was opened so as to allow ample room for men to fight forest fires if one started. The limbs were cut and tops of the trees were removed. The slash burned or stacked so that at a latter date when conditions were favorable they could be burned. All this was done at no expense to the land owner whatsoever.

The following is a correct statement from the federal office:

Acres cleared by WPA	455
Acres cleared by CCC	23

There were 9,685 piles of brush ricked on 235 acres, all of which has been burned in 114 Man Days in addition to the foregoing total of Man Days expenditures. There will be some 43 acres of work to be completed in the near future.

REMOVING STUMPS.

A project has been accepted by the Government for the removal of the stumps in the cemeteries and along the highways. Already we have removed most of the stumps in the cemetery on North Main Street. Some stumps were removed on various streets in town. The work is still going on. Before the project is completed the walls of the cemeteries will be rebuilt, regraded and seeded.

LOG PROJECT.

Through the help of the WPA we were able to cut the logs in both cemeteries and truck them to the Government mill and sell the same. It cost the town \$168.00 to do this. We received \$467.00 from the Government which netted the town \$299.00 profit, which was turned over to the Town Treasurer.

PLAYGROUND PROJECT.

Work has been started on the playgrounds and much progress has been realized. The tennis court is ready for the

top coat which will be asphalt and furnished by the Government. Approximately 500 loads of stone and gravel fill has been put into the base of court. The road, both on the school land and town road, has been widened and graveled so now cars can pass without danger. Over 500 cu. yards of fill have been put in the outfield. The stone abutments and side walls of the bleachers on the first base line is nearly completed. The old bleachers on the third base line have been repaired and painted.

REPORT OF THE SUPERINTENDENT OF SCHOOLS.

January 1, 1940.

TO THE SCHOOL COMMITTEE.

I herewith submit my report as Superintendent of Schools for the brief period beginning August 1, 1939, and ending December 31, 1939, together with the annual reports of my colleagues, and other statistical data.

ENTRANCE REQUIREMENTS.

In August the Committee took under advisement the question of pre-school entrance examinations, which are annual sources of complaints and troubles. After careful consideration, it was decided to discontinue these examinations and establish a fixed age for admission to grade one. The following rule was adopted: "A child who has attained the age of five years and six months on September first is eligible for admission to the public schools of Upton." There are no exceptions to the rule.

ENROLLMENT.

The schools opened on September sixth with a total enrollment of 430 pupils. Each principal took charge of his or her building and did an excellent piece of work in organizing it with very little assistance from the new superintendent, who had not had time to get acquainted with his schools. Owing to the overcrowded condition in the Ball School, it was necessary to reroute Mr. Fay's bus trip and transfer some of the pupils to the Knowlton School. With large families mov-

ing in and out of town, it is impossible to plan the size of classes in advance.

TRANSPORTATION.

In the past all pupils along bus routes have been transported regardless of distance if there was seating room. On most of our trips we are continuing this practice. However, Mr. Fay's bus has been so overloaded that we are compelled to ask those who live within the one mile limit to walk. Enforcing this one mile regulation in this case should bring no hardship to bear upon those required to walk, as many of them are in the habit of walking home for lunch at noon.

HIGH SCHOOL.

The new superintendent was approached by many regarding existing conditions in the high school. Because the condition of the building showed clearly that there was some justification for the complaints, he took the situation as his first major project. Since the pupils could not be expected to do good work without proper equipment, all desks and arm chairs in the building were resurfaced, at a very low cost. New textbooks were provided for some of the classes but, owing to lack of funds, we were unable to equip all the classes with good textbooks. The next step was to revamp the program of studies to fit the situation and to meet the offerings of other schools. With this completed, we were then faced with the administration problem of discipline. Strict rules were laid down and provisions made for some thorough supervision by the principal, by reducing his teaching load. With cooperation by both pupils and faculty we are happy to report that the spirit of the school is greatly improved and that the unsatisfactory conditions have, in most cases, been eliminated. We hope that we can continue to improve conditions for the benefit of all.

MARRIED TEACHERS.

The following rules and regulations regarding married teachers were adopted by the School Committee to take effect on April 26, 1939:

"Resolved that in the future no married women will be employed as teachers, except as substitutes.

"That unmarried women now employed shall be automatically dropped from the service, if they marry."

These rules shall not apply to married women teachers already in the service.

FACULTY CHANGES.

1. Miss Margaret M. Gurry was transferred from grades 3 and 4 in the Knowlton School to grades 1 and 2 in the Ball School.
2. Miss Mango was transferred from grades 2 and 3 in the Ball School to grades 3 and 4 in the Knowlton School.
3. Grades six in the Knowlton and Ball Schools were transferred to the High School Building, in charge of Mrs. Ruth C. Goodrich.
4. Miss Ellen E. Mulhall was elected to fill the vacancy caused by the resignation of Miss Helen E. Crooker and has been assigned to departmental teaching in the High School.
5. Mr. James O'Leary was elected as coach and teacher of mathematics and science in the High School.
6. Miss Arlyne M. Marcy has been engaged as a part time music supervisor.

BUDGET.

We have spent the money allotted to us with the utmost discretion. We have tried to make every dollar go as far as possible. In spite of this, we have not had sufficient funds to do what we would like to do. The Finance Board very kindly transferred the sum of Eight Hundred Dollars to our budget for the purpose of making building repairs. We hope that we have expended this money to the satisfaction of the Finance Board and the citizens. We are turning back part of it, as we do not feel that this is the proper time to begin other repairs.

BUILDING REPAIRS.

The following building repairs have been made since the closing of school in June:

1. The floors and woodwork in all toilet rooms have been painted.
2. New rubber composition seats have been installed in the girls' toilet in the Knowlton School.
3. The leaks in the roof of the Ball School have been temporarily repaired.
4. The inside woodwork in the Ball School has been shellacked and varnished.
5. An automatic water feeder has been installed on the boiler in the Ball School in order to prevent further expensive breaks due to lack of water from "flashing."
6. A new stack heater was installed in the Knowlton School to replace the old one that had rusted out.
7. All desks and armchairs in the high school have been resurfaced. The badly gouged desks in the Knowlton School were also resurfaced.
8. All windows in the High School Building have been weatherstripped and caulked. The outside double doors have also been weatherstripped.

9. New windows have been installed in the High School building to replace those damaged by the hurricane.

SUGGESTIONS.

The following is a partial list of suggestions for repairs that should be considered during the coming year:

1. That the sewerage system in the Ball School be improved so that the sewerage will not flow over the floors in the toilet rooms when several toilets are flushed.
2. That the roof on the Ball School be covered with an asphalt dressing in order to preserve the roofing paper which has dried out.
3. That general electric classroom switches be eliminated, and individual fixture switches installed. This will permit a teacher to turn on only necessary lights instead of all as under the present arrangement.
4. That the heating system in the High School be changed to a more modern one with a stoker. This change should heat the building more efficiently and save the town money.
5. That the interior of the High School building be rearranged and refinished.

In concluding this report, my sincere thanks go to the members of the School Board for their friendly counsel and for their hearty support of my efforts to guard the interests of and improve the opportunities for the youth of Upton. I also wish to express my appreciation for the helpful spirit of cooperation shown by the principals, teachers, janitors, and others interested in our schools.

MANUAL TRAINING.

The following is a report of the Manual Training Instructor:

"Those who saw the exhibit of Manual Training in the Public Library last June perhaps realized for the first time the type of furniture which even grade boys can make under proper guidance. We had a full class in the eighth grade last year and every one showed special aptitude for hand work. This, of course, was exceptional. The present eighth grade consists of only six boys and although they have had not on the whole the ability of the previous group, all are interested and trying hard. I have no doubt but what the results will be very creditable. The seventh grade is unusually large, twenty boys. This will make another large advanced group next year.

"Some may think this subject unnecessary but they do not take into consideration the training in exactness and the application, even the construction which simpler projects take. Few realize that every beginner starts with simple things in any subject he undertakes. We could not construct bookcases or tables at first any more than the entering grades in school could start with multiplication and long division.

"Manual Training reaches many boys and helps them find themselves. Not a few after spending two years with us enter trade school and choose some line of wood work for their life work. Why should not this type of boy have the particular subject which fits his needs as well as the pupil who expects to go to college or commercial school? Then, too, whatever a boy plans to do in the future, he will be just so much the better in that particular field because he has learned to correlate his brain and hand.

"We appreciate the hearty support given this course by the school committee, the Upton Woman's Club who installed it and financed the subject for so many years, and the people of Upton. May it continue for it is a very necessary and important subject in the school curriculum."

DRAWING.

The following is a report of the Drawing supervisor:

"The work is going quite well in the art department, especially in the first six grades.

"In grades seven and eight, however, we are not accomplishing as much as we should, because of the fact that we have one period only—every two weeks, and there is no teacher to carry on the art program for the week of my absence. I believe drawing is most important in these upper grades. The pupils have arrived at an age where they can grasp certain fundamentals as rhythm, balance, color harmony, etc. and they can do handwork too difficult for younger children to attempt.

"Since they have no art of any kind in High School, I do not think the ten hours per year we are allowed for drawing, for that is all they now have, is enough.

"We have tried this year in all grades to make our work of practical value. In grades four and five the pupils were studying Indian life and Indian symbols. Some of the more interested pupils made costumes, bags, belts, etc. and embroidered them with Indian designs. Another time a lesson in paper cutting was made practical by cutting forms to be used for making decorative Christmas Cookies.

"I believe this should be one purpose of the art department, that of applying the laws of order, harmony, color and beauty, to the simplest daily tasks, making their accomplishment a pleasure and a satisfaction that artistic achievement alone can give.

"For after all art for art's sake is for the minority; but to bring beauty into our daily life is something that each pupil, every teacher and all parents should strive to attain."

MUSIC.

The following is a report of the Music Supervisor:

"There are three main reasons for studying music in our public schools. First: It adds to the enjoyment of school life. Second: It gives children the opportunity to learn the most beautiful songs written by the most famous composers. Third: It provides a source of pleasure for others.

"The music period brings a pleasant change from other school work. From the first grade through to the High School children enjoy singing together. It's natural for children to sing when they are happy. In school both the talented and untalented have a chance to express their feelings through music.

"Our environment helps to make us what we are. If we hear and study the finest music, our ears will become sensitive and so able to distinguish the good from the bad. It is sad but true that a great many children, if left to their own choice of songs would listen to nothing but jazz. This foundation for appreciating better music is started in our elementary grades. Many beautiful melodies, including our patriotic songs, folk songs and modern classics are taught to the children by "rote." In these grades we aim to improve the children's speaking and singing voices by trying to produce tones that are rich and flexible. Here rhythm study is started through the dramatization of songs. A course in Music Appreciation is given through-out the grades by the use of a victrola.

"Music more than any other subject provides occasions for giving pleasure to others. The better the children know music the better performance they give, therefore, we must teach the children to "read" music. That is why all our songs must be taught first by reading "notes." The more easily we can read music, the wider is our command of the rich resources of musical literature.

"The Operetta "Pinafore" to be given by our entire high school students of one hundred and twenty voices, proves the

true spirit of "team work" which the study of better music brings about. They are most enthusiastic over this performance and I'm sure it will be a profit to the High School treasury, and a credit to the boys and girls of Upton.

"A High School Glee Club of forty voices has been organized and has been received whole-heartedly by the people of Upton. The many requests for the Glee Club to sing from the Churches and various fraternal orders, promises them a full social season. This adds to their appreciation of music and at the same time adds to the pleasure and profit of the days spent in school.

"In closing, I would like to thank the grade teachers in their cooperation with me in trying to bring about better music in the Upton Schools."

HEALTH.

The following is a report of the School Nurse:

"The health program in the schools has been carried on in the usual routine. The annual physical examination has been completed by Dr. Capen. Notices of defects have been submitted to the parents. Dr. Capen found the teeth and general health of the pupils much improved.

"The clinic for the discovery of Childhood type of tuberculosis sponsored by Worcester County Health Association, and made possible through the sale of Christmas seals was held in January for pupils attending High School. There were four new cases with positive skin tests. No new cases of Childhood tuberculosis were found.

"In June, twenty pre-school children were examined at our Well Child Conference sponsored by the State Department of Health. Physical, dental and nutritious defects were explained to the parents. Many were corrected before entering school.

"A few communicable diseases have occurred this year and a few cases of whooping cough during the summer vacation. This spring and again this fall scattered cases of chicken-pox have occurred among West Upton pupils."

I herewith submit my seventh annual report.

Credits: $\frac{1}{4}$ of a credit per year for cooking; no credit for music. $\frac{1}{2}$ of a credit per year for typing; 1 credit per year for all other subjects.

In 1940—1941 the following courses will be alternated: Geometry for Algebra II; French II for French I; Chemistry for Physics; Latin I for Latin II.

The seventh and eighth grades are now included in the High School. The courses for them are as follows: Geography, Mathematics, Science, English, Spelling, History, Penmanship, Music for one period a week, Art for one period a

week, Sewing for two periods a week, and Manual Training for three periods every two weeks.

All of the classes from the seventh through the twelfth are now under the High School Faculty. This is making for a closer co-ordination of courses.

In extra curricular activities the school paper, "The Uptonian," has had one issue with more to follow. This work is under the direction of Mr. Cowing, Mrs. Dearth, and Mr. Duprey. The production of this paper is handled entirely by students of the High School and is printed on the school mimeograph machine.

A glee club has been formed by Miss Marcy, the Music Supervisor. The club has already had outside engagements and others are to follow.

The French club, under Miss Burke, is very active with meetings every two weeks. The purpose of this club is to foster use of French in reading, writing, and literature.

Athletics are now under the supervision of Mr. O'Leary and Miss Mulhall. The prospects of developing good athletic teams look bright.

Upton High School once again is to take part in the American Legion speaking contest. In the elimination contest held at the town hall last year, Herbert Luebbe won the first prize; Eleanor Fenner, the second prize; and Chestin Heald the third prize. Last year our contestant, Herbert Luebbe, tied for fourth place, which can be considered excellent when one realizes the competition. Some of the schools represented have specific courses in speaking which gives them a direct advantage over other schools. On behalf of the High School I wish to thank the Clifton G. Marshall American Legion Post 173 for the opportunity to compete in this contest.

The desk tops which were cleaned last summer are still in excellent condition, which seems to show that when given the opportunity, most students respect property.
