

WARRANT FOR ANNUAL TOWN MEETING

MARCH 5, 1951

Worcester, ss

To the Constable of the Town of Upton, in the County of
Worcester, Greeting:

In the name of the Commonwealth of Massachusetts,
you are directed to notify the inhabitants of the town of
Upton, qualified to vote in Elections and in Town Affairs,
to meet at the Town Hall, in said Upton, on Monday, the
Fifth day of March, punctually, at Seven o'clock A.M.,
then and there to act on the following articles:

Article 1. To choose all necessary town officers for
the ensuing year: Moderator, Town Treasurer, three
Selectmen, Collector of Taxes, Auditor, five Constables,
Road Commissioner, Tree Warden, one member of the
Board of Public Welfare, to fill a vacancy, one Cemetery
Commissioner, to fill a vacancy, all for one year; one
Assessor of Taxes, one member of the Board of Public
Welfare, one member of the School Committee, one
Cemetery Commissioner, one Park Commissioner, and
three Trustees of Public Library, all for three years, and
one member of the Housing Authority, for five years.

All of the above to be voted for upon one ballot.

The polls shall be closed at 8 o'clock P.M. on the day of said meeting.

The remaining articles contained in the warrant will be acted upon at an adjourned meeting of the voters in Town Hall on Saturday afternoon, March 10, 1951, at 2 o'clock P.M.

Article 2. To hear the reports of all town officers and do or act in any manner pertaining thereto.

Article 3. To hear reports of any committees appointed by the town, and do or act in any manner pertaining thereto.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by Section 108 of Chapter 41, General Laws as amended: Moderator, Selectmen, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Auditor, Cemetery Commissioners, Constables, Trustees of Public Library, Road Commissioner and Tree Warden, or do or act in any manner pertaining thereto.

Article 5. To raise and appropriate such sums of money as may be necessary to defray expenses of Town department for the ensuing year, or do or act in any manner pertaining thereto.

Article 6. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1,

1951, and to issue a note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 7. To see if the Town will vote to authorize the Board of Selectmen to appoint one of its members as Chief of Police or Acting Chief of Police, and to establish a salary to be taken from the Police Appropriation for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of Three Thousand Five Hundred Dollars (\$3500.00) for Chapter 90 Construction of Mendon Street, said money to be used in conjunction with any money which may be allotted by the State or County, or both, for this purpose, or do or act in any manner pertaining thereto.

Article 9. To see if the Town will vote to appropriate the proceeds of the 1950 Dog Tax Refund received from the County, to the School Account, or do or act in any manner pertaining thereto.

Article 10. To see if the Town will vote to raise and appropriate the sum of Four Hundred Fifty-Nine Dollars and Fifteen Cents (\$459.15), in accordance with provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund and Military Services Fund of the Worcester County Retirement System for 1951, or do or act in any manner pertaining thereto.

Article 11. To see if the Town will vote to accept Chapter 820, Acts of 1950, which provides an increase in pension of \$100.00 yearly to certain employees who are now on pension, or do or act in any manner pertaining thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of Three Hundred Twenty Dollars (\$320.00) to the Highway Employees Vacation Account, or do or act in any manner pertaining thereto.

Article 13. To see if the Town will vote to raise and appropriate the sum of Seventy-Two Dollars (\$72.00) to install Four street lights on West Main Street and Wildwood Avenue, or do or act in any manner pertaining thereto.

Article 14. To see if the Town will vote to raise and appropriate the sum of Seventy-Two Dollars (\$72.00) to install Four street lights on Elm Street, between Taft Street and Walnut Street, or do or act in any manner pertaining thereto.

Article 15. To see if the Town will vote to raise and appropriate the sum of Seventy-Two Dollars (\$72.00) to install Four street lights on lower South Street, or do or act in any manner pertaining thereto.

Article 16. To see if the Town will vote to transfer the actual custody of the assets of the Ella W. Risteen Trust from the Hartford Connecticut Trust Company to a safe deposit vault in the custody of the Town Treasurer, or do or act in any manner pertaining thereto.

Article 17. To see if the Town will vote to raise and appropriate the sum of Sixty-Four Dollars (\$64.00), for payment of Industrial School Bill incurred in 1950, or do or act in any manner pertaining thereto.

Article 18. To see if the Town will vote to raise and appropriate the sum of Three Hundred Thirty-Three Dollars and Eighty-Five Cents (\$333.85) for payment of bills incurred in 1950 in the Town Halls and Expenses Account, or do or act in any manner pertaining thereto.

Article 19. To see if the Town will vote to raise and appropriate the sum of Forty Dollars (\$40.00) for payment of bill incurred in 1950 in the Town Dump Account, or do or act in any manner pertaining thereto.

Article 20. To see if the Town will vote to raise and appropriate the sum of One Hundred Twenty-Five Dollars (\$125.00) for purchase of chairs for the Town Hall Building, or do or act in any manner pertaining thereto.

Article 21. To see if the Town will vote to authorize the Board of Assessors to contract with an out of town firm to equalize the Valuation of the Town over a three-year period, or do or act in any manner pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of Seventeen Hundred Dollars (\$1700.00), as the first year's payment on equalization of valuation of the Town, or do or act in any manner pertaining thereto.

Article 23. To see if the Town will vote to raise and appropriate the sum of Seven Thousand Seven Hundred Sixty-Four Dollars and Twenty-Three Cents (\$7764.23) for the installation of sewerage disposal system at the new Elementary School, said account having been incurred in 1950, or do or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to raise and appropriate the sum of Three Hundred Forty-Five Dollars and Seventy-Four Cents (\$345.74) for payment of Snow Removal Bill incurred in 1950, or do or act in any manner pertaining thereto.

Article 25. To see if the Town will vote to raise and appropriate the sum of Seven Hundred and Fifty Dollars (\$750.00) for the Department of Civil Defense, for the purchase of equipment and operational expenses, or do or act in any manner pertaining thereto.

Article 26. To see if the Town will vote to transfer the earnings of 1950 in the Machinery Fund to the Machinery Account, or do or act in any manner pertaining thereto.

Article 27. To see if the Town will vote to accept the provisions of Chapter 39, Section 23, of the General Laws, relative to election of Town Officers, or do or act in any manner pertaining thereto.

Article 28. To see if the Town will vote to amend the By-Laws relative to the time when the annual meeting for the transaction of business and/or the election of officers shall take place, or do or act in any manner pertaining thereto.

Article 29. To see if the Town will vote to raise and appropriate the sum of Three Hundred Dollars (\$300.00) for equipment and replacements in the Fire Department, or do or act in any manner pertaining thereto.

Article 30. To see if the Town will vote to amend the By-Laws by providing that the Tax Collector shall also be Town Collector for any and all accounts due the town in accordance with General Laws, Chapter 41, Section 38A, or do or act in any manner pertaining thereto.

Article 31. To see if the Town will vote to transfer back to the Town Treasury, the unexpended balance in the Pleasant Street Bridge Account, or do or act in any manner pertaining thereto.

Article 32. To see if the Town will vote to transfer from the following appropriations: Ceiling, G.A.R. Hall, Five Dollars (\$5.00), Fire Department Equipment, Fifty Cents (\$.50), Forest Fire Hose, Two Dollars (\$2.00), Police Equipment, One Cent (\$.01), Bathing Beach, Six Dollars and Forty-Nine Cents (\$6.49), Mimeographing By-Laws, Forty-Three Dollars and Fifteen Cents (\$43.15), World War II Honor Roll, Forty-Three Dollars and Twenty Cents (\$43.20), making a total of One Hundred Dollars and Thirty-Five Cents (\$100.35), to the Town Treasury, or do or act in any manner pertaining thereto.

Article 33. To see if the Town will vote to raise and appropriate the sum of Five Hundred Dollars (\$500.00), said monies to be used by the Cemetery Commissioners for the purpose of grading and oiling, or do or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post offices and on the Town House in said Town.

Hereof fail not, and make due return of this warrant, with your doings thereon to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF ANNUAL TOWN MEETING

MARCH 5, 1951

Moderator Malcolm C. Temple called the meeting to order to read the Warrant.

After reading the call of the meeting and Article 1 for the election of officers, Chairman of Selectmen Ernest B. Porter moved that reading of the remaining articles be waived and acted upon at an adjourned town meeting, Saturday, March 10 at 2 P.M. Motion was seconded and voted. Moderator Temple resumed reading of the Warrant and Constable's return during which George A. Whittemore addressing the chair as "Mr. Chairman", stated that he desired to be recorded as being present to perform his duty as moderator.

Prior to opening of the meeting, Moderator Temple invited any voter to inspect the ballot box. The indicator was set at 0000. Officer Eugene A. Closson was on duty at the ballot box. A sealed box purporting to contain 1600 ballots was turned over to Raymond F. Lyford and Peter Bingel, ballot clerks.

The checkers had been sworn to perform their duty by the Town Clerk. They were Messrs. Lyford and Bingel at the check-in table; Kenneth W. Wood and Gerald L. Shaughnessy at check-out table.

Indicator on ballot box read at intervals during the day as follows: 8 A.M., 31 ballots cast; 9 A.M., 58; 10 A.M., 93; 11 A.M., 138; 12 noon, 178; 1 P.M., 221; 2 P.M., 292; 3 P.M., 351; 4 P.M., 402; 5 P.M., 521; 6 P.M., 700; 7 P.M., 916; and 8 P.M., 1029.

At 4 P.M. the first ballots were removed from the ballot box under supervision of Moderator Temple, the checkers and Officer Closson. A total of 400 ballots were counted in blocks of 50 and placed in respective envelopes. At 6.05 P.M., 300 more ballots were removed, counted in blocks of 50, and placed in envelopes. When the polls were declared closed by Moderator Temple, the ballot box indicator registered 1029. A total of 329 more ballots were removed from the ballot box in blocks of 50 and placed in envelopes. Grand total of votes cast during the voting hours, 1029. Indicator on ballot box read 1029.

Following persons appointed by the Selectmen reported at 4 P.M. to canvass the vote: Mrs. Helen Donham, Mrs. Margaret Henderson, Mrs. Ruth Sweet, Mrs. Yvonne Bissonnette, Mrs. Ada White, Mrs. Rita Cutler, Samuel B. Young and Joseph J. Driscoll.

Reporting at 6 P.M. were Gerald McAuliffe, Mrs. Helen Poirier, Ernest Henchey, Mrs. Elizabeth Victor, Mrs. Elinor S. Varney, Mrs. Lillian Morrow, George Daigle and Douglas Gilchrist.

Mrs. Violet Picard and Edward L. Prentiss, who tabulated the votes, reported at 7 P.M.

All of the above took oath to perform their respective duties.

After the polls were closed at 8 P.M., the voting lists used were compared by Messrs. Lyford, Bingel, Wood and Shaughnessy. They reported 1029 names checked, approximately 69.5 per cent of Upton's total registered voters.

Used and unused ballots with voting lists were placed in a container and sealed. The container was placed in the town vaults.

With the canvassing of the vote and tabulating completed, public declaration was read at 10.15 P.M.

PROCEEDINGS OF ADJOURNED ANNUAL TOWN
MEETING, MARCH 10, 1951

Voted.

(b) Highways, Chapter 90 Maintenance. Road Commissioner Harry C. Snow moved that the sum of \$900.00 be raised and appropriated to meet the Town's share of the cost of Chapter 90 Highway Maintenance, and that in addition, the sum of \$1,800.00 be transferred

from unappropriated available funds in the treasury to meet the State and County's share of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the treasury. Voted.

(c) Library. Chairman of Selectmen Ernest B. Porter moved that the sum of \$940.00 plus \$60.00 (Carpenter Fund requirement), total \$1,000.00, be raised and appropriated for Library Account. Voted.

Murphy, that the appropriations made in Articles 13, 14 and 15 for installation of certain street lights be added to Street Lights Appropriation already voted, in order to expedite the bookkeeping.)

BORROWING MONEY

Article 6. Voted: on motion of Town Treasurer Leo F. Murphy, duly seconded, that the Town Treasurer, with the approval of the Selectmen, be and hereby, is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1951, and to issue note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, G.L. Unanimous vote declared by the Moderator.

AUTHORIZING SELECTMEN TO APPOINT ONE OF ITS MEMBERS AS POLICE CHIEF

Article 7. Voted: On motion of Selectman Daniel H. Bates that the Selectmen be authorized to appoint one of its members as Chief of Police, and that the salary of \$35.00 a month be established, said salary to be taken from the Police Department Appropriation, according to provisions of General Laws, Chapter 41, Section 4A.

MENDON ROAD

Article 8. Voted: On motion of Road Commissioner Harry C. Snow that the sum of \$3,500.00 be raised and appropriated to meet the Town's share of the cost of

Chapter 90 Construction work on Mendon Road, and that in addition, the sum of \$10,500.00 be transferred from unappropriated available funds in the treasury to meet the State and County's share of the cost of the work, and reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the treasury.

1950 DOG TAX REFUND

Article 9. Voted: on motion of Town Treasurer Leo F. Murphy to appropriate the 1950 Dog Tax Refund of \$747.58 received from the County, to the School Account.

COUNTY RETIREMENT SYSTEM

Article 10. Voted: on motion of Town Treasurer Leo F. Murphy that the Town vote to raise and appropriate the sum of \$459.15 in accordance with provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund and Military Services Fund of the Worcester County Retirement System.

ACCEPTANCE OF CHAPTER 820, ACTS OF 1950

Article 11. Voted: on motion of Chairman of Selectmen Ernest B. Porter to accept Chapter 820, Acts of 1950, which provides an increase in pension of \$100.00 yearly to certain employees who are now on pension.

HIGHWAY EMPLOYEES' VACATION

Article 12. Voted: on motion of Selectmen Daniel H. Bates to raise and appropriate \$320.00 to the Highway Employees' Vacation Account.

WEST MAIN STREET AND WILDWOOD AVENUE STREET LIGHTS

Article 13. Voted: on motion of Harrison E. Bates to raise and appropriate the sum of \$72.00 to install four street lights on West Main Street and Wildwood Avenue.

ELM STREET LIGHTS

Article 14. Voted: on motion of George Dean to raise and appropriate the sum of \$72.00 to install four street lights on Elm Street between Taft and Walnut Streets.

SOUTH STREET LIGHTS

Article 15. Voted: on motion of Selectman Gladys G. Crockett to raise and appropriate \$72.00 to install four street lights on lower South Street.

TRANSFER OF CUSTODY OF ELLA W. RISTEEN TRUST FUND

Article 16. Voted: on motion of Kenneth W. Wood to transfer the actual custody of the Ella W. Risteen Trust from the Hartford Connecticut Trust Company to a safe deposit vault in custody of the Town Treasurer.

Town Counsel Henry C. Walker informed the voters that such action had been directed to be taken by Henry F. Long, Director of Corporations and Taxation.

1950 INDUSTRIAL SCHOOL BILL

Article 17. Voted: on motion of Chairman of Selectmen Ernest B. Porter, that the town raise and appropriate the sum of \$64.00 for payment of Industrial School Bill incurred in 1950. Moderator Temple declared the vote unanimous.

1950 TOWN HALLS AND EXPENSES BILL

Article 18. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the town raise and appropriate the sum of \$333.85 for payment of bills incurred in 1950 in the Town Halls and Expenses Account. Moderator Temple declared the vote unanimous.

1950 TOWN DUMP BILL

Article 19. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the town raise and appropriate the sum of \$40.00 for payment of bill incurred in 1950 in the Town Dump Account. Moderator Temple declared the vote unanimous.

TOWN HALL CHAIRS

Article 20. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the town raise and appropriate the sum of \$125.00 for purchase of chairs for Town Hall Building.

APPRaising FIRM TO SURVEY VALUATION

Article 21. Voted: on motion of Norman E. Walker, chairman of Assessors of Taxes, that the Assessors be and hereby are authorized to enter into a contract with a municipal appraising firm to make a survey, report and re-assessment of the taxable property in the town for the purpose of equalizing the valuation; said total contract price not to exceed \$5,100.00 payable over a period of three years.

Prior to taking of vote, Chairman Walker asked permission be given to R. S. Nesser of Plainville, Conn., to explain in detail how re-valuation of municipalities for

local tax equalization purposes is done. Unanimous consent was granted.

Voters speaking during the discussion of the article included Harold S. Hopkins, Harrison E. Bates, Donald B. Johnson, Robert E. Maynard, David E. Thompson, Mrs. Ward A. Robinson, Assessor Donald L. Varney, Joseph W. Gorman and Chairman of Assessors Walker.

SURVEY VALUATION APPROPRIATION

Article 22. Voted: on motion of Norman E. Walker, chairman of Assessors of Taxes, that \$1,700.00 be appropriated for the first year's payment of said contract in the preceding article.

1950 ELEMENTARY SCHOOL BILL

Article 23. Voted: on motion of School Committee-man Donald B. Johnson, also a member of the Elementary School Building Committee, that the Town raise and appropriate the sum of \$7,764.23 for payment of sewerage disposal system at new Elementary School, said account having been incurred in 1950. Moderator Temple declared vote unanimous.

Prior to taking of the vote, Gordon E. Benson and George N. O. Poirier of the Elementary School Building Committee spoke on the unpaid bill.

1950 SNOW REMOVAL BILL

Article 24. Voted: on motion of Road Commissioner Harry C. Snow that the sum of \$345.74 be raised and appropriated for payment of Snow Removal Bills incurred in 1950. Vote was declared unanimous by Moderator Temple.

CIVIL DEFENSE

Article 25. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the Town vote to raise and appropriate the sum of \$500.00 for the Department of Civil Defense for the purchase of equipment and operational expenses.

MACHINERY FUND TO MACHINERY ACCOUNT

Article 26. Voted: on motion of Road Commissioner Harry C. Snow to transfer the sum of \$6.50 from the Machinery Fund to Machinery Account.

PROPOSAL TO HAVE BUSINESS SESSION BEFORE
TOWN ELECTION

Article 28. At this point in the meeting, a motion was made and voted to take up Article 28 for consideration before Article 27.

Moderator Temple turned the chair temporarily over to Town Clerk Newton and moved that the town By-Laws be amended so as to act on appropriations and other special articles in the annual town meeting warrant, other than election of town officers, on the first Saturday following the first Monday in February. (Election of town officers would remain on the first Monday in March.) A standing vote was taken. Result announced: Yes, 13; No, 22. Motion declared lost. Moderator Temple resumed his chair.

Town Counsel Henry C. Walker then moved that the By-Laws of the Town be amended by adding the following section after Section 2 of Chapter 2, as follows: "Chapter 2, Section 2 a. The annual adjourned meeting for the transaction of all business other than the elec-

tion of town officers and the determination of matters required to be by ballot, shall be held at 2 P.M. on the Saturday following the first Monday in March of each year." Voted.

ADOPT LAW PERTAINING TO ELECTION OF TOWN OFFICERS

Article 27. Voted: on motion of Town Counsel Henry C. Walker that the Town accept the provisions of Chapter 39, Section 23, of the General Laws of Massachusetts, as most recently amended, relative to the election of town officers.

FIRE DEPARTMENT EQUIPMENT

Article 29. Voted: on motion of Fire Chief George N. O. Poirier to raise and appropriate the sum of \$300.00 for equipment and replacements in the Upton Fire Department.

TAX COLLECTOR TO BE TOWN COLLECTOR

Article 30. Voted: on motion of Town Counsel Henry C. Walker that the Town vote to amend the By-Laws by providing that the Tax Collector shall also be the Town Collector for any and all accounts due the Town in accordance with General Laws 41, Section 38A.

PLEASANT STREET BRIDGE ACCOUNT

Article 31. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the Town transfer the unexpended balance of \$517.53 in the Pleasant Street Bridge Account back to the Town Treasury.

UNEXPENDED BALANCES TO TOWN TREASURY

Article 32. Voted: on motion of Chairman of Selectmen Ernest B. Porter that the Town vote to transfer the following account balances back to the Town Treasury: Ceiling, G.A.R. Hall, \$5.00; Fire Department Equipment, \$0.50; Forest Fire Hose, \$2.00; Police Equipment, \$0.01; Bathing Beach, \$6.49; Mimeographing By-Laws, \$43.15, and World War II Honor Roll, \$43.20, total \$100.35.

GRADING AND OILING AT CEMETERIES

Article 33. Voted: on motion of Norman E. Walker that the Town raise and appropriate the sum of Five Hundred Dollars (\$500.00), said monies to be used by the Cemetery Commissioners for the purpose of grading and oiling.

• Town Treasurer Leo F. Murphy moved and it was so voted that all monies appropriated during the meeting be raised by taxation unless it had been otherwise stated in the article.

Chairman of Selectmen Ernest B. Porter motioned to dissolve the warrant and it was so voted at 5:10 P.M.

PROCEEDINGS OF SPECIAL TOWN MEETING

December 27, 1951

Moderator Malcolm C. Temple called the meeting to order. He declared a short recess until some voters came from another room in the building. There were 23 voters present by the moderator's count when he started to read the Warrant.

Harold S. Hopkins, chairman of the Finance Committee, in answer to an inquiry by Moderator Temple if the committee had acted on the article, replied that it had not as no amount was stipulated in the article in the Warrant.

Chairman of Selectmen Ernest B. Porter said that he sent a letter with a copy of the article to the Finance Committee, that the sum of \$2,748.78 was desired to make payments under the article, the names of the claimants, respective amounts, and bills for labor and materials that had been furnished.

Gorden E. Benson of Finance Committee said that the letter did not state how much additional money might be needed between the date of the letter and town meeting, if any.

Moderator Temple declared a 10-minute recess at this point after Mr. Hopkins said that the Finance Committee would meet to consider the amount asked.

Land damages incurred are as follows: Mr. and Mrs. Joseph Lessard, \$1500; Mr. and Mrs. Albert Porter, \$500; Mr. Henry J. Poirier, \$44.00, \$35.11, \$19.62, \$15.00, \$49.50, \$13.50, \$165.75, \$191.80, \$168.00 and \$46.50, totaling \$2748.78."

Report of Town Counsel

December 31, 1951

To the Board of Selectmen:

As Counsel for the Town I submit my twelfth annual report.

During 1951 I assisted and advised various departments of the town when requested and rendered opinions. Conferences took place at Boston with the Division of Accounts, and phone conferences with that office, the office of the Attorney General and Department of Public Works.

By-Laws were amended and approved.

One land damage case is pending.

The assets of the Ella W. Risteen Trust were brought into the custody of the Town Treasurer in accordance with the vote of the town.

One contract was drawn and executed, and notices to bidders and specifications were drawn.

One instrument of taking for non-payment of taxes drawn and recorded.

George A. Whittemore *vs.* Inhabitants of the Town of Upton and Clement J. Lambert, Tax Collector

On February 2, 1951, George A. Whittemore brought suit against the Town of Upton and its Tax Collector in the Superior Court in Equity by a Bill of Complaint re-

turnable in said Court March 5, 1951. The bill of complaint alleged in varied language many alleged irregularities relative to phases of town elections and town meetings, and alleged irregularities in assessment of taxes and the taking by the collector for non-payment of taxes. The bill prayed for injunctive relief and an order "forever enjoining" the tax collector and the town from interfering with the Whittemore title and use of the land in question, and further prayed that the plaintiff be declared to be and to have been since 1946 the Moderator of the town.

The case was heard in September of 1951, and the court found, among other things in its "findings of fact", that the petitioner had not paid the taxes or the bill that had been rendered and the demand for payment made, that the parcels enumerated in the notice were recognizable to the petitioner, that the petitioner owed the taxes as assessed, and that he is not the Moderator of said town.

The case was therefore dismissed and the order and decree was filed September 25, 1951.

For the interest and assistance of the town officials and the citizens, I am grateful.

Report of the Board of Public Welfare

For the Year Ending December 31, 1951

During the year ending December 31, 1951, the Board of Public Welfare was able to operate within budgets set in January and approved at that time by the Finance Committee. These budgeted figures were set lower than the previous year and proved ample as shown on the following reports. During 1951 legislation was passed which caused the town to be reimbursed on an estimated basis by the Federal Government for Old Age Assistance and Aid to Dependent Children in advance. These Federal reimbursements were received after final payrolls were paid for 1951 and must be carried forward to 1952.

During 1951 new legislation was passed which affects the operation of this department and should be of considerable interest to the taxpayers. A Lien law was passed, effective January 1, 1952, which makes it a requirement of property owners receiving Old Age Assistance or the new assistance headed Disability Assistant, to have a lien on their property so that a recovery may be made on assistance rendered after their demise or discontinuance of the case.

The new assistance program, to be known as Disability Assistance, will enable our department to handle some General Relief cases in this category that were formerly handled under General Relief. The State and Federal governments will reimburse the town 75% of the amount expended, on approved cases, in this program

which should reduce the net cost to the taxpayers in the years ahead.

Legislation was also passed that set minimum budgets on Old Age Assistance cases that will increase the amount to be spent in 1952 on many cases in this group. It should be pointed out, however, that a number of cases will not be affected by the new minimum.

Much credit for the fact that our board operated within budgets set for 1951 is due to the efficient manner our social worker, Mr. Clement Lambert, handled the duties of his office. We sincerely feel that money spent for administration in this department is being reflected in the operation and expenditures of our department.

We would like to take this opportunity to thank the Finance Committee, the Board of Selectmen, Town Council, Town Treasurer and others who have cooperated with our board during 1951. We do not look forward to the year ahead with any degree of optimism due to the closing of the Upton plant of the Merrimac Hat Corporation. While business in the area looks promising for the year ahead there are bound to be some hardship cases that will require assistance.


It will be noted that the balance as shown by the Library Report does not agree with the balance as shown in the compilation of Town figures by me. This difference results from the utilization of the interest from the Carpenter Fund as approved by the Municipal Auditors rather than the use of the interest from the Shultz Fund. The accumulated interest from the Shultz Fund will be available to the Library Trustees if and when the Town accepts this fund.

The books and accounts of the Town Treasurer I have examined and checked in detail. The recorded receipts I have checked wherever possible with the sources from which money was paid to the Town Treasurer. The payments were checked with the orders authorizing the disbursement of town funds. I have verified the cash balance on hand as of December 31, 1951 by a reconciliation of the accounts with the statements furnished by the banks.

In accordance with Section 53 of Chapter 41 of the General Laws as amended, I have examined and checked the securities and savings banks accounts representing the investment of the Trust Funds of the Town Treasurer, and find that they are as stated in the Town Treasurer's report on Trust Funds.

Librarian's Report

To the Trustees of the Upton Library:

The librarian respectfully submits her first annual report with library statistics, list of periodicals, and the catalog of new books.

Books have been added to the Dr. Carpenter alcove as required.

A gift of 115 children's books was received from the Forest Park Library of Springfield, Massachusetts; also gifts of books from the Draper Corp., Miss Eleanor Hermon, Miss Jeanne Kerflin, Mrs. Arthur MacGregor and Mr. Carl Paulson.

During July and August, a Story Hour was held each Wednesday afternoon for children from Grades I to III. Stories were told to help form a background for future reading. The attendance increased from 24 to 42.

A Vacation Reading Club was also conducted by Mrs. Arthur MacGregor for the older children. Six members received State Reading Certificates for having read five books on the State Reading List, and on the last day the children dressed in costumes representing their favorite characters.

A special program was carried out for Book Week in November. The library was opened two afternoons for the schools to visit. Seven grades came with their teachers. The new books were displayed, and book reviews were given by the librarian, suitable for the dif-

ferent grades. The use of the catalog files was shown and where to find the classified books. Both teachers and pupils were most co-operative and appreciative. A 1951 poster, "Make Friends with Books", was posted in the library and a copy was given to each school. Book marks were given out. A Story Hour was held for the younger children.

In December a Christmas Story Hour was held.

The library is a very busy place during the winter months. The school children select books for book reports and look up references. The set of Encyclopedias is in constant use and much of their school work is done in the library. The teachers are using books for supplementary reading in their classes.

I wish to thank Mrs. Ernest Bentley for a lovely winter bouquet for the library.

I am very grateful to Mrs. Bertha Frost, who retired as librarian on July 1, for her kind assistance and advice and continued interest.

I thank the trustees for their generous support and for the assistance of Mrs. Adelle Fields for the month of December.

Report of Upton School Building Committee

The new elementary school opened Feb. 26, 1950, with an enrollment of 253 pupils in grades one through seven. Ninety-five of these were transferred from the Ball School, and one hundred and 58 pupils were transferred from the Knowlton School.

In the Fall of 1951 sessions began with an enrollment of 307 in grades one through eight.

For the opening, the State Department of Safety gave temporary approval of the building pending adjustment of room ventilators to remove more air. Since this was a concern of the designers of the building and the state, the matter was turned over to Perley F. Gilbert Associates, architects.

Then followed several months during which exhaustive tests were made by the manufacturers of the equipment and the architects.

A final test on Oct. 9, 1951 disclosed that enough air was coming in to each classroom, but the ventilators still failed to comply with state specifications.

Thereupon Edmund E. McMahon, supervising engineer for the architectural firm, agreed to pay for electric fans and their installation to comply with regulations as per contract between the architects and the town.

Bids for the work have been received by the architects, and work is expected to be completed shortly.

At the time of the signing of the contracts the

building committee planned to install an equipped cafeteria kitchen off the all-purpose room. This was to be done with Risteen School Funds. It became necessary, however, to use Risteen money to equip the classrooms and do other necessary work, so the cafeteria kitchen was put off until later.

It developed that the ventilating hood and ducts for the kitchen, as well as the ventilating duct for the all-purpose room were not considered a part of the original contract. Thus, this work is to be undertaken along with the other ventilation contract, the cost to be borne, if the necessary permission is obtained from school committee, superintendent and teachers, by Risteen school funds which are still available.

With the completion of these two items, the school will be accepted by the committee, and funds will be forthcoming from the state for their share of the annual cost. Upon the building's acceptance the final architect's fee payment of \$1,326.65 will be made. All other bills have been paid.

The committee wishes to thank the townspeople who have been helpful in their attitude towards the project, and the Board of Selectmen whose members have cooperated to the fullest with the committee. The selectmen, on petition of the building committee, expended Risteen beautification funds for improving and landscaping the school.

Further thanks should be given Harry C. Snow, road commissioner, who used material from the Mendon road job to fill in much of the so-called Briggs lot in front of the new school. It is estimated the town received the benefit of several thousand dollars worth of fill.


The committee has had occasion to be thankful that

Report of the Superintendent of Schools

TO THE MEMBERS OF THE UPTON SCHOOL COMMITTEE:
Gentlemen:

I have the honor to submit my seventh annual report on the Public Schools of the Town of Upton.

Included within this report are the summaries of reports of the various departments.

This is an increase of twenty-one over the enrollment in September 1950, and sixty-two over that of September 1949.

On February 26th, 1951, pupils from the Knowlton School and some of the classes from the Ball School were moved into the Upton Memorial School. Both teachers and pupils have enjoyed the convenience and benefited from the advantages of the new building. As has been suggested in a former report, from time to time additional equipment (blackboards, shelves, etc.) should be purchased for use in the rooms there.

In these days of rising costs, it is necessary to maintain the strictest economy. In order not to exceed the present budget, a policy of thrifty administration has been practiced during the past year by the School Committee and the Superintendent of Schools.

Several sizable bills were paid for which allowance was not made in the present budget. These were created by the occupancy of the Memorial School in February and were impossible to anticipate. In some instances, therefore, planned expenditures had to be eliminated to provide for these items which were more urgent.

On a nationwide basis for the year 1948-49, the average cost of keeping one child in school for one year was \$198.00. More recent figures are not available, but it is reasonable to conclude that the national average for the year 1950-51 has been somewhat higher than that figure.

For the school year ending June 1951 the average cost per pupil in net average membership for the State of Massachusetts as a whole was \$214.40.

For the school year ending June 1951 the average cost per pupil in net average membership from local taxation in the Town of Upton was \$80.48. The total per pupil cost (local plus state reimbursement) was \$135.46.

When these figures are compared with the state and national averages, it may readily be noted that Upton's cost per pupil is very low. On the state list giving per pupil cost, of the 351 Massachusetts towns listed, Upton is sixth from the bottom.

As a result of insistent countrywide public opinion, there has been since 1946 extensive efforts to lift teachers' salaries to reasonable levels. There can be no substantial, sustained improvement in American education unless professional teachers are employed at professional salaries.

Average salaries paid to teachers for the year 1950-51 follow on a national, state and town basis:

State of Massachusetts.....	3,548 00
Town of Upton	2,517 00

A generally understood and commonly accepted belief is that in education, as in every other field of endeavor, communities usually receive the quality of service for which they pay.

Upton, however, is fortunate indeed to have received such high quality of service from a staff of loyal teachers. They have been completely cooperative in every undertaking and it gives me pleasure to commend them to you.

Of timely interest is the following excerpt from an article in the annual report of the National Education Association:

"Educators look with some concern upon the criticism that education costs too much. They recognize that taxation takes a heavy toll upon the national income and the national wealth. They are not unaware that a substantial proportion of the local and state tax dollar is required to support public education. They are equally

cognizant of the fact that retrenchment in expenditures for schools would cut back the educational rights of a generation upon whom the nation has called and is calling for the greatest sacrifices a country can ask of any generation.

There are several factors operating to increase the cost of education. The school-age population is increasing. Education must be provided for more children. The value of the dollar is decreasing. It takes more dollars to buy the same education. The American people are demanding a higher quality of education just as they are demanding higher quality in automobiles and other goods and services. Better education costs more."

Art

The art classes in the schools of Upton have been conducted with following objectives in mind:

- (1) To integrate the art activities with other subjects being studied.
- (2) To acquaint the child with many materials and methods.
- (3) To foster individual growth by encouraging the student to organize, execute, and complete his own work.

The art program includes these topics during the year's work: drawing and color, design, handicraft of some kind, and lettering.

Students are motivated by using their personal experiences . . . the sources of "self-expression" in art. Children can be encouraged and stimulated to such a point that the experience becomes quite vivid to them and they are able to express it on paper.

An exhibition of the art work of students in the

Upton Schools was held in May at the Upton Memorial School.

Music

The aim of the music program is to foster an enjoyment and an appreciation of music so that it becomes an important part of each pupil's everyday life.

In the first grade emphasis is put upon the quality of tone while building a repertory of songs. Rhythmic expression is developed through marching, swaying, and rhythm band.

This program is continued into the second, third, and fourth grades with the children becoming more familiar with the staff, scale, and note arrangement. Gradually, through daily drill and practice, the fifth and sixth grade children are able to sing a new song with a minimum of assistance from the teacher.

The seventh and eighth grade music periods are handled as a combination of practice in acquired skills and singing as a chorus group. This chorus sang United Nation Songs at the King's Daughters' Fair in October.

Reading

In order to discover more exactly the level and needs of each child in reading, standardized tests and informal analyses were made in the first four grades. The levels of reading ability and types of difficulties discovered were tabulated for reference and use in planning a program designed to bring maximum success in reading to every child.

Because, in most cases, the test results showed that several children had similar needs, small group work offered a realistic way of gearing instruction to individ-

ual needs. Five teachers in the first four grades have at least two groups working on that basis. They have helped each child progress at his own rate of speed, correct difficulties, and succeed at his own level. Thus every child has made progress. Our over-all gains have been above average in the past year.

Certainly it is as important to prevent disabilities as to correct them. Therefore, our reading program is twofold it is preventive as well as corrective. Every possible effort is made to analyze the difficulties discovered and to develop more effective means of preventing them.

School Nurse

The routine work of weighing, measuring, testing eyes and hearing, checking absentees and special individual inspections has been carried on throughout the year. First aid given to pupils injured in school or on way to school. Pupils reporting sick are checked and, when necessary, taken home and advice given for further treatment.

Dr. McKernan has completed a thorough health examination of all pupils. All defects are recorded and notices sent home to parents and recommendations made for corrections.

I am also happy to report that the Salvation Army and the King's Daughters made it possible to send two girls and three boys to camp this summer.

Personnel

In June 1951, Mrs. Elizabeth Brokaw, who has been teaching in the town since 1921, resigned. Throughout those thirty years, Mrs. Brokaw had given to the Town of Upton faithful and efficient service. I am sure that

the townspeople join the school officials in wishing her many happy years of retirement.
