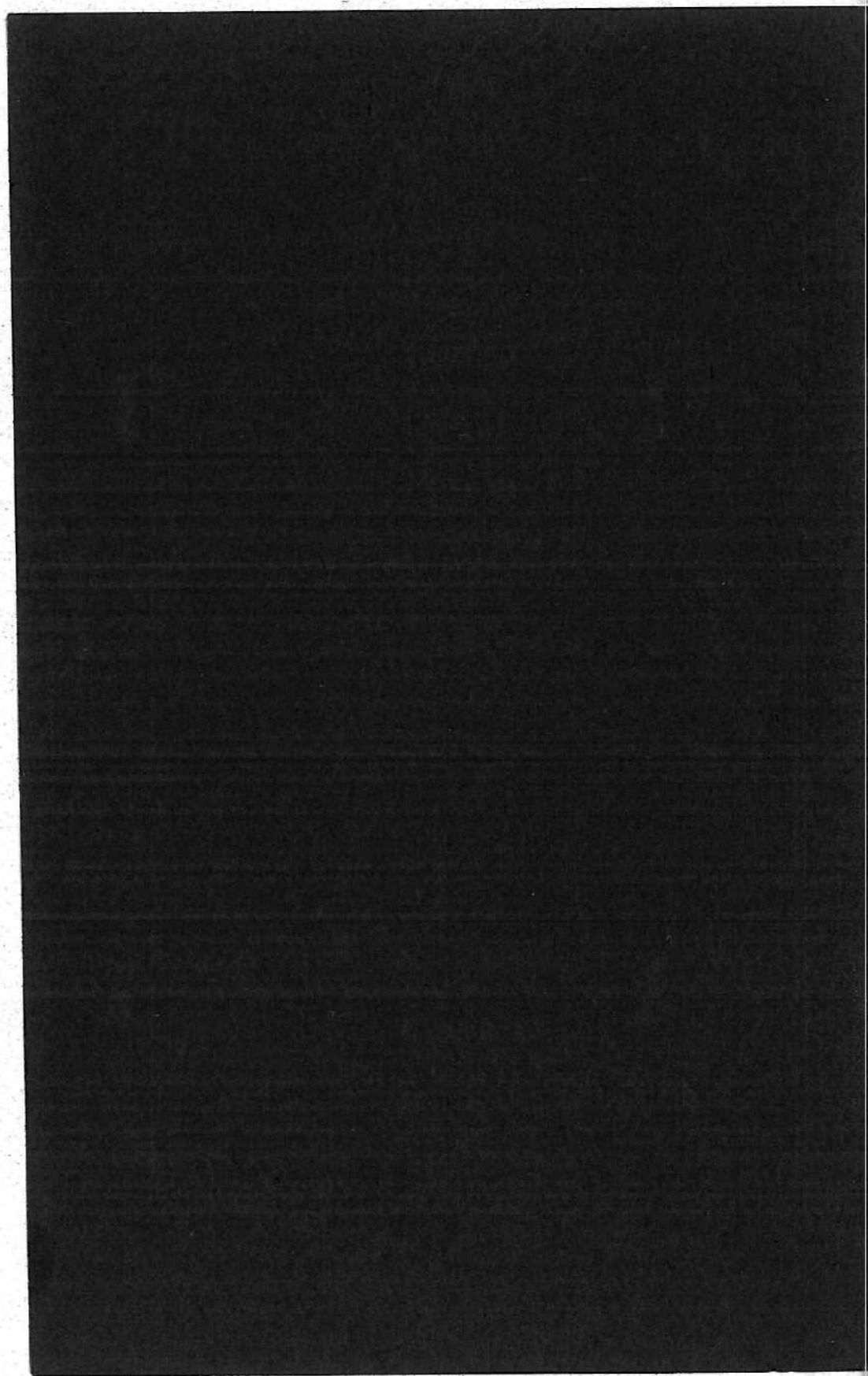

TOWN WARRANT

MARCH 2, 1953

Worcester, ss

To the Constable of the Town of Upton, in the County
of Worcester, Greeting:

In th name of the Commonwealth of Massachusetts,
you are directed to notify the inhabitants of the town of
Upton, qualified to vote in Elections and in Town Affairs,
to meet at the Town Hall, in said Upton, on Monday, the
Second day of March, punctually, at seven o'clock A.M.,
then and there to act on the following articles:

Article 1. To choose all necessary town officers for
the ensuing year: Moderator, Town Treasurer, Town
Clerk, three Selectmen, Collector of Taxes, Auditor, five
Constables, Road Commissioner, and Tree Warden, all
for one year: one Assessor of Taxes, one member of the
Board of Public Welfare, one member of the School Com-
mittee, one Cemetery Commissioner, one Park Commis-
sioner, and three Trustees of Public Library, all for three
years; one member of the Housing Authority for five
years; and three Water and Sewer Commissioners, one
for one year, one for two years, and one for three years.

All of the above to be voted for upon one ballot.

The remaining articles contained in the warrant will be acted upon at an adjourned meeting of the voters in Town Hall on Saturday afternoon, March 7, 1953, at 2 o'clock P.M.

Article 2. To hear the reports of all town officers and do or act in any manner pertaining thereto.

Article 3. To hear reports of any committees appointed by the town, and do or act in any manner pertaining thereto.

Article 4. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by Section 108 of Chapter 41, General Laws as amended: Moderator, Selectmen, Town Treasurer, Town Clerk, Collector of Taxes, Assessors of Taxes, Board of Public Welfare, School Committee, Auditor, Cemetery Commissioners, Constables, Trustees of Public Library, Road Commissioner, Tree Warden, and Water and Sewer Commissioners or do or act in any manner pertaining thereto.

Article 5. To raise and appropriate such sums of money as may be necessary to defray expenses of Town departments for the ensuing year, or do or act in any manner pertaining thereto.

Article 6. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1,

1953, and to issue a note or notes therefore, payable within one year and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 7. To see if the Town will vote to authorize the Board of Selectmen to appoint one of its members as Chief of Police or Acting Chief of Police, and to establish a salary to be taken from the Police Appropriation for such appointee in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 8. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars, (\$2,000.00), for Chapter 90 Construction of Pleasant Street, said money to be used in conjunction with any money

which may be allotted by the State or County or Both, for this purpose, or do or act in any manner pertaining thereto.

Article 9. To see if the Town will vote to appropriate the proceeds of the 1952 Dog Tax Refund received from the county, to the School Account, or do or act in any manner pertaining thereto.

Article 10. To see if the Town will vote to raise and appropriate the sum of Three Hundred Six Dollars and Forty-eight Cents (\$306.48), in accordance with provisions of Chapter 32, Section 22, General Laws, for Pen-

sion Fund, Expense Fund, and Military Services Fund of the Worcester County Retirement System, for 1952, or do or act in any manner pertaining thereto.

Article 11. To see if the Town will vote to raise and appropriate the sum of Five Hundred Seven Dollars and Seventy-three cents, (\$507.73), said money for unpaid bills in the Water and Sewerage Department, or do or act in any manner pertaining thereto.

Article 12. To see if the Town will vote to raise and appropriate the sum of Seventeen Hundred Dollars (\$1,700.00), this being the last payment on equalization of valuation of the Town, or do or act in any manner pertaining thereto.

Article 13. To see if the Town will authorize the School Committee to appoint one of its members as School physician, in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 14. To see if the Town will authorize the Cemetery Commissioners to appoint one of its members as Supervisor of Lakeview Cemetery, and to pay such Supervisor as per schedule set by Cemetery Commissioners, in accordance with the provisions of General Laws, Chapter 41, Section 4A, or do or act in any manner pertaining thereto.

Article 15. To see if the Town will vote to accept the bequest of Seventy-five Thousand Dollars (\$75,-

000.00), such bequest to be held in trust and to be called the William Knowlton Trust Fund, the interest and net income thereof to be annually expended for Public Purposes, as provided under Clause 9 of the will of William Knowlton, late of Upton, Mass., or do or act in any manner pertaining thereto.

Article 16. To see if the Town will vote that the School be named the Upton Memorial School in memory of Upton's Dead of World War II and the Korean War and in memory of Ella Whitney Risteen, or do or act in any manner pertaining thereto.

Article 17. That the Town vote that a suitable plaque bearing the above mentioned contents of Article 16, be installed in the building and a necessary sum of money be appropriated for same, or do or act in any manner pertaining thereto.

Article 18. To see if the Town will vote that the sign, "Upton Memorial School", originally planned but eliminated for lack of funds, be erected on the Main Street wall of the auditorium and a necessary sum of money be appropriated therefor, or do or act in any manner pertaining thereto.

Article 19. To see if the Town will vote to discharge the Elementary School Building Committee, or do or act in any manner pertaining thereto.

Article 20. To see if the Town will vote to establish and maintain a Town Dump at the lower end of Hartford

Avenue in West Upton, and to discontinue the use of and close the present Town Dump at Warren Street, and to authorize and instruct the Selectmen to make the necessary arrangements and execute and accept a lease or other written instrument for the new location, or do or act in any manner pertaining thereto.

Article 21. To see if the Town will vote to raise and appropriate the sum of Eighteen Dollars (\$18.00), for the installation of one street light on South Street, or do or act in any manner pertaining thereto.

Article 22. To see if the Town will vote to raise and appropriate the sum of Thirty-six Dollars (\$36.00), for the installation of two street lights on Warren Street, or do or act in any manner pertaining thereto.

Article 23. To see if the Town will vote to accept Reservoir Street Extension, so-called, as laid out and reported by the Board of Selectmen and filed with the Town Clerk as prescribed by Law, as a Public Town Way, or do or act in any manner pertaining thereto.

Article 24. To see if the Town will vote to raise and appropriate the sum of Five Hundred Seventy-seven Dollars and Fifty Cents (\$577.50), said money to be used to pay the Care of Patients Bills incurred in 1952, or do or act in any manner pertaining thereto.

Article 25. To see if the Town will vote to raise and appropriate the sum of Three Hundred and Four

Dollars and Ninety-four Cents (\$304.94), said money for bills incurred in the Town Halls and Expenses Account during 1952, or do or act in any manner pertaining thereto.

Article 26. To see if the Town will vote to raise and appropriate the sum of Two Hundred Sixty-eight Dollars and Forty-five Cents (\$268.45), said money for bills incurred in the Department of Veterans' Service during 1952, or do or act in any manner pertaining thereto.

Article 27. To see if the Town will vote to transfer the earnings of the Machinery Fund of 1952 to the Machinery Account of 1953, or do or act in any manner pertaining thereto.

Article 28. To see if the Town will vote to raise and appropriate the sum of Three Hundred Fifty Dollars (\$350.00), said money to be used by the Fire Department for the purchase of new hose, or do or act in any manner pertaining thereto.

Article 29 To see if the Town will vote to raise and appropriate the sum of Three Hundred Dollars (\$300.00), said money to be used for the finish painting and finishing of the new Fire Station, or do or act in any manner pertaining thereto.

Article 30. To see if the Town will vote to raise and appropriate the sum of Five Hundred Dollars

(\$500.00), said money to be used by the Cemetery Commissioners for the purpose of Grading and Oiling, or do or act in any manner pertaining thereto.

Article 31. To see if the Town will vote to transfer to the Town Treasury the unexpended balance in the new School appropriation, said amount being One Hundred Eleven Dollars and Sixty-five Cents (\$111.65), or do or act in any manner pertaining thereto.

Article 32. To see if the Town will vote to raise and appropriate the sum of One Hundred Twenty Dollars (\$120.00), said money to be used to purchase new Suction Hose for the Forest Fire Department, or do or act in any manner pertaining thereto.

Article 33. To see if the Town will vote to raise and appropriate the sum of Six Hundred Fifty Dollars (\$650.00), as the Town's payment of Hydrant rental to the Water and Sewer Department, or do or act in any manner pertaining thereto.

Article 34. To see if the Town will vote to have the moderator appoint a Committee of three to investigate all matters pertaining to Regional Schools as set up under Chapter 71 of the General Laws, Section 14 to 161 inclusive, or do or act in any manner pertaining thereto.

Article 35. To see if the Town will vote to name or appoint a committee to look into the feasibility of the Town establishing a Department of Public Works, or do or act in any manner pertaining thereto.

Article 36. To see if the Town will vote to take any action on any reports or information brought forward on the disposition of the Grand Army Hall, or do or act in any manner pertaining thereto.

Article 37. To see if the Town will vote to abandon an old section of Mendon Street, said street commencing at a point approximately fifteen hundred feet southeast of the intersection of Chestnut and Mendon Streets, and continuing in a southeasterly direction for a distance of approximately twenty-five hundred feet and ending at the Mendon Town Line on the Powers farm located in Mendon, or do or act in any manner pertaining thereto.

Article 38. To see if the Town will vote to accept the provisions of Chapter 2260 of the Acts of 1953, establishing a Town of Upton Water System, or do or act in any manner pertaining thereto.

Article 39. To see if the Town will vote to develop well fields, extend present water mains and water systems, erect pumping station with pump, install new standpipe and generally improve water distribution facilities in the Town of Upton, and raise and appropriate the sum of Two Hundred Twenty-two Thousand Dollars (\$222,000.00), and to authorize and instruct the Town Treasurer to issue bonds or notes therefor which shall bear on their face the words "Upton Water Loan, Act of 1953", each authorized issue constituting a separate loan, and such loan or loans payable in not more than thirty (30) years from their dates, said loans to be within the debt limits prescribed by the last paragraph of Section 8, Chapter 44 of the General Laws, and in accordance

with House Bill No. 2260 now pending before the Legislature, or do or act in any manner pertaining thereto.

Article 40. To see if the Town will vote to raise and appropriate a sum of money to be used for the purpose of black-topping in front of the new Fire Station, or do or act in any manner pertaining thereto.

Article 41. To see if the Town will vote to raise and appropriate the sum of One Hundred Dollars (\$100.00), said money to be used to install conductor pipe and eaves trough on the new Fire Station, or do or act in any manner pertaining thereto.

Article 42. To see if the Town will vote to raise and appropriate the sum of Ninety-seven Dollars (\$97.00), said money to be used to balance the books in the Town Halls and Expenses Account for 1952, or do or act in any manner pertaining thereto.

Article 43. To see if the Town will vote to take from available funds in the Town Treasury a sum of money not to exceed Ten Thousand Dollars (\$10,000.00), said money to be used by the Board of Assessors to establish the tax rate for 1953, or do or act in any manner pertaining thereto.

Article 44. To see if the Town will vote to authorize the Board of Selectmen to make the necessary arrangements and execute and accept a lease or other written instrument, and to raise and appropriate the sum

of One Dollar (\$1.00) for same, said money to be used in providing a parking area in West Upton on the Stone property, or do or act in any manner pertaining thereto.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting:—At each of the Post-offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF ANNUAL TOWN ELECTION

March 2, 1953

Pursuant to the Warrant, Moderator Malcolm C. Temple called the meeting to order at 7 o'clock A.M.

After reading the call of the meeting and Article 1, for choosing of necessary officers, Selectman Daniel H. Bates moved that reading of the remaining articles be waived and to be acted upon at adjourned town meeting, March 7, 1953 at 2 P.M. Motion was seconded and voted. Moderator Temple resumed reading of the remainder of the Warrant and Constable's return.

Prior to opening of the meeting, Moderator Temple invited any voter to inspect the ballot box which was opened. The box's indicator was set at 0000. Officer Oscar K. Bates was on duty at ballot box and held the keys to the box throughout voting hours.

A sealed box purporting to contain 1800 ballots was turned over to Edward J. Gurry and Edward L. Prentiss, ballot clerks. At the check-out at ballot box were William

J. Gorman and Arthur J. Page. The checkers were sworn to perform their duty by the Town Clerk before balloting began.

Selectman Daniel H. Bates was the first voter to cast his ballot. Rep. Gladys G. Crockett, member of the Board of Selectmen, was first woman voter.

Indicator on ballot box read at hourly intervals during the day read as follows: 8 A.M., 27 ballots cast; 9 A.M., 44; 10 A.M., 66; 11 A.M., 98; 12 noon, 142; 1 P.M., 175; 2 P.M., 224; 3 P.M., 270; 4 P.M., 327; 5 P.M., 471; 6 P.M., 609; 7 P.M., 786, and 8 P.M., 895. There were 894 ballots cast and counted. Ballot No. 814 became caught in ballot box mechanism. It had to be removed then run through, causing bell and indicator to register twice.

First removal of ballots from ballot was at 3:30 P.M. when 300 ballots were taken out and counted in presence of election officials. At 6 P.M., an additional 300 ballots were removed, and after polls closed at 8 P.M., 294 ballots. Total, 894 ballots.

Tellers reporting at 4 P.M. to canvass vote were: Mrs. Helen I. Donham, Mrs. Margaret M. Henderson, Mrs. Ruth A. Sweet, Mrs. Rita C. Cutler, Mrs. Helen Poirier, Mrs. Celestine I. Mason, Mrs. Ada W. White and Samuel B. Young.

Tellers reporting at 6 P.M. were: Mrs. Yvonne M. Bissonnette, Mrs. Alice G. Cooley, Mrs. Elizabeth Victor,

Mrs. Mary A. Gilchrist, LeRoy W. Prentiss, Mrs. Norma L. Taft, Mrs. Harriet Driscoll and Mrs. Bessie F. Atwood.

Mrs. Irma L. Prentiss reported at 8 P.M. to succeed Mrs. Mason as a teller as the latter was obliged to leave.

Edward J. Furphy reported at 6 P.M. and served as a checker. After 8 P.M. he and Edward L. Prentiss tabulated the vote.

The Town Clerk administered oath to above persons to perform their respective duties.

Voting lists used at the two tables were compared and each showed 894 names checked: 463 men and 431 women voters.

Used and unused ballots were deposited in containers, sealed, and placed in the town vault.

Public declaration of the voting was made at 11:40 P.M. Writing-in of over 40 names for Moderator and nearly as many names for Park Commissioner delayed canvass of ballots. (No candidate filed nomination paper for either office.)

(a) County Hospital, Maintenance, Care of Patients Assessments. Selectman Ernest B. Porter stated that state accountants had advised that this assessment need not be appropriated as it is included in compilation of tax rate by assessors on commitment from the County.

(b) Highways—Chapter 81. Road Commissioner Harry C. Snow moved that the sum of \$4,500.00 be raised

and appropriated to meet the Town's share of the cost of Chapter 81 Highways, and that, in addition, the sum of \$16,500.00 be transferred from unappropriated available funds in the Treasury to meet the State's share of the cost of the Work, the reimbursements from the State to be restored upon their receipt to unappropriated available funds in the treasury. Motion seconded. Voted.

AUTHORIZATION TO BORROW MONEY

Article 6. Voted: on motion of Town Treasurer Leo F. Murphy, duly seconded, that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1953, and to issue note or notes therefore, payable within one year and to renew any note or notes

as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws. Unanimous vote declared by the Moderator.

AUTHORIZING SELECTMEN TO APPOINT ONE
OF ITS MEMBERS AS POLICE CHIEF

Article 7. Voted: on motion of Selectman Daniel H. Bates, duly seconded, that the Board of Selectmen be authorized to appoint one of its members as Chief of Police in accordance with the provisions of the General Laws, Chapter 41, Section 4A, and a salary be set at \$50.00 a month and salary be taken from Police Department Appropriation.

In answer to a question, Selectman Bates said the monthly amount stipulated in the motion was an increase of \$15.00 per month compared with 1952 salary.

PLEASANT STREET

Article 8. Rejected: motion of Selectman Ernest B. Porter, duly seconded, to raise and appropriate the sum of Two Thousand Dollars (\$2,000.00) for Chapter 90 Construction of Pleasant Street, and in addition, transfer from unappropriated available funds the sum of Six Thousand Dollars (\$6,000.00) to meet the State and County's shares of the work, said money to be returned to the town treasury on reimbursement.

Before vote was taken, Selectman Daniel H. Bates moved to amend Mr. Porter's motion that \$1,500.00 be appropriated for Chapter 90 work on Church Street.

Moderator Struthers ruled that the article called for Pleasant Street and he could not entertain the motion to amend. Howard Heald moved to lay the question on the table. Motion seconded. Declared lost. Original motion then acted upon and declared lost.

Mr. Porter said that it had been learned that the town of Northbridge did not plan to do special work on its section of the highway this year. He added, the Selectmen had been informed that it was possible that a Chapter 90 Construction grant might be obtained from the State for Church Street on which the new Fire Station was erected in 1952.

Porter, duly seconded, to raise and appropriate the sum of Three Hundred and Six Dollars and Forty-eight Cents (\$306.48), in accordance with Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund and Military Services Fund of the Worcester County Retirement System for 1952.

1952 WATER AND SEWER BILLS

Article 11. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to raise and appropriate the

sum of Five Hundred and Seven Dollars and Seventy-three Cents, (\$507.73), said money to be used to pay bills incurred in the Water and Sewer Department during 1952. Moderator Struthers declared the vote unanimous.

REVALUATION CONTRACT PAYMENT

Article 12. Voted: on motion of Selectman Ernest Porter, duly seconded, to raise and appropriate the sum of Seventeen Hundred Dollars (\$1,700.00), said money to be used for final payment on the revaluation of the Town.

AUTHORIZING SCHOOL COMMITTEE TO APPOINT ONE OF ITS MEMBERS AS SCHOOL PHYSICIAN

Article 13. Voted: on motion of Mrs. Elsie J. Craib of the School Committee that the Town authorize the School Committee to appoint one of its members as School Physician, in accordance with the provisions of General Laws, Chapter 41, Section 4A.

AUTHORIZING THE CEMETERY COMMISSIONERS TO APPOINT ONE OF ITS MEMBERS AS SUPERVISOR

Article 14. Voted: on motion of Cemetery Commissioner Donald R. Keniston, duly seconded, that the Cemetery Commissioners be authorized to appoint one of its members as Supervisor of Lakeview Cemetery in accordance with General Laws, Chapter 41, Section 4A, and that the salary of \$1.05 per hour be set to be taken from the Cemetery Appropriation.

ACCEPTANCE OF BEQUEST UNDER
WILL OF WILLIAM KNOWLTON

Article 15. Voted: on motion of Selectman Ernest B. Porter, duly seconded, that the Town accept the bequest of Seventy-five Thousand Dollars (\$75,000.00), such bequest to be held in trust and to be called the "William Knowlton Trust Fund", the interest and net income thereof to be annually expended for public purposes as provided under Clause 9 of the will of William Knowlton, late of Upton, Mass.

In voting acceptance of the bequest, voters stood in silence in memory of the late Mr. Knowlton. (Mr. Knowlton passed away July 14, 1952.)

ELEMENTARY SCHOOL BUILDING
NAMED "UPTON MEMORIAL SCHOOL"

Article 16. Voted: on motion of Mrs. Elsie J. Craib of the School Committee, duly seconded, that the new school be named the "Upton Memorial School" in memory of Upton's Dead of World War II and the Korean War and in memory of Ella Whitney Risteen.

PLAQUE TO BE INSTALLED IN
UPTON MEMORIAL SCHOOL

Article 17. Voted: on motion of Town Counsel Henry C. Walker, duly seconded, to raise and appropriate One Hundred Dollars (\$100.00), to install a suitable plaque bearing the above mentioned contents of Article 16 and William Knowlton to be installed in Upton Memorial School.

Moderator Struthers ordered a standing vote after more than the required number doubted his ruling that a voice vote on the motion had been favorable.

Officers Oscar K. Bates and Arthur J. Leclaire made the count of the standing vote. Results: Yes—52; No—14.

"UPTON MEMORIAL SCHOOL" SIGN

Article 18. Passed over on motion of Selectman Ernest B. Porter, duly seconded. Mr. Porter explained that he favored this action until landscaping of school grounds is completed.

DISCHARGE OF UPTON MEMORIAL SCHOOL BUILDING COMMITTEE

Article 19. Voted: on motion of Selectman Ernest B. Porter, duly seconded by Selectman Daniel H. Bates, to discharge the Elementary School Building Committee (now Upton Memorial School) with thanks for their services.

NEW TOWN DUMP

Article 20. Voted: on motion of Arthur M. Bartlett, duly seconded, "that we accept proposal of Joseph Jacques to establish and maintain a Town Dump at the lower end of Hartford Avenue in West Upton, and discontinue the use of and close the present Town Dump at Warren Street, and to authorize and instruct the Selectmen to make the necessary arrangements and execute and accept a lease or other written thereto."

STREET LIGHTS

Articles 21 and 22. Voted: on motion of Gordon E. Benson, duly seconded, to act on both articles jointly. It was then voted to install one street light on South Street and two street lights on Warren Street, cost of same to be taken from Street Light Account.

SO-CALLED RESERVOIR STREET EXTENSION

Article 23. Voted: on motion of Malcolm C. Temple, duly seconded, to postpone action on this article until next Special Town Meeting.

William A. Bellofatto moved that the Town accept Reservoir Street Extension, so-called, as laid out as reported by the Board of Selectmen and filed with the Town Clerk as prescribed by law, as a Public Town Way. Motion was seconded by Representative Gladys G. Crockett, member of the Board of Selectmen.

A lengthy discussion took place on this article, including the number of releases given by abutters of the proposed highway.

Article 37. Voted: on motion of Selectman Daniel H. Bates, duly seconded, to abandon an old section of Mendon Street as set forth in article.

UPTON WATER SYSTEM

Articles 38 and 39. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to pass over said articles.

BLACK-TOPPING IN FRONT OF NEW FIRE STATION

Article 40. Voted: on motion of Selectman Daniel H. Bates, duly seconded, that the sum of Five Hundred Dollars (\$500.00) be raised and appropriated to black-top in front of new Fire Station.

Moderator Halbert K. Struthers called the meeting to order and read the warrant. More than a quorum (20) voters were present when meeting opened.

Voting list was used at main entrance to hall and name of each voter attending checked. Douglas J. Gilchrist (D) and Alfred H. Nichols (R) were checkers. They were sworn by Town Clerk before they began their duties.

CHURCH STREET

Article 1. Voted: on motion of Selectman Daniel H. Bates, duly seconded, to pass over the article.

ADDITIONAL APPROPRIATION TO TOWN COUNSEL'S
EXPENSES ACCOUNT

Article 2. Voted: on motion of Representative Gladys G. Crockett, chairman of Selectmen, duly seconded, to raise and appropriate the sum of Two Hundred Dollars (\$200.00) to supplement the Town Counsel's Expense Account.

ADDITIONAL APPROPRIATION TO PRINTING ACCOUNT

Article 3. Voted: on motion of Representative Gladys G. Crockett, duly seconded, to raise and appropriate the sum of Five Hundred Dollars (\$500.00) to supplement the Printing Account.

GRAND ARMY HALL BUILDING

Article 4. Voted: on motion of Selectman Daniel H. Bates, amended by Charles R. Stuart, that the Selectmen be authorized to appoint a committee of three voters to dispose of the GAR Hall Building in the best interest of the town, said committee to investigate and report back at a special town meeting within two months.

A motion by Town Counsel Henry C. Walker, duly seconded, to pass over the article after it was read by Moderator Struthers, was defeated by a standing vote, 34 to 14. Officers Arthur J. Leclaire and Alvin P. Nichols made the count at direction of the moderator.

Selectman Daniel H. Bates then motioned that the Selectmen be authorized to appoint a committee of three voters to dispose of GAR Hall in the best interest of the town, duly seconded.

A discussion followed concerning the future of the building erected over 180 years ago and a town landmark.

SALARY OF SCHOOL PHYSICIAN IF

Article 9. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to establish the School Physician's salary at Two Hundred Dollars (\$200.00), said salary to be taken from the School Department's Appropriation.

This action was taken to clarify vote under Article 13 at adjourned annual town meeting, March 7, 1953, when the Town authorized the School Committee to appoint one of its members as School Physician in accordance with the provisions of General Laws, Chapter 41, Section 4A.

ACCEPTANCE OF CHAPTER 202, ACTS OF 1953
AUTHORIZING ADDITIONAL WATER LOANS AND
ABOLISHING UPTON CENTER WATER DISTRICT

Article 10. Voted: on motion of Selectman Ernest B. Porter, duly seconded, "that the Town vote to accept the provisions of Chapter 202 of the Acts of 1953, this act authorizing the Town of Upton to make additional water loans and abolish the Upton Center Water District in the Town of Upton, to wit:

"Section 1. For the purpose of developing well fields, extending the present water mains and water system, erecting pumping station with pump, installing new standpipe and improving water distribution facilities, the Town of Upton may borrow from time to time such sums as may be necessary, not exceeding, in the aggregate, two hundred and twenty-two thousand dollars, and may issue bonds or notes therefor which shall bear on their face the words, 'Upton Water Loan, Act of 1953.' Each authorized issue shall constitute a separate loan, and such loans shall be payable in not more than thirty years from their dates. Indebtedness incurred under this act shall be in excess of the statutory limit, but shall, except as provided herein, be subject to the provisions of Chapter 44, of the General Laws.

"Section 2. Chapter two hundred and twenty of the acts of nineteen hundred and forty-six and chapter one hundred and ninety-five of the acts of nineteen hundred and forty-nine, relating to the establishment of the Upton Center Water District in the town of Upton, are hereby repealed.

"Section 3. The Town of Upton is hereby authorized to take over all the properties, rights, powers and privileges of the Upton Center Water District established by Chapter two hundred and twenty of the acts of nineteen hundred and forty-six and amended by Chapter one hundred and ninety-five of the acts of nineteen hundred and forty-nine, and to assume all the duties and obligations of said district, and shall thereby become in all respects the lawful successor to said district.

"Section 4. The provisions of this act shall not affect any act done, ratified or confirmed by said district or any of its officers prior to the effective date of this act, nor any right accrued or established, nor any action, suit or proceeding commenced or had in a civil case, nor shall it impair the validity of any of the notes, bonds, or other obligations of said district outstanding on said date. Any indebtedness incurred by said district and outstanding at the time it is taken over by the town shall be assumed by the Town.

"Section 5. The powers and duties vested in the Board of Water Commissioners of said district shall be assumed and carried out by the Board of Water Commissioners of the Town of Upton.

"Section 6. This act shall take full effect upon its acceptance by a majority of the registered voters of the Town of Upton voting thereon at the annual or a special town meeting called for the purpose in the current year, but not otherwise."

Selectman Porter read the special legislative act, approved by Governor Christian L. Herter, March 23, 1953.

AUTHORIZATION TO BORROW FOR WATER SYSTEM

Article 11. Voted: on motion of Selectman Ernest B. Porter, duly seconded by Selectman Daniel H. Bates, "that the Town vote to raise and appropriate the sum of two hundred and twenty-two thousand dollars (\$222,000.00), for the purpose of developing well fields,

extending present water mains and water system, erecting pumping station with pump, installing new standpipe and improving water distribution facilities in the Town of Upton, and to provide for payment of the same, by borrowing said sum and the Treasurer be and hereby authorized to issue bonds or notes which shall bear on their face, the words 'Upton Water Loan, Acts of 1953,' each issue constituting a separate loan, and such loan or loans being payable in not more than thirty (30) years from their dates, in accordance with Chapter 202 of the Acts of 1953." Moderator Struthers declared the vote unanimous, there being no dissenting voice.

Harold S. Hopkins, chairman of the Finance Committee, stated that the said committee recommended favorable action before vote was taken.

There were several voters speaking and asking questions pertaining to proposed extension of the water system, etc. before Selectman Porter's motion was acted upon.

Delwyn K. Barnes of Whitinsville, an engineer, whose service had been requested by officials in recent weeks in connection with Upton's water system, was given the privilege to address the voters and answer their questions.

Before dissolving the warrant, Town Treasurer Leo F. Murphy moved that money appropriated during this

meeting be raised by taxation unless otherwise stated in the motion. Seconded and voted.

PROCEEDINGS OF SPECIAL TOWN MEETING

July 30, 1953

Moderator Halbert K. Struthers called the meeting to order. He stated there were 25 voters in the hall at the time. (Twenty is a quorum.) A check list was used at the

door to the main hall with John E. Craib and Allan S. Donham, appointed by the Moderator, having been sworn as checkers. More voters arrived during the reading of the warrant and constable's return by the Moderator. Names of 56 voters were check.

RENT CONTROL QUESTION

Article 1. Alanson J. Varney mentioned to accept Article 1 as read. Selectman Daniel H. Bates seconded the motion.

Malcolm C. Temple asked for an explanation of the Rent Control Act.

Among the speakers were Representative Mrs. Gladys G. Crockett, chairman of the Board of Selectmen; Town Counsel Gordon A. Shaw, Harold S. Hopkins, chairmen of the Finance Committee, and Edward L. Prentiss.

Following the discussion, Malcolm C. Temple moved to amend the motion that the town is not a critical area for housing and therefore do not accept the Act. The amendment offered was seconded.

Mr. Varney asked if the Moderator ruled the motion to amend was legal. Moderator Struthers declared in the affirmative.

Moderator Struthers appointed Alexander Kennedy and Police Officer Arthur F. Bartlett to make a count of the standing vote on the motion to amend.

Result of the count: In favor of Mr. Temple's motion, Yes—30, No—10.

INCREASING AMOUNTS OF PENSIONS,
RETIREMENT ALLOWANCES AND ANNUITIES FOR
CERTAIN FORMER PUBLIC EMPLOYES

Article 2. Voted: on motion of Representative Mrs. Gladys G. Crockett, chairman of Board of Selectmen, duly seconded, to accept Chapter 624 of the Acts of 1952. Standing vote: Yes—27, No—9.

Prior to taking the vote there was a discussion concerning purpose of the Act. Mrs. Crockett said that many municipalities had accepted the provisions.

REPAIRS OF CERTAIN HIGHWAYS

Article 3. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to take from unappropriated available funds in the treasury the sum of Three Hundred Dollars (\$300.00) for Warren Road, Two Hundred and Fifty Dollars (\$250.00) for Warren Street and Two Hundred Dollars (\$200.00) for Glen View Street, said monies to be used for minor street repairs. The voice vote taken was declared unanimous by the Moderator.

Before action was taken on the article there was a discussion as to a layout of Warren Road.

At this point in the meeting, Joseph W. Gorman asked for an opinion of the Town Counsel as to the legal-

ity of the motion to amend that had been presented by Malcolm C. Temple under Article 1. Town Counsel Shaw replied that in his opinion the motion was legal.

TOWN AMBULANCE

Article 4. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to pass over the article.

G.A.R. BUILDING

Article 5. Voted: on motion of Selectman Ernest B. Porter, duly seconded, to pass over the article.

Motion to dissolve the warrant and adjourn was made, duly seconded, and voted at 9:05 P.M.

Town Treasurer's Statement

There is deposited in the Milford Savings Bank, \$10.76 known as the Knowlton School Fund with the Town Treasurer as Trustee, to be used by the School Committee to defray extraordinary expenses at the Knowlton School Building.

There is deposited in the Milford Savings Bank, one thousand dollars (\$1,000.00) known as the Ella (Whitney) Risteen Fund in trust with the Town Treasurer and School Committee as Trustees, the income to be divided between the two pupils in our High School who make the most progress during each year. \$31.85 Interest was received this year. \$50.00 was used this year.

There is deposited in the Worcester County Institute for Savings, one thousand dollars (\$1,000.00) known as the Dr. Carpenter Library Fund, the income of which is to be used for the Public Library. \$30.00 Interest was received this year.

Charlotte A. Batchelor and George W. Knowlton established a Trust Deed at the Worcester County Trust Co., with the bank as Trustee, the income to be paid to the Town of Upton for use of Public Schools. \$198.00 was received this year.

There is deposited in the Milford Savings Bank, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Library. \$143.75 was received this year.

There is deposited in the Worcester County Institute for Savings, five thousand dollars (\$5,000.00) known as the Charlotte A. Batchelor School Fund in trust with the Town Treasurer as Trustee, the income to be used for the Public Schools. \$150.00 was received this year.

There is deposited in the Milford Savings Bank, a War Bonus Surplus Fund to be used as a nucleus of a Fund for Public Library Building as voted by the Town, February 7, 1925. \$107.66 Interest was received and the amount of this Fund on January 1, 1954 was \$3,826.44.

There is deposited in the Milford Savings Bank of Milford, five thousand dollars (\$5,000.00) known as the George W. Knowlton Fund. The Income is subject to withdrawal by the Town Treasurer on order from the Board of Selectmen, to be used to help the townspeople who are in distress. \$147.31 Interest was received and the balance on January 1, 1954 was \$5,234.66.

The Industrial Accident Insurance Fund established in 1937 is deposited in the Milford Savings Bank. \$61.52 Interest was received and the balance on January 1, 1954 was \$1,989.34. Payment from this Fund is to be made only in accordance with rules to be established by the Board of Selectmen. \$197.00 was used this year.

Report of Board of Water and Sewer Commissioners

For the year ending December 31, 1953

The voters of the Town of Upton voted to elect a board of water and sewer commissioners at their last election of officers.

We, the board of water and sewer commissioners, after being elected started by electing Edward Orff, chairman and Raymond Griffin, clerk for the following year with Thomas Francis as third member of the board.

At one of our first meetings we met with Henry Poirier and appointed him as water superintendent and superintendent of construction for the following year. At this meeting we entered into a discussion as to what we should do in regard to expanding the system. We had been notified by the Mass. Dept. of Public Works that reconstruction of Route 140 from West Upton to Elm St., Upton was to be done this year starting early in May. This road wasn't to be disturbed for a period of five years so that meant that we would either go ahead and expand or forget it for a period of five years. We thought it best to go ahead and do all possible in our power as a board to lay this system out, and have one that would be approved by the State, and the Fire Underwriters of Mass. This presented some obstacles. Whereas we needed an engineer, Mr. Delwyn K. Barnes of Whitinsville was engaged to do the work. He went ahead and drew up plans, wrote specification, etc., and then we met with the fire underwriters in Boston and they approved the system as laid out.

The system is to be as follows: Starting at the pumping station in West Upton, the water is to be pumped

along Main St., up Warren St. to the standpipe on Pratt Hill and from there to be distributed to parts of town as fast as mains and services are provided.

By this time the preliminary work was done and we were ready to let out bids for Main St., West Upton to Elm St., Upton. This was done and Ralph White Construction Co., of Auburn, Mass., was low bidder and received the contract.

When this work was most finished we thought that we should go ahead and let out other streets for bid because the people were suffering with a water shortage and the system needed water takers to ever be self-supporting. It was decided that we group all other streets without water and put them out to bid and go as far as we thought advisable for the present time. Johnson Bros., of Auburn, Mass., were low bidders and the contracts were signed. Streets which have been serviced to date include: North Main St., Warren St., Nelson St., School St., Pleasant St., Mendon St., Plain St., Grove St., and Fiske Ave.

On March 14, 1953, I was sworn in as Civil Defense Director of the Town of Upton.

The Defense Council originally appointed in 1950 is still intact, as well as the other personnel required by the State Director.

Clement J. Lambert has been designated as director of Civilian War Aid. Evacuee Registration is in charge of Edward J. Furphy—Memorial School Building.

During the Tornado Disaster your director was in close contact with Harold F. Rossi, Adm. Asst. Reg. III as well as with H. W. Hawkins. C.D.D. for Westboro awaiting any orders or requests for assistance. Our services were offered

OUTSIDE MEETINGS—

On March 23, 1953, at Milford High School, Mr. Rossi held a Sector IV meeting for instructions. Geo. N. Poirier and I attended.

On April 22, 1953, at the Sheraton Plaza Hotel, Boston, a State Civil Defense meeting was called which I attended.

On May 5, 1953, Mr. Rossi called a meeting at the Milford High School preparatory to the RED ALERT for

Reg. III held (due) 11 a.m., May 14. Present at this meeting from Upton, were Geo. N. Poirier, Eugene Closson and myself.

At Worcester Municipal Auditorium, Little Theatre, on October 29th, a meeting of all Civil Defense Directors of the Region was called by Francis J. McGrath, Regional III Director. Mr. Rossi presided. The purpose of this meeting was to conduct a critique on the activities of Civil Defense in the recent tornado disaster. Geo. N. Poirier and I attended this meeting which was very instructive.

On Nov. 13, Gerald Shaughnessy and I attended the Communications meeting for Reg. III Sector IV held at Mr. Sherman's residence in Milford where frequency and communication matters were reviewed. Sector IV frequency is 28-640.

The Board met and organized on March 7, 1953. Gladys G. Crockett was elected Chairman of the Board and Atty. Henry C. Walker Town Counsel, the other two members of the Board were Daniel H. Bates and Ernest B. Porter.

During the year the Board was confronted with many matters of interest and importance to the townspeople. Before decisions were made, serious thought was given these problems having always in mind the welfare of the town and its citizens.

The Town Dump, voted to a new location by the Townspeople, because of serious objections at the old location, may not be entirely suitable. However it is an improvement over the old situation. It may well be that a further change may become necessary when a more desirable location is located.

The Town cooperated with area towns during the Civil Defense Alert on May 14. The Town Ambulance was loaned to the Town of Mendon as part of the Alert program.

The reconstruction of route 140 or Main Street through the town has caused many problems, including the change in our Town Commons. These problems have been seriously considered to the interest of all.

This Board has held conferences with the Water Board and other departments, always with the thought of the people as those most concerned.

The installation of Street Lights at various locations has offered increased protection. Street lighting is one of the best services that a community can give its citizens.

The Board recognizes the need of repairs to the interior of the Town Hall Building and express the hope that the condition may be changed during the coming year.

We have enjoyed serving our Town and our Citizens. We thank all department heads, officials and townspeople for the cooperation and courtesy extended to us during the past year. We are grateful.

Sir:

In accordance with your instructions, I have made an audit of the books and accounts of the town of Upton for the period from December 7, 1951, the date of the previous audit, to February 17, 1953; and, in addition, have installed a system of accounts as petitioned for by

vote of the town in accordance with the provisions of Chapter 44, General Laws, the following report being submitted thereon:

The records of the financial transactions of the several departments receiving or disbursing money for the town or committing bills for collection were examined, checked, and verified by comparison with reports and records in the office of the auditor and the treasurer.

The appropriation accounts, as kept by the town treasurer, were checked with the town clerk's records of town meeting proceedings, and the recorded transfers from the reserve fund were verified by comparison with the records of the finance committee.

General ledger accounts were compiled, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on December 31, 1952.

The books and accounts of the town treasurer were examined and checked. The cash book was footed and the recorded receipts were analyzed and checked with the records of the several departments collecting money for the town and with other sources from which money was paid into the town treasury, while the payments were checked with the selectmen's orders authorizing the treasurer to disburse town funds.

The cash balance on February 17, 1953 was verified by reconciliation of the bank balance with a statement furnished by the bank of deposit, by examination of a savings bank book, and by actual count of the cash in the office.

The records of employees' payroll deductions on account of federal taxes and the county retirement system were examined and checked. The payments to a federal depository and to the county treasurer were checked with the vouchers on file.

The reported payments on account of maturing debt and interest were compared with the amounts falling due and with the cancelled securities and coupons on file.

The savings bank books and securities representing the investment of the trust and investment funds in the custody of the town treasurer and the trustees were examined and listed, the income being proved and the withdrawals being verified.

The treasurer's records of tax titles held by the town were examined and checked. The amounts added to records, and the tax titles on hand were listed, proved, and checked with the records in the Registry of Deeds.

The books and accounts of the tax collector were examined and checked. The tax and excise accounts outstanding at the time of the previous examination, as well as all subsequent commitments, were audited and proved. The collections, as recorded on the cash books, were compared with the posting to the commitment books, the payments to the treasurer were compared with the treasurer's records, the abatements were checked with the assessors' records of abatements granted, and the outstanding accounts were listed and proved. The collector's cash balance on February 17, 1953 was verified by actual count of the cash in the office.

The outstanding accounts were further verified by mailing notices to a number of persons whose names

appeared on the books as owing money to the town, and from the replies received it appears that the accounts, as listed, are correct.

It is again urged that prompt action be taken by the collector to obtain settlement of all past due tax levies.

The assessors' records of abatements granted were reconciled with the collector's books. The assessors' warrants for the commitment of taxes and motor vehicle and trailer excise were examined and checked with the detailed lists.

The records of the selectmen were examined for licenses and permits issued and the payments to the treasurer were verified.

The books and accounts in the office of the town clerk were examined and checked. The records of licenses issued were checked with the cash book record of receipts from this source, the payments to the Division of Fisheries and Game and to the town treasurer as well as the cash on hand being verified.

The surety bonds of the officials required by law to furnish them were examined and found to be in proper form.

In addition to the departments mentioned, the books and accounts of the sealer of weights and measures and of the police, fire, health, highway, public welfare, veterans' services, school, library, and cemetery departments were examined and checked, the payments to the treasurer were compared with the treasurer's cash book, and the cash on hand was verified.

There are appended to this report, in addition to the balance sheet, tables showing reconciliations of the several cash accounts, summaries of the tax, motor vehicle and trailer excise, and departmental accounts, together with tables showing the condition and transactions of the trust and investment funds.

The books and accounts under the new system of accounts were opened as of January 1, 1953, and all transactions to March 31, 1953 were recorded therein.

A list of the books and forms provided for the town, together with a brief description of their use and certain general instructions relative to the keeping of the accounts, follows:

- Journal for town accountant
- Cash book for town accountant
- Ledger for town accountant
- Classification book for town accountant
- Cash book for treasurer
- Check register for treasurer
- Schedule of department bills payable
- Treasury warrants
- Debt record
- Schedule of collector's payments to treasurer
- Schedule of departmental payments to treasurer
- Schedule of treasurer's receipts
- Schedule of tax abatements allowed
- Schedule of motor vehicle excise abatements
- Voucher folder
- General department payrolls
- School department payrolls
- Monthly abatements
- Water cash book
- Water commitment book

All of these books and forms are arranged so as to simplify the reporting and making possible a proper check on the accounting of public moneys, also to insure a classification of both receipts and payments. All moneys received from every source and paid to the treasurer are also reported to the town accountant, in whose book will be recorded all cash transactions in detail which will furnish an absolute check on the total.

Journal.—This is a bound book of the ordinary two-column stock type. It forms, together with the cash book, the medium from which all entries in the general ledger are posted, as it is of vital importance that no entry shall be originated in the general ledger.

The journal is used for keeping a record of the debiting and crediting of items in the ledger, such as opening entries, budget appropriation entries, the entering of tax commitments, the abatement of taxes, accounts receivable, and all entries which are not strictly cash book transactions.

It is important that all journal entries state clearly the ledger accounts which are to be debited and credited; also that a full explanation of the entry be made, in order that the transaction may be fully understood by anyone examining the accounts.

Cash Book (for Town Accountant).—This is a loose-leaf book in which should be entered all transactions involving the receipt or the disbursement of cash, in order that the total transaction for a given period may be shown at a glance.

All moneys received from every source will be reported to the town accountant; therefore, in the latter's

cash book will be recorded cash transactions which are similar to those of the treasurer except in detail, and which will furnish an absolute check on the total.

Ledger.—This is of the loose-leaf type; when the several sheets are properly arranged and placed in the binder provided for the purpose, they form the general ledger, in which are recorded in controlling accounts all of the financial transactions of the town.

The accounts in the general ledger are separated and grouped in sections, as follows:

- First, Assets and liabilities
- Second, Revenue accounts
- Third, Appropriation accounts
- Fourth, Funded or fixed debt
- Fifth, Trust funds

From the ledger, information relative to the condition of the several appropriations may be obtained readily and the administrative officers may keep constantly informed of the amounts expended; also of the amounts available for the balance of the year. This information is very necessary in view of the statute which expressly forbids the incurring of liabilities in excess of the appropriations made for the use of the several departments. Unless the work is well planned, it will be found that the appropriations will be exhausted before the end of the year, with much needed work still to be done.

Classification Book.—This book consists of loose-leaf forms with printed headings covering the chief sources from which revenue is received and objects for which money is expended, with blank spaces which allow for additional headings to cover important items that may

seem desirable. These sheets are arranged in functional order and placed in a binder provided for the purpose, thus forming the principal source of detailed information regarding the receipts and disbursements of the town. They are arranged in a classified form that is generally accepted and adopted by accountants and students of municipal affairs. Provision is made for the recording of the date of the receipt, from whom received, and the source.

On the payment side will be shown the date of the bill, to whom paid, and the purpose of object of payment.

From this book definite information can be readily obtained of every cash transaction of the town, but its chief object is to furnish classification in a scientific manner, regardless of the method of making appropriations.

This book is also designed to bring the costs of each particular function or service together, so that by knowing the costs and intelligently comparing them with the service given, the taxpayer may judge of the efficiency or inefficiency of the administrative officers.

Cash Book (for Treasurer).—This is a bound book especially designed for the recording of all of the cash receipts and disbursements of the treasury department in one book.

Check Register (for Treasurer).—This book consists of loose-leaf forms which, placed in the binder provided for the purpose, form the book in which all the transactions with the banks are recorded. It will show at a glance the condition of the accounts in any of the depositories of the town.

Debt Record.—This book consists of loose-leaf forms which, placed in the binder provided, form the book in which all serial loans are recorded. It will readily show the requirements for debt and interest for each loan to maturity.

Schedule of Bills Payable.—On these sheets each department should list all bills approved for payment, and should forward them, accompanied by the original bills, to the town accountant. From these the treasury warrants are prepared.

Treasury Warrants.—These are for listing the bills of the several departments. Warrants are submitted to the selectmen, together with the bills, for their approval, the bills first having been checked by the town accountant and compared with the several appropriation accounts to which they are chargeable. The selectmen having signed the warrant, it is passed to the treasurer as his authority for payment.

Under the statute, the selectmen are required to approve bills before they are paid by the treasurer, and by using the treasury warrant they can give greater attention to the bills and appropriation accounts without consuming additional time.

Schedule of Collector's Payments to Treasurer.—These are especially designed forms for the reporting to the town accountant of payments made to the treasurer by the collector. From these reports the town accountant is enabled to classify properly the collector's receipts and verify the receipts reported by the treasurer.

Schedule of Departmental Payments to Treasurer.—This form is for the use of departments, except those for

which special forms are prepared, for reporting payments to the treasurer.

Schedule of Treasurer's Receipts.—The treasurer will use these forms in reporting the cash receipts to the town accountant. They form the basis of the debit entries in the town accountant's cash book, and, together with the schedules of payments to the treasurer, serve as an automatic check on the cash account, furnishing the town accountant with the necessary information for keeping his accounts up to date at all times, and also enabling statements to be drawn off showing actual cash transactions. By the use of printed forms for the reporting of all items involving cash, but little time is required for reporting the same.

Schedule of Tax Abatements Allowed.—This form is for the use of the assessors in reporting abatements to the town accountant so that he may credit the collector with these items in addition to his cash payments to the treasurer. On the town accountant's book, the collector is charged with the commitment and credited with collections paid the treasurer; if to the collections are added abatements allowed, the town accountant's ledger will show in his collector's account the exact amount of outstanding taxes.

Schedule of Motor Vehicle Excise Abatements.—This form is for the use of the assessors in reporting to the town accountant the abatements granted on account of motor vehicle excise.

Voucher Folder.—This form is for the use of the town accountant and is designed for the purpose of securing uniformity in the filing of bills.

General Department Payrolls.—These are to be used by all departments, except the school department, in making up their weekly or monthly payrolls, and are designed for the purpose of securing uniformity in the payrolls of all departments.

School Department Payrolls.—These are especially designed for the use of the school department, provisions being made for showing the gross amount of salary due each teacher or employee, the amount of deduction on account of the retirement fund, the net amount received by each person, and the total amount to be sent to the treasurer of the retirement fund.

Monthly Statements.—These forms are used by the town accountant in notifying each department of the warrants drawn against its appropriation and the balance subject to draft.

Revenue.—Upon receipt of notice from the town clerk of appropriations voted by the town to be raised by taxation, a journal entry should be made debiting revenue and crediting the proper appropriation accounts. When the warrant for poll and property taxes is delivered to the collector, this account should be credited and taxes debited. Revenue should also be debited with the amount of the state taxes, county taxes, and overlay raised, and the respective accounts credited.

At the close of the year, a journal entry should be made debiting all unexpended appropriation accounts (the object for which the appropriation was made having been completed) and crediting revenue. The estimated receipts account should also be closed out into the revenue account at the close of the year, and the revenue account closed into the excess and deficiency account.

Estimated Receipts.—The amount of estimated receipts deducted by the assessors in determining the amount to be raised by taxation should be debited to the estimated receipts account and the revenue account credited; as cash is received, estimated receipts should be credited and cash debited.

Taxes (Poll and Property).—Upon the delivery of the assessors' warrant for the collection of taxes, a journal entry should be made debiting taxes with the total amount of the commitment and crediting revenue.

As money is paid into the town treasury, cash should be debited and the tax account credited. When poll or property tax abatements are granted by the assessors, a journal entry should be made crediting taxes and debiting overlay.

Commonwealth of Massachusetts, Veterans' Services.—This account represents the amount due from the Commonwealth for aid to veterans disbursed during the previous year. Upon receipt of money from the State, cash should be debited and Veterans' Services credited. At the close of the year, a journal entry should be made debiting Veterans' Services due from the Commonwealth and crediting the departmental revenue with the amount of veterans' services disbursed during the year.

Public Welfare Department Accounts Receivable.—When bills are sent to the State, cities and town, or individuals, for aid rendered persons not having settlement in the town, a journal entry should be made debiting the public welfare department accounts receivable and crediting departmental revenue with the amount of the charge; as cash is received, the accounts receivable account should be credited and cash debited.

The same procedure should be followed in the case of accounts receivable of all departments rendering bills for amounts due the town.

Overlay.—Whenever poll or property tax abatements are granted by the assessors, a journal entry should be made debiting overlay and crediting taxes for the amount of the abatements. Any balance in the overlay account in excess of the amount of the warrant remaining to be collected or abated should, by journal entry, be transferred to the overlay reserve fund.

Overlay Reserve Fund (Overlay Surplus).—This account represents the surplus or difference between the overlay and the abatements granted by the assessors, and should be reserved for extraordinary or unforeseen expenses, as required by Section 25, Chapter 59, of the General Laws.

Revenue Loans.—Whenever loans are issued in anticipation of revenue, the cash account should be debited and the revenue loan accounts credited; when the loan is paid, a warrant should be drawn, revenue loan account debited, and cash credited.

Departmental Revenue (Not Available Until Collected).—This account represents revenue of the several departments on account of charges for services rendered or materials furnished. At the end of each month the amount of cash received on account of departmental charges should be credited by journal entry to the estimated receipts account and departmental revenue should be debited.

Net Funded Debt.—When debt is incurred by the issue of bonds or notes (for other than temporary loans),

a journal entry should be made debiting not funded debt and crediting the specific loan account. When the bonds are paid, the specific loan account should be debited and net funded debt credited.

Trust and Investment Funds.—When money is received, the income of which is to be used for some specific purpose, cash should be debited and the special fund account credited. A warrant should be drawn authorizing the treasurer to deposit the amount in the savings bank, cash should be credited and trust funds (cash and securities) debited.

As income is withdrawn from the bank, cash should be debited and the specific purpose for which the fund was created (such as library, cemetery, etc.,) credited. At the end of the year, the income in excess of the withdrawals should be entered on the books by debiting trust funds (cash and securities), and crediting the specific fund account.

Cooperation was received from all town officials during the progress of the audit and the installation of the system, for which, on behalf of my assistants and for myself, I wish to express appreciation.

Librarian's Report

To the Trustees of the Upton Library:

The librarian respectfully submits the annual report with library statistics, list of periodicals, and the catalog of new books.

Books have been added to the Dr. Carpenter alcove as required and purchased from the George H. Schultz fund.

Gifts of magazines and books have been received from Mrs. Eleanor Merrill, Mrs. Henry Laberge, Mrs. Edith Hill, Mr. Chester Walker, Mr. David Colcord, the Upton Woman's Club, Kiwanis Club, Ford Co. and Stanford University.

Mrs. Helen Bentley and Mrs. Arthur Morrison have sent beautiful bouquets from their gardens.

I thank the trustees for their generous support and for the assistance of Mrs. Eleanor Merrill in November and December.

During the year we have had some very interesting exhibits. Kenneth Wood, a pupil at the Memorial School brought in an excellent collection of bird's nests. Mrs. Wood borrowed bird specimens from the Natural History Museum in Worcester and rented bird records from the Audubon Society which were enjoyed by the children.

Coronation Week, Mrs. Violet Bailey loaned the library an exhibit of very attractive Coronation souvenirs which she received from relatives in England.

In July and August, a Story Hour was held for the younger children. In 1948 when this program was started, the largest attendance was under 30; this year 54 children were registered.

A Reading Club was also held for the older children with a registration of 22. Seven of these children read over 30 books. At the close a Pirate Party was held for the club.

Art Week was observed in November with an exhibit of local paintings by Victoria Grebenstein, and portraits by Doris Daniels Cox of Mendon.

For Book Week, there was a large display of new books, posters were given to the schools with the slogan "Reading is Fun", and book marks were given out. The library was opened every afternoon from 1 to 3 for the schools. Two years ago when this program was started 7 classes visited the library with their teachers; this year 14 teachers and classes came. Book reviews suitable to the individual grades were given by the librarian. One hour was also given for book reviews for adults. Both teachers and pupils have been most cooperative and appreciative. As a result, each year shows a steady increase in the circulation of Juvenile books which this year exceeds the other circulation. Books are used by the schools for book reports and to supplement their units.

In December, a Christmas Story Hour was held with an attendance of 44.

The facilities of the library and the space are quite inadequate for this increased interest and work. There is very little space left for the new books which are added from year to year.

I would like to quote from a letter from the trustees as follows:

"Your Board of Library Trustees wishes to bring before the townspeople the ever-increasing need for greater library facilities and new quarters. The Board intends to make a concerted effort in 1954 toward a definite plan for the acquisition of a new library".

"The need is here and now, but we wish first to lay the groundwork for such a project. We will dedicate the coming year to our proposed 'Investment In Tomorrow'".

Report of the Superintendent of Schools

TO THE SCHOOL COMMITTEE AND CITIZENS OF UPTON :

It is with pleasure that I submit this, my first annual report as Superintendent of Schools. The weeks in which I have held that position have been ones of profit and satisfaction. It is my anticipation that the association so auspiciously entered upon with the citizens of Upton will continue to be a happy one.

Let me first speak of what we have here upon which to congratulate ourselves. The school system of Upton shows evidence upon the part of those who have been in guiding positions of a disposition to provide the best in education which the town could afford. For example, the beautiful new school building so recently completed. Again, the text books, which in essence constitute a course of study, are of the best, generally speaking. The school personnel are conscientious and anxious to make full contribution to the welfare of the children.

Whatever direction education in Upton takes will be influenced by two factors—the needs of the children and the public desire for education. Much of the effort in our schools has been directed toward the physical plants. While there is need to crystalize the gains made, more attention should be directed toward the program of studies and instruction. Taking this long range view, then, let us consider what should be our objective over a period of time. First, let us remember that we must keep in mind the material with which we are working. Upton represents in

many ways the average American school system—for the majority of American school systems are small. As in larger schools, so here in Upton, we find ourselves working with children of varying aptitudes, personalities, interests, backgrounds. It is our job to accommodate our schools to all of these different conditions. Our curriculum must be broad enough, our vision wide enough, to answer the needs of each child. That responsibility to every child cannot be denied nor side-stepped; our children cannot live these years over again in some other time or place, for a second chance.

In the short time in which the office has been incumbent upon me, we have been able to accomplish the following things:

(1) Taking of initial steps to establish a cafeteria.

It seems quite evident at this time that the cafeteria to be established at the Memorial School must be designed to meet the needs of more than three hundred boys and girls. I have recommended that the cafeteria be sponsored by the Parent-Teacher Association under the general supervision of the superintendent and school committee; that a full time cafeteria supervisor be employed; and that the program be tied in with the state lunch program. The operation of such a cafeteria is a substantial enterprise. Both the initial investment, the operation and the day-to-day turnover in terms of dollars is big business, and therefore personnel must be selected with great care. A committee has been organized, consisting of two parents, two teachers, and the principal of the school, to execute the setting up of the cafeteria under the direction of the superintendent and school committee.

(2) Organization of a Parent-Teachers Organization.

I have always found such a group to be invaluable as a means of developing strong and friendly home-school-community relations. It is as important to know the home and community in which a child lives as to know him in the school situation. The school alone cannot achieve the most worthwhile aims of education, nor can it work efficiently except as parents and teachers co-ordinate their efforts and aspirations.

(3) Laying of plans to departmentalize work in the seventh and eighth grades.

We now have in Upton the conventional, traditional, eight-graded grammar school. From about 1910 on, the trend has been toward the re-grouping of grades so that grades seven and eight shall be, not a mere continuation of grades one through six, but an integrated unit in themselves and a bridge between the grammar and the senior high school. Toward that end, the following are recommended: (1) re-grouping of grades to bridge the gap between the lower and upper grades that the educational process might be one continual whole; (2) departmental teaching; (3) an enrichment of the curriculum; (4) a provision for group and individual differences, the real *raison d'être* of the junior high school; (5) courses of study and administration better to satisfy the nature and needs of early adolescent youth. This can be accomplished through the constants, the integrating factor, in the curriculum; i. e., the subjects carried by all the pupils, as English, Mathematics, Social Studies, Science, Health and Physical Education, Music and Guidance. Many educators regard this as the real work of the junior high school, the first cycle of secondary education. There is not the opportunity for a "constants and variables" type of curriculum usually found in the larger secondary school that provides for

election under guidance on the part of the pupils, and that helps solve better the problem of individual and group differences. A well-rounded Home Economics, background is denied the girls and an Industrial Arts or Shop Work background, the boys, in the present set-up. There is also no opportunity for discovering and developing interests, aptitudes, and abilities through "exploratory or trial" courses. Such a reorganization would discharge what many regard as the primary purpose of the junior high school; viz., continuation of common integrating outcome, group solidarity.

For a detailed account of the excellent work of the special departments—handwriting, music, public school health, and art, I refer you to the respective reports.

In closing let me express my appreciation for the cooperative and friendly attitude which I have found here in Upton, and extend my thanks to the school committee, the school personnel, the citizens of Upton, who have by their helpfulness made my first days as your school superintendent so gratifying.

REPORT OF THE HANDWRITING SUPERVISOR

Dear Mr. Hilyard:

I am pleased to submit the following report on the operation of the handwriting program in the Upton Schools for the school year 1952-53.

In the initial handwriting tests administered to your pupils in September 1934, 26% received a grade of "A" (Excellent); 26% received a grade of "B" (Good); and 48% were scored less than "B". In the tests administered in June 1953, 83% received a grade of "A"; 10% received a grade of "B"; and 7% scored less than "B". Handwriting certificates were awarded to 77% of your graduates.

During the school year we graded approximately 3100 formal and 9300 informal handwriting samples for your pupils. A formal test was administered monthly and a report was furnished each teacher giving a careful diagnosis of the handwriting of each pupil in the room.

We furnished the following instructional materials: monthly teachers' outlines, pupil folder outlines, room motivation certificates, handedness tests, individual handwriting certificates to pupils who qualified monthly and term envelopes, seals, etc.

My supervisors join with me in expressing our appreciation for the splendid cooperation we have received at all times. We are very pleased with the results obtained in your schools.

I hereby submit the following report as School Nurse.

The pre-school registration was held in June in which 75% of the children entering the first grade in September were registered. This was a great help in getting the information necessary for the new health cards.

Dr. McKernan has completed a thorough health examination of all pupils in grades one, four, eight and all new admissions. Defects are recorded and notices sent to parents. Defects found in previous examination were rechecked and found much improved.

Eye tests were carefully performed by the nurse. Several cases where poor sight was found, notices were sent home and all cases were immediately corrected.

The usual routine of weighing, measuring and general health inspection have been carried out in the usual manner. Home visits are made to consult with parents about health and social problems, and advise treatment for defects.

Classroom visits and consultations with Principal and teachers have been carried out throughout the year.

I regret Mr. Sturke leaving us in September, and wish him the best of luck in his new position. I am glad to have Mr. Hilyard as our Superintendent of Schools and find he is very interested in the School Health Program and will be a great help in maintaining the good health standards in our schools.

I wish to thank everyone for their splendid co-operation.
