

SPECIAL TOWN MEETING

January 5, 1971

TOWN WARRANT

Worcester, ss

To the Constable of the Town of Upton, in the County of Worcester
GREETINGS:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Tuesday Evening, the Fifth (5th) day of January, 1971, punctually, at Eight (8) o'clock P.M. for the following purposes:

Article 1. To see if the Town will vote to authorize the Selectmen to purchase land and buildings from the New England Conference of the United Methodist Church in the Town of Upton for use as a Town Library and Town Offices, and to raise and appropriate or transfer from available funds in the treasury, a sum of money for the purpose of this article, or take any action thereon.

Article 2. To see if the Town will rescind prior authorizations of borrowing for Sewerage Systems and Sewage Treatment and disposal facilities; and to see if the Town will appropriate a sum of money for the construction of Sewerage Systems and Sewage Treatment and disposal facilities, to determine whether such appropriation shall be raised by borrowing or otherwise, and to take any action relative thereto.

Article 3. To see if the Town will vote to transfer a sum of money from the Cemetery Commission General Maintenance Account to the Cemetery Commission Machinery Account, or take any action thereon.

Article 4. To see if the Town will vote to raise and appropriate a sum of money for the purpose of purchasing and equipping a new Town Ambulance, or take any action thereon.

Article 5. To see if the Town will vote to raise and appropriate a sum of money for the purchase of Radar and Portable Radio Equipment for the Police Department, or take any action thereon.

Article 6. To see if the Town will rescind its vote under Article 3 of the Special Town Meeting held October 6, 1970, and to see if the Town will raise and appropriate or transfer from available funds, or raise by borrowing or issuing its note or bond or any combination thereof, a sum of money to purchase a new 1971 Police Cruiser, or take any action thereon.

Article 7. To see if the Town will vote to amend its Town By-laws by adding the following Chapter 10, entitled "Street Numbering", or take any action thereon:

1.0 The Board of Selectmen of the Town of Upton or their appointed agent shall be responsible for assigning street numbers to each dwelling, business, or industrial building in the Town of Upton.

2.0 The numbers shall be those assigned to each structure in accordance with the street numbering survey compiled by the Board of Selectmen on file in the office of the Town Clerk.

3.0 Street numbers shall be provided for each building shown in the above survey by the owner of such structure within ninety days after approval of the By-law by the Attorney General. The numbers shall be a minimum of three inches high, made of permanent weatherproof material, and shall be placed on each structure or on a suitable support near the main entrance to the structure so as to be clearly visible from the street or roadway upon which the structure fronts.

4.0 It shall be the responsibility of each owner of property not presently covered by the above survey, to obtain a number assigned to his structure within three months after notification of such new assignment.

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting: At each of the Post Offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF SPECIAL TOWN MEETING

January 5, 1971

Moderator George W. Burnham called the meeting to order at 8 P.M. He stated more than a quorum (20 voters) present. He read the Warrant.

Mrs. Rita C. Cutler (D) and Mrs. Nancy E. Kennedy (R) were in charge of the voting list at main entrance to the hall. They reported 82 voters' names checked during the meeting.

TO PURCHASE METHODIST CHURCH PROPERTY

Article 1. Chairman of Selectmen James J. Gallagher presented a motion, seconded by Assessor of Taxes Samuel Nahra, Jr., "that action taken on Article 2 on October 6, 1970 be rescinded and that the Town vote to authorize the Selectmen to purchase land

and buildings from the New England Conference of the United Methodist Church in the Town of Upton for use as a Town Library, Town Offices and other town uses, and to raise and appropriate the sum of \$18,500 for the purpose of this article."

Jones E. Carter, chairman, reported the Finance Committee favored the article if previous vote was rescinded.

Moderator Burnham stated he would divide the motion into two sections. Result of vote to rescind action on Article 2 of October 6, 1970 Special Town Meeting declared favorable by Moderator. No dissenting voice.

Then voted: "The Town vote to authorize the Selectmen to purchase land and buildings from the New England Conference of the United Methodist Church in the Town of Upton for use as a Town Library, Town Offices and other town uses, and to raise and appropriate the sum of \$18,500 for the purpose of this article."

Standing vote with Police Officers Alfred E. Aldrich and John Kinney making the count.

Result: YES - (in favor of motion) 73: NO - 1

SEWERAGE SYSTEM

Article 2. Selectman Ernest B. Porter motioned, seconded by Town Accountant Charles H. Ferris, "that the vote passed under Article 8 of the Warrant for the May 13, 1969, Special Town Meeting and Article 5 of the Warrant for the October 6, 1970 Special Town Meeting authorizing a total borrowing of \$260,000 for the construction of sewerage systems and sewage treatment and disposal facilities are rescinded; that \$260,000 is appropriated for the construction of sewerage systems and sewage treatment and disposal facilities, that to raise this appropriation the Treasurer, with the approval of the Selectmen, is authorized to borrow \$260,000 under G.L. C - 44, S 8(15), such sum to be spent for the project in addition to any State or Federal aid received, and that the Selectmen are authorized to contract for State or Federal Aid for the project."

Jones E. Carter, chairman, stated the Finance Committee recommended favorable action on the motion.

Moderator Burnham stated he would divide the motion into two sections. Result of vote to rescind action on Article 8, May 13, 1969 and Article 5, October 6, 1970, declared unanimous by Moderator.

Then voted: That \$260,000 is appropriated for the construction of sewerage systems and sewage treatment and disposal facilities, that to raise this appropriation the Treasurer, with the approval of the Selectmen, is authorized to borrow \$260,000 under G.L. C-44, S8 (15), such sum to be spent for the project in addition to any State or Federal aid received, and that the Selectmen are authorized to contract for State or Federal aid for the project."

Standing vote with Police Officers Aldrich and Kinney making the count:

YES – (in favor) 74: NO – 0 (zero)

TRANSFER OF MONIES FROM CEMETERY GENERAL MAINTENANCE ACCOUNT TO CEMETERY MACHINE ACCOUNT

Article 3. Voted: on motion of Selectman Norman E. Walker, seconded by Selectman Ernest B. Porter and Town Accountant Charles H. Ferris, "that the sum of \$1200 be transferred from the Cemetery Commission General Maintenance Account to the Cemetery Commission Machinery Account." Moderator declared a favorable unanimous vote.

Jones E. Carter, chairman, stated the Finance Committee recommended favorable action preceding taking of the vote.

TO PURCHASE AND EQUIP NEW TOWN AMBULANCE

Article 4. Voted: on motion of Selectman Norman E. Walker, seconded by Arthur Leroy Aldrich, "that the Town vote to raise and appropriate a sum not to exceed \$16,860 toward the purchasing and equipping of a new town ambulance." Moderator declared favorable action was unanimous.

Chairman of Selectmen James J. Gallagher stated notice was received in November of a grant of \$6750 under the Federal Safety Highway Act toward purchase of a town ambulance.

During the discussion on the motion it was stated with the allowance (trade in) on the present ambulance the approximate cost to the town would be \$3250.

Before action was taken on the motion, Jonas E. Carter, Chairman, stated the Finance Committee recommended favorable action.

PURCHASE RADAR AND PORTABLE RADIO EQUIPMENT

Article 5. Voted: on motion of Chairman of Selectmen James J. Gallagher, seconded by Selectman Norman E. Walker, "that the Town vote to raise and appropriate the sum of \$2412 for the purchase of Radar and Portable Radio Equipment for use by the Police Department." Voice vote, no opposition.

NEW POLICE CRUISER

Article 6. Chairman of Selectmen, James J. Gallagher motioned, seconded by Selectmen Norman E. Walker, "the Town rescind the vote under Article 3 of the Special Town Meeting held

October 6, 1970, and vote to raise and appropriate the sum of \$2700 for the purchase of a new 1971 Police Cruiser."

Jonas E. Carter, chairman, reported favorable action by the Finance Committee.

During the discussion on the motion, it was stated the action voted in October 1970 meeting called for the present police cruiser to be traded in toward a new car. The plan now is to retain the present cruiser in addition to purchase of a new cruiser.

Moderator Burnham stated he would divide the motion into two sections. It was voted to rescind action on Article 3 of the October, 1970 meeting on a favorable voice vote declared by the Moderator.

Then "Voted: to raise and appropriate the sum of \$2700 for the purchase of a new 1971 Police Cruiser." Favorable action declared by Moderator with a few dissenting voices.

STREET NUMBERING

Article 7. Voted: on motion of Selectman Ernest B. Porter, seconded by Selectman Norman E. Walker, "that the Town vote to amend the Town By-laws by adding the following Chapter 10, entitled "STREET NUMBERING".

"1.0 The Board of Selectmen of the Town of Upton or their appointed agent shall be responsible for assigning street numbers to each dwelling, business, or industrial building in the Town of Upton.

"2.0 The numbers shall be those assigned to each structure in accordance with the street numbering survey compiled by the Board of Selectmen on file in the office of the Town Clerk.

"3.0 Street numbers shall be provided for each building shown in the above survey by the owner of such structure within ninety days after approval of this By-law by the Attorney General. The numbers shall be a minimum of three inches high, made of a permanent weather-proof material, and shall be placed on each structure or on a suitable support near the main entrance to the structure so as to be clearly visible from the street or roadway upon which the structure fronts.

"4.0 It shall be the responsibility of such owner of property not presently covered by the above survey, to obtain a number assigned to his structure within three months after notification of such new assignment."

Jonas E. Carter, chairman, stated Finance Committee recommended favorable action on motion.

During discussion on motion, Selectman Porter complimented workers of the street numbering survey compiled for the Selectmen.

Standing vote count by Officers Aldrich and Kinney:

YES — (in favor) 81: NO — 0 (zero)

On motion of Assessor of Taxes Samuel Nahra, Jr., duly seconded, a standing vote was extended to retiring Town Clerk George G. Newton who served in the office more than 36 years.

On motion of Selectman Ernest B. Porter, duly seconded, it was voted to dissolve the Warrant.

WARRANT FOR ANNUAL TOWN MEETING

March 1, and 6, 1971

Worcester, ss

To the Constable of the Town of Upton, in the County of Worcester

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are directed to notify the inhabitants of the Town of Upton, qualified to vote in Elections and in Town Affairs, to meet at the Town Hall, in said Upton, on Monday the First day of March 1971, punctually at Seven (7) o'clock A.M. for the following purposes:

Article 1. To choose necessary officers for the ensuing year. All to be voted for upon one ballot. The polls will be closed at eight (8) o'clock on the day of said meeting. The remaining articles in the Warrant will be acted on at an adjourned meeting in Town Hall. Saturday, March 6, 1971 at two (2) o'clock P.M.

Article 2. To hear reports of all Town Officers and appointed Committees, or take any action thereon.

Article 3. To see if the Town will fix the salaries and compensation of all officers of the Town as provided by Section 108, General Laws as amended, and raise and appropriate such sums as may be necessary to defray expenses of Town Departments for the ensuing year, or take any action thereon.

Article 4. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of revenue of the financial year beginning on January 1, 1972 and to issue a note or notes therefor payable within a year and to renew any note or notes that may be

given for a period of less than one year in accordance with the General Laws, Chapter 44, Section 17, or take any action thereon.

Article 5. To see if the Town will vote to raise and appropriate a sum of money under provisions of Chapter III, Section 85 of the General Laws, as an estimated amount for the Town's assessment for the care and treatment of persons suffering from tuberculosis and for the care, maintenance, and repair of the Worcester County Sanitorium, or take any action thereon.

Article 6. To see if the Town will vote to raise and appropriate a sum of money in accordance with the provisions of Chapter 32, Section 22, General Laws, for pension fund, expense fund, military service fund and workmen's compensation fund of the Worcester County Retirement System, or take any action thereon.

Article 7. To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money received from the sale of lots and graves during the year 1970, in accordance with General Laws, Chapter 114, Section 15, or take any action thereon.

Article 8. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury a sum of money from Chapter 81 Highways, or take any action thereon.

Article 9. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury a sum of money from Chapter 90 Highway Maintenance, or take any action thereon.

Article 10. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury a sum of money from Chapter 90 Highway Construction, work on East St., Fisk Road and Glen View Street, or take any action thereon.

Article 11. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury a sum of money for a sidewalk on the westerly side of School Street from Main Street, Route 140, to Warren Street a distance of approximately 1500 ft., or take any action thereon.

Article 12. To see if the Town will vote to raise and appropriate or transfer from available funds in the Treasury a sum of money to be expended on Shore Drive for oiling and grading, or take any action thereon.

Article 13. To see if the Town will vote to raise and appropriate or transfer from available funds in the Treasury a sum of money to pay unpaid bills of the previous year, in accordance with General Laws, Chapter 44, Section 64 as amended, or take any action thereon.

Article 14. To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to reimburse the Tree Warden for supervisory work done during the year 1970, or take any action thereon.

Article 15. To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to the conservation fund set up under Article 24 of the 1966 Annual Town Meeting, or take any action thereon.

Article 16. To see if the Town will vote to raise and appropriate to transfer from available funds in the treasury a sum of money to purchase twenty-eight (28) home unit receivers to be used by the fire department, or take any action thereon.

Article 17. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury, a sum of money to enlarge the tennis court at Leland Field, or take any action thereon.

Article 18. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury, a sum of money for Assessor's maps as the first phase of revaluation, or take any action thereon.

Article 19. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury, a sum of money for the street light account for the purpose of installing street lights, or take any action thereon.

Article 20. To see if the Town will vote to authorize the Board of Selectmen to convey certain parcel of property on the southerly side of the County Road running from Upton to Milford to William D. Allen, et ux, purchaser to pay all back taxes, land court costs, and costs of conveyance, or take any action thereon.

Article 21. To see if the Town will vote to request the great and General Court of the Commonwealth of Massachusetts to enact

legislation providing for life tenure to Rodney B. Marchand, incumbent of the office of Chief of Police in the Town of Upton, tenure to office to be controlled and governed by the provisions of the General Laws of the Commonwealth of Massachusetts, Section forty-three of Chapter thirty-one, or take any action thereon.

Article 22. To see if the Town will vote to have the annual salaries of all the employees of the Town (including all of those employees in the Regional School District with Mendon) published in the annual Town Report. Said publication to list the individual with his or her annual salary appearing beside his or her name, or take any action thereon.

Article 23. To see if the Town will vote to instruct the Moderator to appoint a dump site committee of five members: one from the Board of Selectmen; one from the Board of Health; one from the Finance Committee; and two registered voters, or take any action thereon.

Article 24. To see if the Town will vote to amend the Town of Upton By-laws by adding Chapter 11 to read: A committee to be known as the Capital Budget Committee shall be established, composed of one member of the Town Finance Committee appointed by and from it, one member of the Planning Board appointed by and from it, and four additional members to be appointed by the Moderator. The members from the Finance Committee and the Planning Board shall be appointed for one year terms. The other members shall be appointed for four year terms such that one will expire each year. Vacancies shall be filled for the unexpired terms in the manner of the original appointments. The committee shall annually prepare a Capital Budget program for use by the Finance Committee, the voters, other Town Boards and officials in their deliberations. The Committee shall publish such a report or a summary thereof in a suitable manner and deposit the original with the Town Clerk, or take any action thereon.

Article 25. To see if the Town will vote to take a sum of money from available unappropriated funds in the Town Treasury to reduce the tax rate for the year 1971, or take any action thereon.

Article 26. To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury a sum of money to the stabilization fund, or take any action thereon.

Article 27. To see if the Town will vote to raise and appropriate or transfer from available funds in the Treasury, a sum of money to the Finance Committee Reserve Account, said amount to be expended in accordance with Chapter 59, Section 25 of the General Laws, or take any action thereon.

Article 28. To see if the Town will vote to amend the Zoning By-law of the Town of Upton, by striking the reference to Section II on Page two (2) of said By-law, and substituting therefor, Section III, or take any action thereon.

Article 29. To see if the Town will vote to amend Section XV of the Zoning By-law, entitled Definitions, by adding and defining the following:

I Sign: Any words, lettering, parts of letters, figures, numerals, phrases, sentences, emblems, devices, designs, trade names, or trademarks, whether stationary or portable, by which anything is made known, such as are used to designate or locate an individual, a firm, an association, a corporation, a profession, a business, or a commodity or product, which are visible from a public or private street or right-of-way and used to attract attention.

J Home Occupation: An endeavor which is carried on for profit in a minor part of a dwelling by an occupant in residence which is customary in residential areas and which does not change the character of such areas. The professional office definition is preferred, but this may be too rigid for many of the activities in a community like Upton.

K Frontage: The linear extent of a lot measured along the street right-of-way from the intersection of one side lot line to the intersection of the other side lot line of the same lot.

L Hotel, Inn, Motel, Tourist Home or Lodging House: A building, or portion thereof, or a group of buildings on a single lot, intended to be used for the temporary occupancy of three (3) or more persons who are lodged, with or without meals, and in which major provision for cooking may be made in a central kitchen but may not be in the individual rooms or suites.

M Rooming or Boarding House: A building or premises, other than a hotel, inn, motel, tourist house or lodging house, where rooms are let and where meals may be regularly served by prearrangement for compensation; not open to transient guests: in contrast to hotels, restaurants, and tourist homes, open to transients.

N Town House: A single family dwelling attached by a party wall to another single-family dwelling, in such a manner that such dwelling has a floor at ground level and front and rear access to the outside of

the ground level.

O (1) *Garden Apartment*: A single family dwelling of one (1) or more rooms on one (1) floor (but not necessarily having an entrance or exit on the ground level) of a garden apartment building.

(2) *Garden Apartment Building*: A structure of more than one (1) story but not more than three (3) stories containing garden apartment dwellings grouped around a central stairwell.

Article 30. To see if the Town will vote to amend Section X, entitled Enforcements, by striking the present Sub-Section E in its entirety and substituting the following Sub-Section E: "Any person who violates any provision of this By-law shall, upon written notice by the Building Inspector of such violation to the owner or to his duly authorized agent and to the occupant, if any, of the premises in violation, forfeit a sum not to exceed \$50.00 for each offense. Such forfeiture shall be recovered as provided by law and shall enure to the Town. Each day that such violation continues shall constitute a separate offense.", or take any action thereon.

Article 31. To see if the Town will vote to amend the Zoning By-law by adding the following to Section III. B, 11: "h. Townhouses and garden apartments within a Residence A or B District provided that there be the equivalent of fifteen thousand (15,000) square feet of lot area per dwelling unit in Residence A and an equivalent of twenty-five thousand (25,000) square feet of lot area per dwelling unit in Residence B and provided that there are no more than eight (8) dwelling units in any one townhouse building and no more than twelve (12) dwelling units in any garden apartment building and subject to the following restrictions:

1. Each dwelling unit shall have two exposures.
2. Each dwelling unit shall have two separate exits.
3. There shall be one off-street parking space of two-hundred fifty (250) square feet per dwelling unit plus one off-street parking space per bedroom over and above that area needed for access roadways and maneuvering to a maximum of three (3) spaces per unit. No more than fifty (50) spaces may be allowed in any one parking lot, each of which shall be adequately screened from view from exterior streets by appropriate landscaping. No parking spaces shall be located within thirty feet (30') of that part of a building containing windows of habitable rooms at the basement or first story level, unless such rooms are protected from headlight glare by at least a four (4), but no more than five (5) foot high densely planted landscaped strip or fence placed at the periphery of the

parking area. Such parking spaces which are screened as above mentioned may be located up to, but not within, ten (10) feet of that part of a building containing habitable rooms at the basement or first story level.

4. Each dwelling unit shall be connected to Town water in Residence A, or supplied by a water source as approved by the Town Board of Health in Residence B.

5. In cases of seventy-five (75) dwelling units or more each dwelling shall be connected to a packaged on-site sewage treatment facility as approved by the Town Board of Health and the State Department of Health. Such treatment facility shall be constructed concomitantly with the dwelling units and shall be fully operable before the occupancy of any of the dwelling units.

In the case of a single owner of all of the dwelling units, such owner shall be responsible for the maintenance of the treatment plant in a manner prescribed by the State Department of Health. In the case of more than one owner, each owner shall, as a condition of purchase, be required to join a homeowner's association for the purpose of maintaining the treatment plant in a manner prescribed by the State Department of Health, and each owner shall be required to pay a periodic assessment to the association for the maintenance of said sewage treatment plant. The organization of such homeowner's association shall be on file with the Town Clerk along with an annual report including the names and addresses of officers, to be submitted to the Town Clerk by February 15 of each year.

6. There shall be adjacent to the exterior walls of each residential building, except at entrances, at least a three foot (3') wide area of landscaping.

7. There shall be eight thousand (8,000) square feet of usable common open space per dwelling unit. Usable common open space shall mean areas left substantially in a natural state or improved by landscaping and primarily designed and intended for the active and passive recreation of the occupants of the dwellings. Usable common open space shall not include street right-of-ways, open parking, or service areas, driveways, easements for above-ground utilities, laundry drying areas, required front yards, landscaped areas around the buildings or any other land deemed unsuitable by the Planning Board for reasons of excessive slope or poor drainage.

In case of rental property, the Owner shall assume the responsibility for maintaining the open space.

In cases of the sale of individual units, there shall be included in the deed a requirement obligating the purchasers to participate in a non-profit homeowner's association and to support the maintenance of the common open space accessible and available for the

purchasers only, by paying assessments to the association. This association may be one and the same as that referred to in subsection (5) above.

In cases of public open space dedicated in fee to the Town, such open space shall be maintained as a public park, accessible to the public. This shall not preclude the Town from refusing to accept such land without a favorable report from the Planning Board.

8. There shall be a satisfactory design and location of collection points for the disposal of garbage and trash, adequately screened for reasons of health and safety, as determined by the Planning Board and the Board of Health.

9. All existing and proposed utilities shall be installed underground at the time of initial construction.

10. A site plan prepared in accordance with the provisions of Section V-D has been submitted and approved.

11. If there is more than one (1) such structure on a lot of record, there shall be at least forty feet (40') between each structure." (or take any action thereon.)

Article 32. To see if the Town will vote to amend the Zoning By-law by striking the present sub-section D 1 (a) of Section III entitled Use Regulations, and substituting therefor the following sub-section D 1 (a):

"Any use permitted and regulated by Section III B (2 through 11) inclusive." (or take any action thereon.)

Article 33. To see if the Town will vote to amend the Zoning By-law by striking the present sub-section C 1 (a) of Section III entitled use regulations, and substituting therefor the following sub-section C 1 (a):

"Those uses permitted and regulated by Section III B (1 through 10) inclusive", (or take any action thereon.)

Article 34. To see if the Town will vote to amend Section V of the Zoning By-law, entitled Special Provision in General Business, Commercial and Industrial Districts, by adding the following paragraph F, entitled Performance Standards pertaining to all uses:

1. Building construction: All buildings shall be constructed as prescribed by the Building Code of the Town of Upton.* (*when adopted)

2. Odor, dust and smoke: No such offensive emissions shall be discernible beyond the property line or, in the case of an industrial park development or of multiple use of the property, beyond one

hundred feet of the building generating the emission, except that in no case shall the discharge from any source exceed the following limits:

- a. Smoke measured at the point of discharge into the air shall not exceed a density of No. 1 on the Ringelman Smoke Chart, as published by the U. S. Bureau of Mines, except that a smoke of a density not darker than No. 2 on the Ringelman Chart may be emitted for not more than three minutes in any one hour.
- b. Lime dust, as CaO, measured at the property line of any lot on which the activity creates such dust, shall not exceed ten micrograms per cubic meter of air.
- c. Total particulate matter measured at all stacks or other points of emission to the air shall not exceed 30 grams per hour per acre of land included in the lot.
- d. Odors shall not exceed the smallest values given in Table III (Odor Thresholds) in Chapter 5 of the "Air Pollution Manual," Manufacturing Chemists Association, Inc., Washington, D. C. 1951.
- e. All measurements of air pollution shall be by the procedures, and with equipment, approved by the Building Inspector, which procedures and equipment shall be of the latest generally recognized development and design readily available.

3. Noise: The noise generated on any lot, measured at any point beyond the property lines of the lot on which the noise source is located, shall not cause the total sound level to be more than three decibels above the natural ambient sound level except as provided below:

- a. For not more than five minutes in any one hour the noise generated may cause the total sound level to be more than three decibels but not more than ten decibels above the natural ambient sound level.
- b. For not more than 60 minutes in any seven day period the noise generated may cause the total sound level to be more than ten but not more than 30 decibels above the natural ambient sound level.
- c. Noise making devices which are maintained and are utilized strictly to serve as safety warning devices are excluded from these regulations.

Measurements shall be conducted by personnel approved by the Building Inspector using the "A" weighting on a standard commercial total sound level instrument approved by the Building Inspector. For the purpose of this By-law the natural ambient sound level shall be assumed to be 40 decibels above 0.0002 microbar during hours of daylight, and 30 decibels above 0.0002 microbar at all other times.

4. Heat, glare, vibration, and radiation: No heat, glare, or

vibration shall be discernible without instruments from the outside of any structure, and no radiation shall be discernible from the outside of the structure with or without instruments.

5. Exterior lighting: No exterior lighting, other than street lighting approved by the Selectmen, shall shine on adjacent properties or towards any street in such a manner as to create a nuisance or hazard.

6. Screening, surfacing, parking, and signs: As provided in Section V of this By-law.

7. Waste disposal and water supply: Regulations of the State Board of Health and the Upton Board of Health shall be met and shall be indicated on the site plan, when a site plan is required.

8. Open burning: No open burning is permitted, unless in an incinerator of a type approved by the Board of Selectmen. (or take any action thereon)

And you are directed to serve this Warrant, by posting attested copies thereof at each of the following places in said Town, seven days at least before the time of holding said meeting: At each of the Post Offices and on the Town House in said Town.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, before the time and place of meeting aforesaid.

PROCEEDINGS OF ANNUAL TOWN ELECTION

March 1, 1971

Warden Robert K. Sweet (R) called the meeting to order at 7:00 A.M., the hour designated in the Warrant.

PROCEEDINGS OF ADJOURNED ANNUAL TOWN MEETING

March 6, 1971

Moderator George W. Burnham called the meeting to order at 2:00 P.M. with more than a quorum of voters (20) in the hall. Mrs. Nancy Kennedy (R) and Mrs. Rita Cutler (D) checked 355 voters on voting list at the main entrance to the hall. Moderator called for a delay of five minutes for remaining voters to be seated in the hall. Meeting called to order at 2:10.

Moderator Burnham requested permission for Town Counsel, Robert J. Gallagher; Superintendent of Schools, Gordon B. Allan; Regional Public Health Nursing Advisor, Mrs. Bernardine McQueeney, R.N.; Public Health Nursing Advisor of the Mass. Department of Public Health, Miss Claire Donahue, R.N. and Walter J. Kruckvich of General Mapping, Inc. to be seated on the main floor. No objection was voiced.

Article 2. Voted unanimously that the reports of the several town officers and committees as printed in the 1970 Town Report be accepted and that the report of the Finance Committee be acted upon item by item under the various articles in the Warrant.

A report of the Salary and Wage Commission was read by Robert F. Bowen, Chairman. Other members, Mrs. Helen Nelson, Secretary; Mrs. Rita Cutler, Mr. Roy Swanson and Lawrence Atwood. Fourteen committee meetings were held through the second week of December. The information the Committee evaluated and used as a basis for recommendations was based on reports submitted from a number of towns comparable to Upton in size and type of government and also through meetings with various department heads in our town. Forty-eight positions reviewed, a total of twenty raises were recommended. Four general recommendations were made.

1. That the Town have a Personnel Board whose duties would consist of setting up job classifications and descriptions, act as an arbitrator for town employees, and to present certain segments of the Town budget to the Finance Committee.

2. That certain Town departments that now exist could be consolidated under one department head. As an example, Town Clerk, Accountant and Treasurer.

3. That the Town have an administrative clerk whose duties would be to handle functions and clerical work now handled by separate clerks.

4. Nursing - It is the recommendation of this Committee that the Finance Committee investigate further the possibility of the *Town of Upton* joining a Visiting Nursing Association from another town.

The monies expended for nursing services (nurse, clerk, office rent and expenses) by the Town of Upton are not comparable to expenses with other towns with relation to population and services rendered and received.

Jonas E. Carter, Chairman of the Finance Committee moved that the report be accepted as read.

Chairman of Selectmen, James J. Gallagher, moved for a break in procedure to honor three retiring officials. A. Kleber McCarty was escorted to the front of the hall. A plaque for untiring and unselfish work as member of the Park Commission for 17 years, and a portrait of Mr. McCarty was presented by Selectman Ernest B. Porter.

Selectman Norman E. Walker requested that Edward J. Gurry be escorted to the front of the hall. A member of the Cemetery Commission for 25 years, Mr. Gurry was presented a plaque for his outstanding work in the cemetery down through the years and a portrait of himself.

Retiring Town Clerk, George G. Newton was escorted to the front of the hall by Chester Walker. Selectman Gallagher presented him with a plaque citing his untiring efforts as Town Clerk for the past 36 years and also as clerk to the selectmen for 29 years. A portrait of Mr. Newton was also presented by Mr. Gallagher.

Article 3. Moderator Burnham stated that he would read the Finance Committee's recommendations for proposed salaries and/or compensation of certain town officers for 1971. Any voter desiring to be heard on an item may request "Hold" and it would be considered after the complete list was read. No objection voiced.

Moved that the Town raise and appropriate monies for all items as recommended which have not been requested Hold. So voted.

Voted unanimously that salary increases for all elected officials be made retroactive to January 1, 1971.

Article 4. Moved that the Town vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of revenue of the financial year beginning January 1, 1972, and to issue a note or notes therefor payable within a year and to renew any note or notes that may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17. Motion carried.

Article 5. Voted unanimously: That the Town vote to raise and appropriate the sum of \$1,131.47 under provisions of Chapter III, Section 85 of the General Laws for the Town's assessment for the care and treatment of persons suffering from Tuberculosis and for the care, maintenance, and repair of the Worcester County Sanitorium.

Article 6. Moved and seconded that the Town raise and appropriate \$2,846.57 in accordance with the provisions of Chapter 32, Section 22, General Laws, for Pension Fund, Expense Fund, Military Service Fund, and Workmen's Compensation Fund of Worcester County Retirement System. Motion carried.

Article 7. Voted unanimously: That the Town vote to transfer \$300 from the sale of Lots and Graves accounts during the year 1970 to the Oiling and Grading account, in accordance with General Laws, Chapter 114, Section 15.

Article 8. Moved that the Town vote to raise and appropriate \$4,650 to be used in conjunction with monies available from the State and County or both, for Chapter 81 Highway work. Motion carried.

Article 9. Voted unanimously: That the Town vote to raise and appropriate \$3,800 to be used in conjunction with monies available from the State and County or both, for Chapter 90 Highway Maintenance.

Article 10. Voted unanimously: That the Town vote to raise and appropriate the sum of \$5,500 to be used in conjunction with monies available from the State and County or both, for Chapter 90 Highway construction work on East Street, Fisk Road and Glen View Street.

Article 11. Moved that the Town vote to raise and appropriate the sum of \$6,000 for a sidewalk on the westerly side of School Street, from Main Street, Route 140, to Warren Street, a distance of approximately 1,500 feet. Motion carried.

Article 12. Voted unanimously that this Article be passed over.

Article 16. Moved that the Town vote to raise and appropriate the sum of \$3,516 to be used to purchase 28 Home Unit Receivers for use by the Fire Department. A standing vote was taken. In favor 222, opposed 74. Motion carried.

Article 17. Motion that the Town vote to raise and appropriate the sum of \$1,675 to enlarge the tennis court at Leland Field. Motion defeated.

Article 18. Moved that the Town raise and appropriate the sum of \$9,400, and that the Town Treasurer, with the approval of the Board of Selectmen, be authorized under the appropriate General Laws, to borrow the sum of \$9,400 for the purpose of contracting for assessor's maps, the total contract sum to be \$18,800. A 2/3 vote required, a standing count was taken. Yes, 217. No, 53. Motion defeated.

Article 19. Voted unanimously: That the Town vote to raise and appropriate the sum of \$90 for the installation of street lights on Prospect Street and at the intersection of High Street, School Street, Hopkinton Road and Westboro Street and said monies be applied to the Street Light account.

Article 20. Voted unanimously: To authorize the Board of Selectmen to convey a certain parcel of property on the southerly side of the County Road running from Upton to Milford to William D. Allen, et. ux. Purchaser to pay all back taxes, land court costs, and costs of conveyance.

Article 21. Moved that the Town vote to request the Great and General Court of the Commonwealth of Massachusetts to enact legislation providing for life tenure to Rodney B. Marchand, incumbent of the Office of Chief of Police in the Town of Upton, tenure of office to be controlled and governed by the provisions of the General Laws of the Commonwealth of Massachusetts, Section forty-three of Chapter thirty-one. Motion was seconded. Moved to have a secret ballot on the question, was seconded by seven voters. Senator Burke and his aid were given permission to be seated on the floor at this point. After much discussion the vote was taken, 310 ballots were cast, 112 in favor and 198 against. Motion was defeated.

Article 22. Voted unanimously to pass over this article.

Article 23. Motion that the Town vote to instruct the Moderator to appoint a Dump Site Committee of five members, one from the Board of Selectmen; one from the Board of Health; one from the Finance Committee; and two registered voters. Voted unanimously.

Article 24. Voted unanimously that the Town amend the Town of Upton By-laws by adding Chapter 11 to read: "A Committee to be known as the Capital Budget Committee shall be established, composed of one member of the Town Finance Committee appointed by and from it, one member of the Planning Board appointed by and from it, and four additional members to be appointed by the Moderator. The members of the Finance Committee and the Planning Board shall be appointed for one year terms. The other members shall be appointed for four year terms such that one will expire each year. Vacancies shall be filled for the unexpired terms in the manner of the original appointments. The Committee shall annually prepare a Capital Budget Program for use by the

Finance Committee, the voters, other Town Boards, and Officials in their deliberations. The Committee shall publish such report or a summary thereof in a suitable manner and deposit the original with the Town Clerk."

Article 25. I move that the Town vote to take \$15,000 from available unappropriated funds in the Town Treasury to reduce the tax rate for the year 1971. Voted unanimously.

Article 26. Voted unanimously that this article be passed over.

Article 27. Voted unanimously that the Town transfer from available funds in the Town Treasury, the sum of \$5,000 to the Finance Committee Reserve Account, said amount to be expended in accordance with Chapter 59, Section 25 of the General Laws.

It was moved, seconded and voted that all monies appropriated during this meeting, unless otherwise provided in the motion, be raised by taxation.

It was moved, seconded and voted to adjourn this meeting until the following Saturday, March 13, 1971 at 2:00 P.M. Meeting adjourned at 6:15 P.M.

Adjourned Annual Town Meeting was called to order by the Moderator at 2:05 P.M. Justice William Brewin of Marlboro, representing Town Counsel Robert Gallagher was seated on the floor.

Voted: Unanimously that Section O (1) as contained in the warrant be amended to read as follows:

O Garden Apartment: A single family dwelling of one (1) or more rooms on one floor, but to consist of not more than two (2) bedrooms, but not necessarily having an entrance or exit on the ground level of a garden apartment building.

Voted: Unanimously that Section O (2) be changed to read Section P.

Article 32. Voted: Unanimously to amend the Zoning By-law as contained in Article 32 of the Warrant.

Article 33. Voted: Unanimously to amend the Zoning By-law as contained in Article 33 of the Warrant.

Article 34. The motion was made that the Town vote to amend Section V of the Zoning By-law as read except those sections asked to be held. Motion seconded. A standing vote was taken with 51 voting in favor and 4 opposed. Motion carried. Those sections asked to be held and voted separately were:

Section 1, Building Construction – Voted: Unanimously that Section 1 shall read as follows: All buildings shall be constructed as prescribed by the Building Code in force in the Town of Upton.* (*when adopted)

Section 5, Exterior lighting – Voted: Unanimously to adopt Section 5 as worded in the Warrant.

Section 8, Open burning – Voted: Unanimously to accept Section 8 as follows: No open burning is permitted, unless in an incinerator of a type approved by the Board of Health.

Voted: Unanimously to amend the Zoning By-law as contained in Article 34 in the Warrant with the amendments as voted.

The motion was made and seconded that the Warrant be dissolved (3:30 P.M.) So Voted.

REPORT OF UPTON HISTORICAL COMMISSION

To the Board of Selectmen:

Gentlemen, we herewith submit our eighth annual report. Requests from historical data from outside sources have been numerous during the past year. Descendants of Upton families have been assisted in genealogical information and two college students, one from Worcester State and one from Assumption, were given interviews and accorded sources of information concerning "Upton During the Depression" and "Education in Upton".

We have continued our picture-framing project and several pictures were framed or repaired in 1971.

MODERATORS REPORT

As Moderator for the Town of Upton I presided at the Adjourned Annual Meeting on March 6, 1971 and the second adjourned meeting on March 13, 1971.

As directed by the voters I appointed a Dump Site study committee of five members. Robert Ramsey, a member of the Board of Health; James Gallagher, Selectman; John Craib of the Finance Committee; David Teachout of the Planning Board and George Shephard of the Conservation Commission.

Under Article 24 of the Warrant for the annual Town Meeting the Voters approved a By-law establishing a Capital Budget Committee. Under this By-law I was directed to appoint four members. The following were appointed.

Olaf Olson for Four Years, term will end in March 1975; Howard Sether for Three Years, term will end in March 1974; Kenneth Fougere for the Two Year term, to end in March of 1973; and Edward Henderson Jr. for One Year, term to end in March of 1972.

During the year Howard Sether and Kenneth Fougere resigned because of pressure of personal business. I appointed Jonas E. Carter to the remainder of the three year term and Royce E. Beatty to complete the two year term.

I also presided at the Special Meeting on November 2, 1971.

Because of a previous commitment I was unable to preside at the special meeting on December 9, 1971.

During the year 1971 your Upton Civil Defense organization, as usual, has been taking part in the monthly Races Drill Tests on the first Monday night of every month at 7:30 P.M. with the Sector 3B Communications Center. Gerald Shaughnessy and your C.D. Director have been on hand at the Upton C.D. Headquarters in the Town Hall.

There also have been Checkerboard (warning) Tests monthly and the Police Department has recorded the time and date received and by means of State Police via Radio or County Fire Net or via Radio, the time that the person responsible for activating outdoor warning is notified should be close to the time of receipt of the Checkerboard. We then mail a reply card to the Office of Emergency Preparedness, 400 Worcester Road, Framingham, Mass.

Emergencies in Upton have been taken care of. Our equipment is ready for emergency. Call Wilfred Fowler, Tel. 473-9403

Upton Fallout Shelter is located in the basement of the Memorial School.

As of January 1, 1972, we have a new Sector 3B Director Albert E. Edmonston who is located at Westboro Headquarters. Tel. 1-366-1700. Mrs. Anna DeHass is his secretary. Former 3B Director Ernest Coomb has been transferred to Sector 3C with headquarters at Gardner State Hospital.

We have purchased surplus materials and equipment from Myles Standish Warehouse in Taunton, Mass.

The Police Department, Auxiliary Police and Fire Department have been very cooperative. In November, Capt. Robert J. Prentiss organized an Official Red Cross First Aid Standard Course in which many members of the Fire and Police Departments and others took part. On December 13 at the Church Street Fire Station, 26 persons including 3 women received certificates for having successfully completed the course. Mr. Beverly Hubbard of the Worcester Red Cross Chapter was in charge. Beginning January 4 a six week advanced First Aid Course will take place.

The Greater Blackstone Valley Mental Health Association, of which Upton is a part, after years of work now is able to assist the over 18 population with crises situations and mental health needs. This Fall the Adult Valley Counseling Service opened, with a

professional staff available, at Rice House, 41 Pine Street, Whitinsville. This service is available to all residents at no cost.

The South East Task Force, this area's extension of the Comprehensive Health Planning office in Worcester, has met monthly and is in the process of making proposals and application for a future Family Health Service Center. This will be a means of improving the delivery of health care for the area towns.

Commendation is given to the School Committee and the Administrative Staff of our School Department for the foresight and implementation of a health education program. The position of Health Education Coordinator is a valuable addition to the educational needs of our children.

REPORT OF THE UPTON CAPITAL BUDGET COMMITTEE

In accordance with Chapter 11 of the Town of Upton By-laws, a Capital Budget Committee has been established consisting of one member of the Planning Board, one member of the Finance Committee and four additional members appointed by the Moderator.

Capital programming makes it possible for the Town to set up a priority of needs and to schedule improvements over a period of time in order to stabilize the tax rate.

It is the purpose of this Committee to consult the various Town Boards to find out what the Town needs and how and when

needed improvements can be financed. The Committee then makes recommendations for use by the Finance Committee, the voters, other Town Boards and Town officials. Any improvement is considered a capital project if the cost exceeds \$5,000.

Meeting regularly since July, the Capital Budget Committee has examined the work of similar committees in other towns, analyzed the degree of Upton's indebtedness and discussed with the Selectmen the Town's need for capital improvements. A Proposed Project Report has been adopted and with a letter introducing the Committee and explaining its objectives, has been sent to all Town Departments. The Committee has requested that the Departments fill out and return the Proposed Project Report indicating improvements the Departments anticipate during the next five years, the need for each improvement and the proposed method of financing.

Based on the reports of the Departments the Committee is preparing a Capital Budget Program for the Town.

We submit the following report of the activities of the Water and Sewer Department for the year of 1971:

The latter part of September we put the water line on Maple Avenue, approximately from the railroad tracks to the entrance of the new Sewer Treatment Plant, which was (1,000) one thousand feet. The contractor of the Sewage Treatment Plant put the water line from the entrance to the plant.

Late this fall we installed (12) twelve meters with outside readers that should make it easier for meter readings.

At this time we wish to thank the townspeople for their cooperation.

During the year, 73,347,800 gallons of water were pumped,

with the month of January being the highest with 7,473,200 gallons, and April being the lowest with 5,150,400 gallons.

The income is to be divided between two pupils in our High School who make the most progress during the year. Interest of \$71.51 was received this year and \$50.00 was expended.

There is deposited in the Worcester County Institution for Savings, One Thousand Dollars (\$1,000.00) known as the Dr. Carpenter Library Fund. The income is to be used for the Public Library. \$52.68 interest was received this year.

There is deposited in the Milford Savings Bank, Five Thousand Dollars (\$5,000.00) known as the Charlotte A. Batchelor Library Fund, in Trust with the Town Treasurer as Trustee. The income is to be used for the Public Library. Interest of \$263.65 was received this year.

There is deposited in the Milford Savings Bank, Five Thousand Dollars (\$5,000.00) known as the George W. Knowlton Fund. The income is subject to withdrawal by the Town Treasurer on order from the Selectmen and is to be used to help townspeople who are in distress. Interest of \$438.36 was received this year and nothing was expended. The balance of the account on December 31, 1971 was \$7,942.22.

DAY PROGRAM

A. January – June 1971

1. Enrollment

At the beginning of 1971, 80 boys were in the senior class, 86 in the junior class, 124 in the sophomore class and 155 in the freshman class, making a total of 445 boys enrolled at the Blackstone Valley Regional Vocational Technical High School.

2. Pupil Selection for the Fall of 1971

During the months of January and February all the schools in the member towns were visited by the Director of Pupil Personnel Services in order to give information to the boys in the eighth grade about courses that are offered at the Blackstone Valley Regional Vocational Technical High School. Applications were distributed and the students were requested to indicate their first, second, and third choices among the courses offered. Specially designed information forms were given to each school administrator, to be completed for each boy who planned to make application for admission to the Blackstone Valley Regional Vocational Technical High School.

At a later date, applicant groups from the various towns were brought to the school so that they could visit each of the departments and actually see the program in operation. During the day they were given a series of aptitude tests involving verbal reasoning, numerical ability, mechanical reasoning, abstract reasoning, and spatial relations. The scores on the above tests and the information sheet provided by the sending school were evaluated in order to produce a profile of each applicant's characteristics. Each

applicant's profile was recorded on a compilation sheet which served to identify the most qualified students in each town. Every effort was made to admit the best qualified boys in each town, to give them their course preference, to distribute the courses as equally as possible among the towns, and to select each boy for the course in which he appeared to have the best chance of success. This year we admitted 150 boys out of the 370 that applied for admission. That means that over 200 young men who wanted to attend this school could not due to lack of space.

3. Second Graduation

The second graduation of the Blackstone Valley Regional Vocational Technical High School was held on Sunday, June 13, 1971. 78 seniors received both their high school diplomas and their occupational certificates from the chairman of our school committee, Kelton Johnson.

In spite of the fact that this area had one of the highest unemployment rates in the entire state we were very successful in finding jobs for all of our seniors who were available for employment. Approximately 22 percent of the graduates decided to continue their education at institutions of higher learning.

B. September – December 1971

1. Enrollment

In September we started our sixth year of operation with 85 seniors, 120 juniors, 151 sophomores, and 150 freshmen for a total of 506 pupils. The number of boys from each of the towns was as follows: 46 from Bellingham, 27 from Blackstone, 16 from Douglas, 57 from Grafton, 26 from Hopedale, 15 from Mendon, 70 from Milford, 65 from Millbury, 7 from Millville, 68 from Northbridge, 30 from Sutton, 29 from Upton, and 50 from Uxbridge.

2. Exploratory Program

This year, based upon the experience of the previous years, we decided to have all freshmen spend the entire first semester in their assigned department, with the understanding that all students who were not sure that they were in the right department would be given the opportunity to explore other departments of their choice during the second semester. Less than 10% of the freshmen asked to go into the exploratory program, which clearly indicates that the vast majority of them were satisfied with their original choice.

3. Cafeteria

Our cafeteria staff continues to do an outstanding job for the students of our school. Once again our cafeteria was rated in the top ten in Massachusetts by the Massachusetts Bureau of Nutrition Education and School Food Services. The most meaningful rating is the extent of pupil participation. Our students participated to the extent of 136% while the average participation throughout the state was 67%. To paraphrase an old saying – “the proof of the rating is in the eating.”

4. Lincoln Arc Welding Foundation Awards

For the fourth successive year Blackstone Valley Tech has finished first in the entire United States in awards won by its students in the annual Lincoln Arc Welding Foundation contest.

Competing with hundreds of high schools throughout the country, 8 Valley Tech students came through with 1 National Grand Award, 3 Regional Awards, and 2 merit awards, totalling \$1200 in prize money for themselves and the school.

The Lincoln Electric Company created the James F. Lincoln Arc Welding Foundation in 1936 to encourage interest and study in arc welding. The Foundation sponsors the Arc Welding Awards annually for full-time high school, technical or vocational school students in the United States 19 years old or younger. This award program offers an opportunity to compete for \$15,000 in regional and national cash awards. These awards are made for the best written reports describing arc welded school shop projects. The entry must not be more than 25 pages in length and should contain detailed descriptions of the operations, all necessary calculations, photographs, sketches and drawings.

5. Cooperative Training Program for Seniors

In brief, this program involves on-the-job training during the week that the student would ordinarily be in his school shop. On the alternate week the boy will return to school for his academic and related work. Cooperative pupils must be paid wages during the work week at the cooperating establishment reasonably comparable to those paid to other persons doing similar work in the same company. While the students work the same hours and under the same conditions as other employees, they are legally considered as members of our student body rather than employees in the usual sense of the word.

Because of the general slow-down in business activities during this past year we did not have as many opportunities to place our seniors in the cooperative program as in the previous year. However, we were able to place over 50 percent of all the seniors who wanted to go into the program. We feel that this program has been very successful because it gave our seniors an opportunity to get on-the-job training while they were still in school and at the same time it provided the employer an opportunity to have the services of a young man who has both skill and technical knowledge. The majority of the seniors became full-time employees of the co-operating companies upon graduation.

ADULT TRAINING PROGRAMS

1. Evening Trade Extension Courses

The evening trade extension courses for adults started Monday, October 4, 1971. These classes are open to persons over 16 years of age who are not attending school and who can show evidence of trade contact with the specific training desired. The following courses were offered: Auto Body Repair, Auto Mechanics, Mill and House Carpentry, Electronics, Electrical, Machine Shop, Metal Fabrication, Plant Maintenance, Drafting, Graphic Arts, Plumbing, and Blueprint Reading. A total of 449 adults were registered and 385 were enrolled in these courses. The number of students from each of the towns was as follows: 19 from Bellingham, 16 from Blackstone, 12 from Douglas, 22 from Grafton, 6 from Hopedale, 12 from Mendon, 79 from Milford, 20 from Millbury, 4 from Millville, 75 from Northbridge, 12 from Sutton, 47 from Upton, and 45 from Uxbridge. We enrolled an additional 16 students from towns that are not members of our regional school district. The tuition for these students was paid for by their towns.

2. Automotive Machinist Program

This program was organized for unemployed young men under the provisions of the Manpower Development and Training Act. It was developed with the cooperation of an advisory committee from the Automotive Wholesalers Association of New England and it is the only program of its kind in the United States. The program operates 8 hours per day five days per week and is in session throughout the entire year.

The first section of this program started July 10, 1967 and our sixth section graduated on December 23, 1971. During the past four years we have given training to over 91 men and have helped them to become gainfully employed at no cost to the member towns, inasmuch as this program is financed entirely with federal funds.

FOLLOW-UP SURVEY OF GRADUATES

In November we sent out questionnaires to all the graduates of the class of 1971 in order to find out what they were doing approximately six months after graduation. We were amazed when we received returns for every graduate, either from the graduate himself or from his parents.

From the survey we found that 67.9% were employed, 21.8% were full time students at post secondary institutions, 7.7% were in the Armed Forces, and 2.6% were unemployed. We think that it is very important to make a follow-up study of our graduates every year in order to have accurate information which will be used to guide us in our future planning.

CONCLUSION

Midway through our sixth school year we feel that the Blackstone Valley Regional Vocational Technical High School is operating efficiently and serving the people of the area effectively in several divergent capacities, as shown in the number of students who enrolled in the regular day program and in the adult training programs:

1. 506 freshman, sophomore, junior and senior boys in the day program.
2. 385 men and women in the Evening Trade Extension program.
3. 15 young men in the Automotive Machinist program.

Thus we have offered about 906 people the opportunity to further their education and to increase their vocational skills. In addition, our school is in operation from 8:00 A.M. to 9:30 P.M. every day except Friday when we close at 4:30 P.M.

1971 has been a good year for us, and the reason lies in great measure in the cooperation between the staff, students, and the communities we serve. We have come to expect this loyalty and support, but we hope we will never take it for granted; therefore, it is fitting that each year when we report on our school's progress, we close with a sincere expression of gratitude to all who make it possible.

REPORT OF THE MENDON-UPTON REGIONAL SCHOOL DISTRICT COMMITTEE

During 1971 the Committee's attention was largely devoted to the problems of space and finance. The lack of adequate room to house and educate the junior and senior high school children has been with us for eight years. Overlapping and double sessions have been a reality for the last four and one-half years. Reiteration of the reasons would serve no useful purpose, but a reminder that the situation does exist has a place in any school committee report. The lost opportunities for our young people in the many areas touched by the school system is a small and private tragedy to each of the children.

Site acquisition is the major obstacle, and progress is painfully slow with no completion date in sight. To accelerate the program, action parallel to the site acquisition has been initiated. An Advisory Building Committee was established, and a meeting held with the State School Building Assistance Bureau to set up a planning and building schedule for a new high school. Based on this meeting the administration compiled tentative educational specifications and presented these to a joint meeting of the School and Building committees. These two areas, site acquisition and educational requirements, will continue to have the highest priority in 1972.

Finances were the second problem area that required in-depth consideration by the Committee. At a special meeting in February the 1971 budget was reduced in recognition of deteriorating economic conditions in the two towns. New contracts based on bidding and negotiations were carefully reviewed. Attempts were made to hold costs to a minimum without adversely affecting the educational level, already tenuous, due to double sessions. In the fall the 1972 budget was closely examined by the Committee at open meetings attended by Finance Committee members and citizens of the two towns. The resulting budget was then discussed in detail at a Taxpayers' Association meeting in Upton and at the annual Budget Reading on November 15. Both meetings were well attended, reflecting the concern of the citizens of the two towns. A reduction of over \$10,000. was made as a result of suggestions at these meetings. The increase was reduced to 9.5% compared to over 14% in previous less inflationary years.

On the optimistic side, the quality of education appears to be improving over the level experienced in the first years of overlapping and double sessions. The strengthening of the staff in the critical guidance and remedial areas has helped, but perhaps a greater

contribution has been the enthusiasm and efforts of many of the staff members.

The time-consuming nature of the School Board business combined with professional commitments resulted in the unexpected resignations of our able chairman, Richard Ferrucci, and Richard Howarth. We are fortunate in having Margaret Stanton and Dwight Davenport appointed as their successors.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Mendon-Upton Regional School Committee
 and the Citizens of Mendon and Upton:

A year ago it was stated in this report that the Mendon-Upton school system can point with pride to many solid accomplishments and a continuing concern for areas and issues of unresolved problems. The year 1971 has been a year highlighted generally by deep social, economic, and educational concerns. Yet, in spite of this we continue to log in our regional school district many more solid accomplishments as well as a deep commitment to working at our continuing challenges.

The top challenge, as we are all aware, is the matter of double sessions at Nipmuc Regional High School. Resolving this nagging problem means building a new high school, and building a new high school means acquiring an appropriate land site.

The land has been located and has been endorsed by our architect, Korslund, LeNormand and Quann; has been granted water and sewer rights by the Town of Upton; and has been approved for building purposes to qualify for state aid by the School Building Assistance Bureau. In Massachusetts the revised state aid formula

now provides 100 percent aid for planning (architect's fees to point of bidding), 65 percent of capital costs, and 65 percent of interest. Meetings have been held between architect and department heads, key school officials and the School Building Assistance Bureau. Department heads have visited other high schools recently constructed, they have developed preliminary educational specifications, and these specifications have been presented by Principal Frigard to two joint meetings of the School Committee and Building Committee. Early in 1971 an Advisory Building Committee was named with three members from each town — Mr. Thomas Hackenson, Mr. Herbert Pickard, and Mr. Richard Childs of Mendon; Mrs. Marjorie McLaughlin, Mr. James Gallagher, and Mr. Jerald Rice of Upton.

In the meantime, official permission of the State Department of Education must be obtained annually to operate Nipmuc Regional High School on double sessions. A condition of this approval is supplying the Commissioner of Education with satisfactory evidence that the district is making a good faith effort to acquire land, start the new school, and develop a target date for re-establishing a full school day and full school program for all grades, 7 through 12.

In a year marked by greater than usual fiscal concerns, the School Committee twice reviewed the 1971 budget before final adoption on February 1, 1971 in the amount of \$1,269,941.15. Again following the recent November hearing on the 1972 budget, the School Committee gave that document careful scrutiny before adopting a figure of \$1,390,699.00, an increase of 9.5% over 1971 and the lowest percentage increase in five years. The School Committee has voted to continue its annual policy of using available funds as a credit against the budget assessment.

Concerns of the Mendon-Upton Regional School Committee are people-oriented. Staff additions provided in the last three years to meet pupil or curriculum needs include the following:

1. Pupil personnel services department organized to co-ordinate existing programs and services, and provide the following new staff: elementary counsellor, teacher of children with learning disabilities, speech therapist, junior-high counsellor, counsellor to work with children with health problems.

2. Coordinated library program between 1969 and 1972 with library open five afternoons a week for junior high students for first time. Book acquisition program of 15 books per student in both elementary school libraries is progressing on target.

3. Additional teacher of home economics employed fall 1971, additional teacher of industrial arts to be added fall 1972 — both to

make courses in the curriculum regularly available to students who wish to elect them.

4. Continued support for the position of remedial or resource teacher as needed to work with students in grades 7 and 8.

5. Expansion of opportunities for girls in the athletic program by adding another coach to work with three JV teams.

The Mendon-Upton Regional School District continues to attract excellent teachers. More than just level of compensation is the atmosphere of mutual respect which pervades working relations between staff and School Committee.

As we go about the daily task of meeting our responsibilities, we must express a word of thanks to these fine and dedicated members of the teaching staff, to the administrators who lead and plan, and also to the many members of back-up teams who help to make it all possible: the nurses, the librarians, the counsellors, the secretaries, the cafeteria workers, the custodians — these people have combined their talents and dedication to help the 1434 boys and girls of Mendon and Upton through another school year.

REPORT OF THE HIGH SCHOOL PRINCIPAL

One of the conditions for continued approval of double-sessions for 1971-1972 by the Massachusetts Department of Education was that both morning and afternoon sessions were to be conducted for a minimum of five hours. Compliance with this directive necessitated extending the afternoon session twenty-five minutes, resulting in a dismissal time of 5:20 p.m.

In spite of double-sessions, attempts are being made continually to improve the educational offering to the pupils attending the school. Listed below are the most significant additions and changes which have been implemented during the past year:

1. The art program in the afternoon session was extended from five to ten periods per week.

2. The self-contained transitional seventh grade class for pupils who would have had difficulty adjusting to the regular seventh grade program has been eliminated. This year all seventh and eighth graders have been assigned to regular class sections and those

who need special help in basic skills leave their regular classes two or three times per week to receive assistance from a resource teacher available for that purpose.

3. A guidance counselor is available for junior high school pupils as a result of the addition to the staff of a combined counselor and system-wide health education coordinator.

4. A speech therapist is available on a limited basis to pupils in grades seven through twelve.

5. In order to make home economics courses available to a greater number of girls in the high school, the home economics room was partitioned into two rooms, and a second teacher has been added to that department.

It should be noted here that provisions have been made to add another industrial arts teacher next September in order to expand this department and thus make shop activities available to more boys and girls, many of whom have had to be denied these experiences during the past few years due to shortage of staff.

Nipmuc Regional High School has been selected to participate in an eighth grade test of basic skills conducted by the Massachusetts Department of Education. This is a testing program similar to the one administered to fourth graders last spring. This testing will have been completed by the time this report is published.

All teachers are participating in an in-service course entitled "Designing Effective Instruction," which is an in-depth study of planning instruction in terms of behavioral objectives.

Department heads and other staff members have also spent considerable time in formulating educational specifications for the proposed new high school.

In 1963 the Nipmuc Regional High School was evaluated and accredited by the New England Association of Colleges and Secondary Schools. One of the conditions of membership in this association is a re-evaluation in ten years, which means that we must be evaluated again before the end of the 1972-1973 school year. The fact that we are and shall be on double sessions in 1973 is practically an assurance that we shall lose accreditation, which, in my opinion, would be very unfortunate. We might be able to receive a waiver of a re-evaluation if we are in a building program at that time.

In closing, I wish to thank all persons and organizations who have assisted in any way during the past year in the operation of the Nipmuc Regional High School.

REPORT OF THE SUPERVISOR OF ELEMENTARY EDUCATION

A significant step was taken by the Massachusetts State Department of Education in an attempt to assess the quality of education in the state. All Fourth Graders in the state were given the California Test of Basic Skills achievement test. The Mendon-Upton fourth grade classes in most areas were average or above average in skill development. The department of education is in the process of developing goals for education and an assessment policy will be established in order to create good learning environments for all students, hopefully with more financial aid from the state.

The Mendon-Upton Regional School District received a Federal Grant of \$15,000.00 under Title I ESEA (Elementary and Secondary Education Act of 1965) to conduct a reading program for primary school pupils. Classes were held at the Henry P. Clough School in Mendon and the Memorial School in Upton. Sixteen professional people were employed including teachers, a speech therapist, and an evaluator. Our Title I experience and evaluation shows that primary school children respond favorably and with success.

An In-Service Program for our staff was offered in the Identification of Learning Problems. A professional staff from the Worcester Rehabilitation Center conducted the three hour workshop.

The most significant workshop for our staff, which began in the Fall and will end sometime in the Spring, deals with Instructional Systems Development. The entire professional staff from grade 1 through 12 is involved. The purpose of the program is to train the staff to approach education with more specificity, proper assessment, and an educational systems approach for the entire school program.

In order to diagnose and prescribe treatment for pupils with speech and hearing difficulties a full time speech therapist was employed to correct these problems, particularly on the elementary level. The program is operating smoothly and is greatly helping pupils. Also added to our Pupil Personnel Department was a health education coordinator who is responsible for developing programs that will insure a child's exposure to proper health and living procedures that are so vital for youth today. A fourth day was added to the schedule of the learning consultant. The learning consultant instructs those pupils who may or can be having serious learning problems.

Our library facilities have been steadily expanding in terms of books and audio-visual materials for the pupils and professional staff. The program is backed up by many volunteers without which the program could not be successful. The library is supported with local, federal, and Risteen funds.

The Music and Art Departments are a vital part of our total school program. Pupils have participated in concerts, art contests, and in a few instances have worked jointly to put on effective programs for the general public.

A new report card system has been introduced to our system. The card gives sub-categories of major subjects and more accurately describes where the child needs help.

Our P.T.A.'s again have been generous in supplying us with educational equipment and presenting programs for the children. We are appreciative of their efforts and continued support.

I wish to express my thanks to the school committee, superintendent, staff, and townspeople for their support to provide the best possible education for our children.
