



WARRANT FOR SPECIAL TOWN MEETING

March 14, 1983

Worcester, ss.

To either of the Constables of the Town of Upton in the County of Worcester,

Greeting:

In the name of The Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Town Hall in said Town of Upton on Monday the fourteenth day of March next, at seven thirty o'clock in the evening, then and there to act on the following articles:

ARTICLE 1. To see if the Town will vote to transfer the sum of six thousand, six hundred, seventy-eight dollars and ninety-six cents (\$6,678.96), said sum received by the Town from Hartford Insurance because of vandalism done to Memorial School, to the Mendon-Upton Regional School Department to be applied to the cost of repairs, or, to take any other action relative thereto.

ARTICLE 2. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of twenty-five hundred dollars (\$2,500.00), or any other sum, to be expended for legal services rendered by Attorney Philip M. Cronin re Thomas E. Barnicle, and re James J. Janson vs. Town of Upton, or, to take any other action relative thereto.

ARTICLE 3. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of twenty-five hundred dollars (\$2,500.00), or any other sum, for the Town Counsel's Expense Account for fiscal year '83, or, to take any other action relative thereto.

ARTICLE 4. To see if the Town will vote to approve the transfer of one thousand, nine hundred and forty three dollars (\$1,943.00) from the State Aid to Libraries to the Town Library Account, or, to take any other action relative thereto.

ARTICLE 5. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of fifteen hundred dollars (\$1,500.00) for the Insurance Account to cover increases in insurance rates for fiscal year 1983, or, to take any other action relative thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at both Post Offices and the Town Hall Building in said Town, fourteen days at least before the time of holding said meeting.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.

PROCEEDINGS OF SPECIAL TOWN MEETING

March 14, 1983

Town Clerk Martha R. Williams called a fifteen minute recess at 7:30 p.m. because a quorum was not present. The meeting was called to order by Town Clerk Williams at 7:40 p.m. with a quorum present. Aldo B. Consigli, Jr. was elected temporary moderator in the absence of Moderator George W. Burnham.

Barbara Burke and Nancy Kennedy checked forty-six voters into the hall. It was announced that Allison Jones of the Milford Daily News was the only non-voter seated in the hall.

ARTICLE 1. Voted: Unanimously that the Town transfer the sum of \$6,678.96, received by the Town from Hartford Insurance to the Mendon-Upton Regional School Department to be applied to the cost of repairs of damage caused by vandalism to Memorial School.

ARTICLE 2. Voted: That the Town appropriate from available unappropriated funds in the Treasury the sum of \$2,500.00 to be expended for legal services rendered by Attorney Philip M. Cronin.

ARTICLE 3: Voted: That the Town appropriate from available unappropriated funds in the Treasury the sum of \$2,500.00 for the Town Counsel's expense account for fiscal year 1983.

ARTICLE 4. Voted: That the Town transfer the sum of \$1,943.00 from the State Aid to Libraries Account to the Town Library. If this amount has already been appropriated for fiscal year 1983 then the funds so voted would be for fiscal 1984.

ARTICLE 5. Voted: That the Town appropriate from available unappropriated funds in the Treasury the sum of \$1,500.00 for the Insurance Account to cover increases in insurance rates for fiscal year 1983.

It was moved and seconded to dissolve this warrant and to adjourn. This meeting adjourned at 8:11 p.m.

WARRANT FOR ANNUAL TOWN MEETING

May 2, 1983

Worcester, ss.

To either of the Constables of the Town of Upton in the County of Worcester,
Greeting:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Upton Town Hall in said Upton the second day of May next, at seven o'clock in the forenoon, then and there to act on the following articles:

ARTICLE 1. To choose necessary officers for the ensuing year, all to be voted for upon one ballot. The polls will be closed at 8:00 p.m. on the day of said meeting. The remaining articles in the warrant will be acted on at an adjourned meeting in the Town Hall, Saturday, May 7, 1983, punctually at 2:00 p.m.

ARTICLE 2. To hear reports of all Town Officers and Appointed Committees, or to take any other action relative thereto.

ARTICLE 3. To see if the Town will fix the salaries and compensation of all officers of the Town as provided by Section 108, General Laws as amended, and appropriate such sums as may be necessary to defray expenses of Town Departments for the ensuing year, or, to take any other action relative thereto.

ARTICLE 4. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow in anticipation of revenue for the fiscal year beginning July 1, 1983 in accordance with the provisions of General Laws, Chapter 44, Section 4, and to issue a note or notes therefor payable within one year in accordance with General Laws, Chapter 44, Section 17, or, to take any other action relative thereto.

ARTICLE 5. To see if the Town will vote to raise and appropriate or appropriate from available funds in the Treasury the sum of \$31,772.00, or any other sum, in accordance with the provisions of Chapter 32, Section 22, General Laws, for

Pension Fund, Expense Fund, Military Service Fund, and Workmen's Compensation Fund, of Worcester County Retirement System, or, to take any other action relative thereto.

ARTICLE 6. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$300.00, or any other sum, equal to that received from the sale of lots and graves during the fiscal year beginning July 1, 1983, in accordance with General Laws, Chapter 114, Section 15, to be used for cemetery oiling and grading, or, to take any other action relative thereto.

ARTICLE 7. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,000.00, or any other sum, for the Conservation Fund set up under Article 24 of the 1966 Annual Town Meeting, or, to take any other action relative thereto.

ARTICLE 8. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,000.00, or any other sum, to be added to the account for the Town's 250th Anniversary.

ARTICLE 9. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or borrow the sum of \$9,300, or any other sum, to be used in connection with and in addition to any funds allotted by the Commonwealth and/or County for the construction, reconstruction, and improvement of the town roads, or, to take any action relative thereto.

ARTICLE 10. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury or borrow the sum of \$27,944, or any other sum, to be used for the construction and/or improvement of town roads, to be reimbursed from the Commonwealth under Chapter 191, or, to take any other action relative thereto.

ARTICLE 11. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$15,500.00, or any other sum, to be used to install a new culvert pipe at the site of the bridge on Crockett Road (approximately Upton's share), or, to take any other action relative thereto.

ARTICLE 12. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$4,300.00, or any other sum, to be used for weed control at Pratt Pond, Taft Pond, Mill Pond, Lake Wildwood, or any one or more of them, in accordance with regulations of the Department of Environmental Quality Engineering, or, to take any other action relative thereto.

ARTICLE 13. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$5,000.00, or any other sum, for an audit of the accounts and records of the Town of Upton, or, to take any other action relative thereto.

ARTICLE 14. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$7,000.00, or any other sum, for Workmen's Compensation, or, to take any other action relative thereto.

ARTICLE 15. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,000.00, or any other sum, for gravestone markers for the new section of Lakeview Cemetery, or, to take any other action relative thereto.

ARTICLE 16. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$1,700.00, or any other sum, for the repair on the roof of the fire station, or, to take any other action relative thereto.

ARTICLE 17. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of \$900.00, or any other sum, for the purchase of two 2-watt, 2-channel portable radios, or, to take any other action relative thereto.

ARTICLE 18. VOTED: Unanimously that the Town vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow in anticipation of revenue for the fiscal year beginning July 1, 1983 in accordance with the provisions of General Laws, Chapter 44, Section 4, and to issue a note or notes therefor payable within one year in accordance with General Laws, Chapter 44, Section 17.

ARTICLE 5. VOTED: Unanimously that the Town vote to raise and appropriate the sum of \$31,772.00 in accordance with the provisions of Chapter 32, Section 22, General Laws for Pension Fund, Expense Fund, Military Service Fund, and Workmen's Compensation Fund, of Worcester County Retirement System.

ARTICLE 6; VOTED: Unanimously that the Town transfer the sum of \$300.00, said sum equal to that received from the sale of lots and graves during the fiscal year beginning July 1, 1983, in accordance with General Laws, Chapter 114, Section 15, to be used for cemetery oiling and grading.

ARTICLE 7. VOTED: That the Town vote to raise and appropriate the sum of \$1,000.00 for the Conservation Fund set up under Article 24 of the 1966 Annual Town Meeting.

ARTICLE 8. VOTED: Unanimously that the Town vote to raise and appropriate the sum of \$1,000.00 to be added to the account for the Town's 250th Anniversary Celebration.

ARTICLE 9. VOTED: Unanimously that the Town vote to raise and appropriate the sum of \$9,300.00 to be used in connection with and in addition to any funds allotted by the Commonwealth and/or County for the construction, reconstruction and improvement of the town roads.

ARTICLE 10. VOTED: Unanimously that the Town borrow the sum of \$27,944 to be used for the construction and/or improvement of town roads, to be reimbursed from the Commonwealth under Chapter 191.

ARTICLE 11. VOTED: Unanimously that the Town raise and appropriate the sum of \$15,500.00 to be used to install a new culvert pipe at the site of the bridge on Crockett Road (approximately Upton's share).

ARTICLE 14. VOTED: Unanimously that the Town raise and appropriate the sum of \$7,000.00 for Workmen's Compensation Insurance.

ARTICLE 15. VOTED: Unanimously that the Town transfer the sum of \$1,000.00, received from the sale of lots and graves, to be used for gravestone markers for the new section of Lakeview Cemetery.

ARTICLE 16. VOTED: Unanimously that the Town raise and appropriate the sum of \$1,700.00 for the repair of the roof of the fire station.

ARTICLE 17. VOTED: Unanimously that the Town raise and appropriate the sum of \$900.00 for the purchase of two 2-watt, 2-channel portable radios.

ARTICLE 18. VOTED: That the Town transfer the sum of \$10,000.00 from the Stabilization Fund for the purchase of a maintenance vehicle (3/4 ton pick-up truck) for the Town of Upton to be assigned to the Water/Sewer Department.

ARTICLE 19. The motion to accept Section 26G of Chapter 148 of the General Laws was declared lost.

ARTICLE 20. VOTED: That the Town amend the by-laws of the Town of Upton under Title 2, Municipal Government and Finance, Chapter 11, Personnel and Employee Benefits, by striking therefrom the provision entitled "Sick Pay" therein and by inserting in place thereof the following provision entitled "Sick Leave":

- (1) Sick leave credited on July 1, 1983 (as provided in paragraph (3) below) shall be in lieu of any and all unused sick leave that may have accumulated prior thereto. Any person whose employment shall commence after July 1 of any year shall be credited, until the following June 30, with one day of sick leave for each two calendar months of work, credit to begin at once for an employee commencing work prior to the 16th day of the calendar month; otherwise, credit shall begin on the first day of the calendar month following the month of hire.
- (2) Unused sick leave shall accumulate from year to year to a maximum accumulation of fifteen days.
- (3) On July 1, 1983, each employee shall be credited with six days of sick leave. On July 1 of each year after 1983 each employee shall be credited with six days of such leave, or with such a lesser number of days as will limit the accumulation from year to year of sick leave for any employee to a maximum of fifteen days.
- (4) For periods of absence from work of three days or more, a physician's certificate shall be required.
- (5) In cases of emergency the Selectmen may at their discretion grant to an employee an additional number of days of sick leave, said additional days not to exceed thirty in number.
- (6) All full time employees shall fill out time cards to verify the time worked. Said record shall be maintained by the Clerk of the department and a duplicate forwarded to the Town Accountant.

ARTICLE 21. VOTED: That Chapter II, Title II of the By-laws of the Town be amended by adding thereto, immediately prior to the provision as to "Effective Date" shown in the last paragraph thereof, the following provision entitled "Personal Leave":

Personal Leave. An employee, with specific approval of the Selectmen, may be granted up to one day of personal leave in any year to meet a serious personal obligation that cannot be met other than during working hours.

Personal leave shall not be deemed an extension of vacation leave, sick leave or emergency leave.

ARTICLE 22. VOTED: That the Town raise and appropriate the sum of \$5,000.00, and to transfer from the Overlay Reserve Account the sum of \$5,000.00 to the Finance Committee Reserve Account, said amount to be expended in accordance with Chapter 59, Section 25 of the General Laws.

Following the voting on Article 3 a motion was made by Gail Heald that the Town vote, in the event that less than \$8,000.00 can be raised and appropriated for the Council on Aging Coordinator's salary because of Proposition 2½ limits, to request that the Selectmen investigate the trusts within their jurisdiction and based on their judgment, assist the Council on Aging in funding its Coordinator's salary up to a total amount of \$4,000.00.

It was moved and seconded to dissolve the warrant and adjourn this meeting. This meeting adjourned at 5:00 p.m.

REPORT OF COMMUNICATIONS OFFICER

From an equipment standpoint, 1983 may be considered a near catastrophe. In May lightning made a direct strike on the base station located in the Fire Station, destroying the antenna and its lead-in cable, and causing considerable damage to the base radio. In fact, the damages continued to plague us throughout the summer and fall. While we've been gently coaxing along the base equipment to prolong its usefulness, the lightning short circuited our efforts. I would be remiss to not forewarn the Town that a replacement of the base system has become essential. Even though it has been repaired, the equipment is beyond its normal life expectancy and its reliability has been severely limited by the damages. Corrective measures have been taken to try to prevent a recurrence of the damages of last May, but we must now consider the need for new equipment. For all departments, the communications system is the vital life link with the townspeople's needs, without which emergency responses would be impossible. To avoid the potentially disastrous consequences of a total communications loss, I ask you to consider the need of replacing our main equipment.

From a personnel standpoint, 1983 was a year for a memorable first. Alvin P. Nichols became the first dispatcher to retire from the Communications service after almost eight years as a full-time dispatcher. We all wish Alvin the best in his retirement.

REPORT OF CONSERVATION COMMISSION

In 1983, the Conservation Commission, along with other town boards, noted an increase in the development of property in the town. Much of the land in Upton available for building is under the jurisdiction of the Conservation Commission; that is, it is within one hundred feet of a wetland, brook, stream, swamp, marsh, or other, as defined by the Wetlands Protection Act.

During the year, the Commission conducted five Wetlands Protection Act Hearings and signed Certificates of Compliance for three completed projects. The largest projects involved a development site at the junction of Hartford and Glen Avenues and a proposal for a gravel removal operation on Main Street in West Upton. Both projects required numerous on-site inspections. In cooperation with the Board of Selectmen, the Commission availed itself of engineering expertise in order to write Orders of Condition that would best protect the land itself, the adjoining wetlands, the landowners, and the community at large.

The Commission has noted, with regret, the increase of those private wood cutting operations that ignore good woodlot management practices. This mismanagement can result in scarred land, blocked streams, fire hazards, and negative changes in the environment. Several on-site inspections of such operations have been made by the Commission following complaints by concerned neighbors. Landowners are reminded that any work that could alter a wetland is under the jurisdiction of the Commission. Consideration for the land and for others is urged.

The Town woodcutting program continues and the Commission is pleased with the results. The program is limited to citizens of Upton and has proven beneficial to the woodlots involved. Hopefully, this will be an ongoing project.

Aquatic Control Technology of Northboro received the contract for the treatment of nuisance aquatic vegetation. Pratt, Wildwood, Taft, and Mill Ponds are treated on a rotating schedule, depending on need. The use of a rotating schedule insures the most efficient treatment of these ponds and maintains them suitable for recreational purposes.

The Commission expects a very busy year with the overseeing of the gravel removal project on Main Street, and, the possibility of new areas of development. Continued cooperation among town boards is essential if the anticipated growth is to continue in an orderly manner and the integrity of the lands involved is to be protected.

At the close of 1983, the Commission accepted, with regret, the resignations of two members, Elsie Craib and Sheila Porter.

REPORT OF COUNCIL ON AGING

1983 has been a year of new beginnings for the Council on Aging. Under the direction of John Morrel, working as part-time program developer and Acting Coordinator, the Council made significant strides in serving Upton's senior citizens.

A goal of many years became a reality when Tri Valley Elder Services, with the first funding available for program expansion in a number of years, selected Upton to become a congregate mealsite. During this same period Title XX funds made it possible for Tri Valley to assume the cost of our home delivered meals, paying both preparation costs and mileage for delivery. 4124 hot meals, prepared by Beaumont Nursing Home, were served to Upton elders this year. Beginning in January, our home delivered meals began emanating from our meal site at the Senior Center.

Among the many accomplishments during his tenure with us, Mr. Morrel wrote a successful grant enabling us to provide our clients with a twenty-four hour a day taped message containing basic information of interest to them. He developed and published a flier which details the services and programs available through the Senior Center. He arranged for a vegetable truck to visit the Center and Coach Road Apartments weekly providing easy access to fresh produce. His reinforcement and expansion of our linkages with many social services at both the county and state levels have been invaluable in maintaining and improving the quality of our services.

With the hiring of full-time coordinator, Joan Hoel, in July, Mr. Morrel resigned to return to his work as a Human Services Consultant.

Since that time, the smoothness with which our meal-site was launched combined with the high level of attendance at meals, resulted in our rapid transition from a 3-day a week site to a 5-day site, serving nutritious meals daily to an average of 50 to 60 senior citizens.

Our outreach program provides a vital link between clients, many of whom are homebound, and the information and services they need. Currently, with the help of grant funding, nineteen clients are being visited regularly by outreach worker Lucy Porter. Ms. Porter has assumed the caseload formerly handled by interim outreach worker Kathleen Usher. Elder Service Corps worker, Henry Smith, provides additional outreach information.

In the area of health, some one hundred twenty people took advantage of the first annual Upton Health Fair held at the Center in November. Cosponsored by the Council on Aging and the Upton Health Service, local doctors took part in providing health screening and information. The Senior Center continues to host blood pressure clinics provided by the Upton Health Service. An Alzheimers Disease educational support group has been formed in conjunction with the Visiting Nurse Association of greater Milford-Northbridge. The Stroke Club continues to hold monthly meetings at the Center.

Cheese and butter distribution, fuel assistance, counseling, referral for service to other agencies, plus information involving social security, SSI, health issues and other questions of concern are among the services available through the Center office.

Upton continues to be well represented in the Silver Haired Legislature with Edward Prentiss succeeding Anna Gorman as Senator for the First Worcester Middlesex District. Mr. Prentiss keeps Upton's seniors abreast of pending legislation through reports in "THE HOUR GLASS", a bi-monthly newsletter published by a staff of senior citizens and distributed to all residents over the age of sixty.

In October, the Council accepted with regret, the resignation of Rosina Nelson who had volunteered her secretarial skills in the Center office. Elizabeth Nichols succeeded Rosina in the position. The Council is grateful for the services of these two dedicated women. Among other volunteers are Grace and Henry Smith who open the building daily. Center hours are 8:30 a.m. to 4:00 p.m., Monday through Friday and 9:00 a.m. to 12:00 p.m. on Saturday. Office hours are 9:00 a.m. to 5:00 p.m. Monday through Friday.

Keeping our operation afloat without our volunteers would be virtually impossible. Their commitments include staffing the recreation room and supervising the myriad of activities 5½ days a week, working daily to assist in serving noon meals, being completely responsible for the custodial maintenance of the Center, assisting in the production, collation and distribution of "THE HOURGLASS", arranging recreational trips, driving clients to medical appointments and a variety of other activities too numerous to mention. This year alone, in excess of 5500 hours have been donated by these invaluable people.

Special thanks go to the Friends of Upton Elders for their untiring efforts as volunteers and fund raisers in support of our efforts. They have contributed thousands of dollars to assist us in staffing and Center operations since their inception four years ago.

The Council is looking forward to further upgrading services to the senior population. Major goals to be addressed during the coming year are increasing mobility for elders through a transportation system permitting greater access to Senior Center activities, more efficient medical and shopping transportsations to surrounding towns; and to provide respite relief to families caring for invalid members in their homes.

Recognizing the value and success of our programs, the townspeople, in 1981, voted at annual town meeting, to establish the position of Council on Aging Coordinator.

Since proposition 2½ had severely limited tax monies, the position was funded from a variety of sources including the Selectmen's trusts, monies raised by the Friends of Upton Elders, contributions from townspeople, and donations from Harbor Associates, the owners of Millhaus Apartments.

Last year, for the first time, the townspeople voted at town meeting to raise and appropriate money from taxation to help fund the position.

The life-sustaining services we provide to the more than 700 senior citizens of Upton require a full-time qualified coordinator. We look to the townspeople for the continued financial backing to keep our coordinator and our high level of service.

The Board of Health members respectfully submit this annual report to the town.

1983 was a busy year for the Board of Health members and agent, with the increase in building there was an increase in permits issued and inspections performed. Over eighty percent of the septic system permits issued were for new homes.

The Board of Health responded to 29 complaints from Upton residents. All the violations found were corrected and it was not necessary for any condemnations.

In April, the Board of Health endorsed a Rabies Clinic, held at the Fire Station. The clinic was conducted by Dr. Richard A. Heller. Martha Williams was also available to license dogs.

In July some of the local schools were inspected by the Board of Health for presence of lead paint and asbestos.

In November, Diane Tiernan, Clerk, began a six month maternity leave. Sandra Charette was hired as the acting clerk until Diane returns.

The Board of Health members regretfully accepted the resignation of Donald Johnson, Agent, in December. Philip Dumas, a Sanitary Inspector for the city of Worcester Department of Public Health, was hired.

REPORT OF HEALTH SERVICE COMMITTEE

The Town Nurse, and the Health Service Committee respectfully submit this annual report to the town.

The Health Service continues to function as the major provider of non-third party payment home health care in the town. Changes in Medicare-Medicaid regulations and the proliferation of H.M.O.'s in the area have necessitated an increase in the Health Service workloads. The nurse makes an average of 60 home visits and 10 office visits per month for a total of 705 home visits and 100 office visits this year. Such visits include newborn assessments, visits to monitor vital signs, dressing changes, and the administration of medication.

The cooperation of many service agencies is necessary to provide quality home health care at a reasonable cost to the taxpayers. The Greater Milford-Northbridge Visiting Nurse Association provides a wide variety of services to many of Upton's residents.

Tri-Valley Elder Services continues to provide free homemaker service to those over 60 meeting certain income guidelines and help on a sliding fee

scale for those outside those limits. The Health Service has a mutual referral system for the health care network, depending on the needs and resources of the client.

Along with home and office visits, the Health Service provides the following clinics for townspeople:

24 Blood Pressure Clinics	800 clients per year
3 School Immunization Clinics	45 children
4 Influenza Clinics	420 shots given
Mantoux (T.B.)	50 shots given

These clinics provide free preventative medicine for many people and are becoming more popular as other medical costs continue to rise.

Another area of involvement for the service is health education. The town nurse taught "Kid's Aid" (first aid for children) as a volunteer in the Mendon-Upton School System and conducted an educational overview of the interaction of food and medications for the Council on Aging and Women's Club. This year the Council on Aging and Health Service sponsored a Health Fair providing free health screening by a number of health professionals, 100 people took advantage of this program, hopefully an annual event.

The Town Nurse gratefully acknowledges the assistance of Jayme Armstrong, RN, Nan Haven, RN, Marjorie Wilcock, RN, Marjorie Keniston, RN and Cindy Wilson, RN.

REPORT OF THE LOCAL SUPERINTENDENT OF INSECT AND PEST CONTROL

During 1983, twenty-two (22) diseased Dutch Elm and twenty-four (24) diseased maple trees were removed in the town of Upton. Four (4) pine trees were removed that were weakened by the Gypsy Moth infestation in 1981.

Poison Ivy was sprayed at the school yards, Lake Wildwood, Upton Fire Station pine grove and along sidewalks where needed.

Thirty-one (31) stumps were removed that were dangerous to the public way.

The 1983 Gypsy Moth infestation was very light and no calls were received for assistance. The 1983 Gypsy Moth map shows that this next year will also be a light year. The home owner should check for egg masses around their yards; paint them with creosote, or scrape them into a can of kerosene, or have their yard sprayed if needed.

I wish to thank public officials, state and district supervisors and all townspeople for their help and cooperation in 1983.

REPORT OF THE BOARD OF WATER AND SEWER COMMISSIONERS

1983 — a year of projects. We awarded Paragon Contracting Corporation the contract for cleaning and painting the Pratt Hill water storage tank. That job has been completed, along with the installation of a fence by Cyclone. Wall Trucking Company was selected to rebuild the old existing sewer line along Main Street in West Upton. In spite of some problems encountered with ledge, that job also was successfully completed during the summer.

Near the end of the year, we placed an order for a new pickup truck with Oste Chevrolet of Boston, expected to be delivered early in 1984.

We have concentrated this year on the design and implementation of rates which realistically reflect the actual costs of operating the water and waste treatment facilities serving the town.

We have continued to press for the closeout of the 1981 sewerage extension project with the State Department of Environmental Quality Engineering. We had expected to resolve our differences by the end of the year with this agency, which represents both state and federal EPA. However, the DEQE has not yet notified us of any approval for release of funds. We hope to achieve a final resolution of this issue in 1984.

We were sorry to lose Mr. Aram Varjabedian during the year as our second treatment plant operator. We were, however, able to hire qualified persons on a part-time basis. In the meantime, we have been advertising for a full-time operator.

The Board also received with regret the resignation of Mr. Royce Beatty, who had served with distinction since 1976 as member and chairman. The Board expresses its sincere appreciation for the countless hours he has devoted to the successful completion of many projects during his eight years of service.

We also express our thanks to Mr. Daniel Fitzpatrick, who became a member of the Board in 1972, and served as a valued contributor through 1983.

The Board notes with regret the resignation of Mr. Henry J. Poirier as Superintendent of the Water Department. He has consented to remain in a consulting capacity, and continues to furnish valuable insight for various problems which arise. Mr. Leo Morin has very capably taken over the duties of Superintendent.

We acknowledge the invaluable and unselfish services of our Clerk, Mr. Olof Olson. He has contributed many hours of his time to assure the smooth operation of the departments this past year.

Finally, the Board appreciates the assistance and cooperation of town officers, members of other boards and commissions, and especially the people of Upton for their continued support and understanding.

REPORT OF LIBRARIAN

I herewith respectfully submit my annual report.

As required, books have been added to the Dr. Carpenter collection. Children's film on loan from the Regional System's Film Library were shown on Saturday mornings. An Easter egg candy hunt and jelly bean guessing contest were held. Children participating in the Summer Reading Program were rewarded with a paperback book.

Augmenting our book collection were loans from the Central Regional Library system in the forms of large print books, framed art prints, recordings and talking books. Specific requests for print and non-print material on inter-library loan were fulfilled by weekly van delivery.

My sincere thanks to Mrs. Gloria Shea, a Library Trustee, for contributing the time and effort in creating her interesting and original monthly displays. Her displays included knitting, tole, a miniature house, remembrance cups, wood carved animals, Kennedy and Earhart memorabilia, enameled tinware, hotel pitchers, post cards of Upton, a Grange arrangement and a Christmas theme.

I attended meetings and workshops held in neighboring libraries, the Globe Book Fair, the two-day NELA meeting at Hyannis and the NEELA meeting in Worcester. During my ALA sponsored trip to Russia last summer, I visited two important libraries that help service over 200 million readers. The beautiful Lenin State Library was impressive because it is second in size to our own Library of Congress, and it is engaged in an extensive exchange of books with 335 institutions in the United States. The Lenin Library in Leningrad with its huge reading hall that can accommodate one thousand scholars at a time doing research work is open only to those with a degree. Patrons with a doctorate are the only ones permitted to take books from this library.

In April, to our regret, Mrs. Janet Caton, our Library Trustee, retired. Mrs. Ruth Crooker, former member of the Board of Library Trustees, and Mr. Richard Lindi, former chairman of the Board of Trustees, passed away and are greatly missed.

REPORT OF THE PLANNING BOARD

There was considerable interest in Upton as a site for residential development in 1983. Four new subdivision plans were reviewed by the Planning Board representing 101 house lots and 21 townhouse condominiums. The condominiums would be the first in town. No final subdivision plans were acted upon by the Board in 1983.

SUBDIVISIONS

Brookside Farms Realty Partnership of Hopkinton proposed a subdivision on a 240 acre parcel of land straddling South Street near the site of the old Upton poor farm. The subdivision plans call for four new streets and 74 house lots. A subdivision to be called Heritage Heights was proposed for 44 acres of land off Forest Street. The plans call for two new streets and 22 house lots. A subdivision was proposed for eight acres of land off Mendon Road near Center Brook. One new street and five house lots are planned. Casa Corporation of Millbury proposed 21 townhouse condominiums for a seven acre parcel of land off Williams Street near Lake Wildwood. Development of Woodland Estates off Grafton Road remained incomplete at year's end.

LITIGATION

The case of Upton Planning Board v. Upton Zoning Board of Appeals, et al. (Worcester Superior Court, Civil Action No. 26524) is scheduled for trial in March 1984.

OTHER BUSINESS

The Planning Board welcomed new member Mary Ann Sterry following her election in May 1983.

No new amendments were proposed to the town's zoning bylaws or the subdivision rules and regulations.

Board members made several visits during the year to sites of proposed subdivisions and to parcels of land being considered by the zoning board of appeals for variance from the zoning bylaws. Board members attended several zoning board of appeals hearings and commented on proposed variances in an effort to improve communications between the two town boards most directly concerned with zoning and planning issues.

Regular School Committee meetings are held at the Blackstone Valley Regional Vocational Technical High School, Pleasant Street, Upton, Mass. on the third Thursday of each month in the Conference Room at 7:30 P.M.

1. The Blackstone Valley Regional Vocational Technical High School opened its school year on August 24, 1982 and completed on June 10, 1983. School was in session for 180 days. Regular educational/vocational programs were conducted five and one-half (5½) hours per day. Student progress reports were issued three times (at the end of each trimester). The dual program of academic study and specific occupational training was provided by way of alternating two-week cycles throughout the school year.

A total of 882 day-school students (720 boys and 162 girls) were enrolled on October 1, 1982. The distribution of students among the thirteen (13) regional district towns was as follows:

Sixteen (16) specialized vocational programs, designed to prepare young people for gainful employment were available. The district occupational training specialties were: Air Conditioning/Refrigeration, Auto Body, Auto Technology, Carpentry, Culinary Arts/Baking, Computer Information Processing, Drafting (Machine), Electrical, Electronics, Graphic Arts, Health Services, Machine Shop, Metal Fabrication/Sheet Metal, Painting/Decorating, Plant Maintenance, and Plumbing.

The school also provided Special Education services for ninety-six (96) young men and women who required individualized education plans. A substantially separate program (prototype 502.4), identified as Buildings and Grounds Maintenance, trained eight (8) young people for gainful employment.

2. Three categories of personnel were employed by the Regional Vocational School District to deliver the educational/vocational services. Staffing patterns and numbers of personnel are as follows:

3. Extra-curricular activities in which approximately 250 students participated included interscholastic team sports: Cross-Country, Soccer, Basketball, Baseball, Softball and Track & Field. Other activities included: Class Officers, Yearbook, Jr./Sr. Prom, Cheerleading and fund raising functions. Senior Week provided graduates with a class banquet and a Recognition Night at which outstanding seniors received scholarships and awards.

4. The highly successful Cooperative Education Program, in spite of the serious recession, was able to locate jobs for 89 seniors during the past year. It is a credit to the reputation of the school that employers were willing to hire and train students during the school year. All of the cooperative education participants profited immeasurably from the extension of their vocational training by actually working in the field and being paid for their skills and abilities.
5. Two adult training programs were sponsored and conducted during the school year. (1) The Basic Electronic Assembler Program (supported with Federal funds) was conducted twice during the year. Some 34 adults (men and women) ranging in age from 18 to 55 years old were trained to take jobs in the electronics field. All of the trainees were selected by cooperating employers and the Division of Employment Security on the basis of need (displaced homemakers, unemployed, and handicapped) and aptitude. Over 94% of the trainees were employed by end of the intensive 500 hours of specialized training. (2) The regular Evening Adult Training Program was conducted in two sessions, in the fall during October and November and in the spring from mid-March to May. This self-sustaining (trainees paid a minimum of \$70.00 per training course) program trained or upgraded a total of 165 men (149) and women (16).
6. The long awaited evaluation by the New England Association of Schools and Colleges was conducted in December of 1983 with the result that the Blackstone Valley Regional Vocational Technical High School was found to meet standards for continued accreditation by the association. Official notification was received in May 1983.
Plans to implement recommendations for improvement will be initiated in 1983-84.
7. The climax of the school year occurred with Graduation held in the James S. Mullaney Gymnasium on Sunday, May 22, 1983. One hundred and sixty-eight (168) seniors were awarded high school diplomas and vocational certificates by a successful alumnus, Peter Girouard, Class of 1972, who possesses a B.S. Degree and is currently employed as an experimental machining supervisor for Wang, Inc.
Class officers were: Judith E. Army (Millbury), President; Ginger M. Lodi (Northbridge), Vice President; John B. Lucier (Millbury), Secretary; James A. Haley (Bellingham), Treasurer.
8. The citizens of the Vocational Regional School District shared directly in the training of students during the past year. A major renovation of the former school administration building in the town of Milford was completed in behalf of that town's Council on Aging. The year-long project provided an excellent training site for students of the Carpentry, Electrical and Painting/Decorating programs.

In addition, other training programs such as Auto Body, Auto Technology, Graphic Arts, and Metal Fabrication, were utilized by citizens of the Valley.

The school's Three Seasons Restaurant, open from September through June (11 AM to 1 PM daily), was patronized by numerous groups and individuals for luncheons, buffets and special meetings. Pastries and other baked products were also purchased by visitors to the school.

Health Services Program students gained valuable practical experience by conducting blood pressure clinics. These trainees also assisted at two major Red Cross Blood Drives from which a total of 180 pints of blood was collected.

These mutually beneficial and cooperative activities are vital to the school's continued ability to train young people in the acquisition of skills necessary for employment.

9. The school year was not free of problems. Substantial repairs to original plant equipment and core facilities (boilers) were undertaken. The repairs were caused by aging machinery, boilers and drainage which were originally installed in 1965. There is a real need to budget funds annually for equipment replacement and for maintenance of core facilities before breakdowns occur and serious emergency situations result.
10. In conclusion, we are pleased to report satisfaction in achieving the goals and objectives of Vocational Education. The School Committee, Administration, Faculty, Advisory Committees, Students and Support Staff are fully aware and appreciate the whole-hearted support given by the citizens of the Blackstone Valley Vocational Regional School District.

REPORT OF THE MENDON—UPTON REGIONAL SCHOOL DISTRICT COMMITTEE

To the Citizens of Mendon and Upton:

We have seen many changes in our school system this year.

We have accepted, with regret, the retirement resignation of Dr. Charles R. Hand after eleven years in our system.

Mr. Anthony H. Gulla, Jr. has been appointed Acting Superintendent of Schools and Mr. Allen J. Byrne, Acting Principal of Nipmuc Regional High School for one year to allow ample time to conduct a search for a new superintendent.

Mr. Gulla and Mr. Byrne have worked very hard this year as have all our administrators and staff to assure that the system and students have had minimum disruptions during this difficult transitional year.

We hired New England School Development Educational Council (NESDEC), a non-profit organization, to help us in our search for a new superintendent. They have helped the committee immensely in the undertaking of this extremely important job.

After serving three (3) years on the committee, Brian Hastings decided not to seek re-election, although he is still very active with P.A.G.E., a volunteer group in our system. We thank him for his service on the committee and welcome Joy DiLegge in his place.

The committee would like to take this opportunity to thank the many volunteer groups in our system: Upton Mothers' Club, Warriors Club, Music Boosters, PAGE and the Advisory Council on Education (ACE) for their fund raising efforts for school activities. Through their efforts our students have been able to make many field trips which were cut from the budget because of Proposition 2½.

Maintenance of Buildings — as with previous committees the maintenance of the buildings is of great concern. Every year as we must make difficult decisions on whether to cut programs or to cut maintenance projects, the maintenance has been cut back. This action is fast catching up with us as we now have two buildings, Clough and Memorial Schools, which must have the roofs replaced within the next couple of years at the latest or we are going to have serious problems with both buildings.

We have been extremely fortunate this past year in hiring Dr. Herrick Hawkins as a coordinator of Health Education. He has been instrumental in setting up a Task Force on the dangers of drug and alcohol abuse in our school system.

We would like to express our appreciation to our administrators, staff members, and all other employees for their part in the success of our schools during this very difficult year. We also wish to thank the people of both communities for their continued interest and support.

EDUCATION

The School Committee had two distinct segments within the calendar year 1983. The first seven months saw the School Committee intensely involved in the development of a school budget for fiscal year 1983 and its final adoption with all credits correctly apportioned to both towns. It must be understood that budget cuts and adjustments of the magnitude expressed this year cannot regularly be absorbed without destroying our public education system as we know it. Dr. Charles R. Hand resigned his superintendency as of August 31, 1983. The second five months saw the Committee in search of a new superintendent of schools and the temporary transition of leadership within the school system. Mr. Gulla assumed temporary responsibilities as Acting Superintendent of Schools for the district. Mr. Byrne became Acting Principal of Nipmuc Regional High School along with Mr. Olson teacher and Acting Vice-Principal.

In order to help assist Mr. Milligan, principal of Miscoe Hill Middle School, Mr. Henry Morel was made Head Teacher. Mr. Edward Furphy, sixth grade teacher at Miscoe Hill Middle School, retired from teaching December 31, 1983.

COMPUTER LITERACY

In 1972, the Committee on Computer Education of the Conference Board of the Mathematical Sciences concluded that: "It is essential that our educational system be modified in such a way that every student become acquainted with the nature of computers and the current and potential roles which they play in our society."

Addressing this need, our school district established a Computer Task Force Committee of citizens and educators for the purpose of developing goals and objectives for a Comprehensive Computer Literacy Program.

Mr. Steven Rakitin, an Upton resident and computer specialist, presented recommendations of the Task Force Committee to the school committee. Further, study is needed before full implementation can begin. Information will be released as the study continues.

GIFTED AND TALENTED PROGRAM

Project Must (Mendon-Upton Servicing Talent) is a program for gifted and talented elementary school students in its first year of operation.

The basic design of MUST is a pull-out program using a resource room and teacher. It places emphasis on a combination of skill lessons, group projects and individual research.

One of the major components of this program is a system of project sharing, called "Two-Way Enrichment," which ensures that the work of the students in the pull-out program will return to the regular classroom and become of value as enrichment to the rest of the school population. This approach serves two functions: the task of researching, designing and producing a presentable project becomes an enrichment education tool for the gifted student, and the presentation of this gained knowledge to the regular classroom is an addition to the regular curriculum.

LANGUAGE ARTS AND MATHEMATICS COORDINATION

The emphasis in the work of the Mathematics Coordinator has been organizing and designing the function of the Computer Task Force Committee and evaluating the mathematics program systemwide.

Enrichment and supplemental materials have been added to strengthen the program in key areas. The organization and purchase of educational software for our classes has begun.

The Language Arts Coordinator has been evaluating and making recommendations in the areas of writing skills and study habits systemwide. Attempts are being made to coordinate a pattern of skill development which will be consistent throughout the system. A series of study-guide filmstrips and study guide packets are planned for purchase this year.

Both coordinators have developed packets for teachers to enhance certain skill areas in the language arts and mathematics.

SCHOOL ENTRY AGE

A major policy change in regards to school entering age was made during this past year. Following much research and several public meetings, the Entry Age Study Committee Members recommended and the Mendon-Upton Regional School Committee voted to change the entrance date for kindergarten from a child's having to be five years old on or before December 31st, preceding the opening of school in September to having to be five on or before August 31st,

prior to entering kindergarten. The policy continues on to state that a child must be six years old on or before August 31st to enter first grade. The effective date for kindergarten entrance is the opening day of school in 1984. The effective date for entrance to first grade is the opening day of school in 1985.

The recommendations and subsequent votes were based on the premise that all children need the gift of time to grow and to develop. School readiness is not determined by age; however, policies are needed to organize our school programs.

The policy was voted as a universal cut-off date with no exceptions.

CAFETERIA

Beginning in September 1983, the Mendon-Upton Regional School District Lunch Program began a satellite feeding system. Under this program, food for the Henry P. Clough School and Upton Memorial elementary schools is prepared in bulk at Nipmuc Regional High School and transported to these schools in order to lower the labor and food costs throughout the district and to provide balanced and nutritious meals. Putting this practice to work reduced the price for full meals at the elementary schools from eighty cents each to sixty cents each.

During the late fall and winter months, there has been greater pupil participation in lunch and a general acceptance of the program.

The staffs at all schools have been helpful in working out the problems encountered at the beginning of the year and continue to make suggestions to make the program responsive to the needs of all the students.

SIX DAY CYCLE

In order to better coordinate the efforts of personnel who must divide their time among the elementary, middle and high schools, the Mendon-Upton Regional School District has adopted a six-day schedule. This six-day cycle is coordinated among all schools for the first time this year.

A six day schedule is simply another way of insuring the continuity of school days. Rather than the usual Monday, Tuesday, Wednesday, etc., days become day 1, day 2, day 3, and so forth. A "week," therefore, becomes a cycle of six days and is not dependent solely on a calendar week.

Personnel, such as art, gym, etc. shared among schools, are in residence at each school for six days at a time. Their six day week is never shortened because of holidays or snow days. For example, if a teacher is scheduled to be at one school for a six day week and one day is cancelled because of snow, that cancelled day is made up on the day school reopens. Classes are not cheated out of time in the art room or gym if they are scheduled on a snow day or holiday as they would be under the old Monday through Friday schedule.

NIPMUC REGIONAL HIGH SCHOOL EVALUATION

Nipmuc Regional High School was evaluated on the days of April 10 through 13, 1983, by a visiting committee appointed by the New England Association of Schools and Colleges. The primary concern of the evaluation team was to assess the quality of the educational program for grades nine through twelve.

The evaluation program which public schools must undergo is a threefold process: the self-study conducted by the local professional staff, the evaluation by the Commission's visiting team, and the follow-up program carried out by the school to implement the findings of its own self-study and the valid recommendations of the visiting team. Continued accreditation requires that the school be re-evaluated at least once every ten years.

The visiting committee submitted a thirty-three page report to the New England Association, and we are proud to say that on September 29, 1983, the Commission on Public Schools awarded Nipmuc Regional High School continued accreditation in the New England Association of Schools and Colleges. Because we received this honor, many thanks must go to the faculty and staff of Nipmuc Regional High School, members from the communities of Mendon and Upton, the school committee, and the students without whose cooperation this endeavor would not have been completed successfully.

Changes in graduation requirements and awarding of credits have been upgraded for the following reasons:

1. To encourage students to utilize their time better by adding classes in place of study halls.
2. To broaden the scope of knowledge so that better career decisions may be made.
3. To upgrade and improve curriculum choices.
4. To place greater demands on students.
5. To receive fuller utilization of the school dollar.
6. To give greater meaning to a Nipmuc diploma.
7. To require three years of mathematics for graduation.

We are pleased to announce that two members of the Class of 1984 are enrolled in an early admissions program at the University of Rhode Island.

IN-SERVICE PROGRAMS

Under the able leadership of Elaine Ford, Head Teacher at Memorial School, a questionnaire was distributed to all staff members in an effort to determine needs for inservice programs. In general, computer literacy, behavior and discipline, health education issues, curriculum coordination and children with learning problems were felt to be major areas for programming. Mrs. Ford and the In-Service Committee developed programs to address these issues for the full inservice day and the four release days during the 1983-1984 school year. These programs were designed to meet staff needs as well as recommendations of the recent Nipmuc Regional High School evaluation.

DRUG AND ALCOHOL AWARENESS

Use and abuse of drugs and alcohol have been a long standing concern of the parents, citizens and school staff of Mendon and Upton. Under the direction of our now full-time Health Education Specialist, Dr. Herrick Hawkins, a Task Force has

been formed as a direct result of the communities participating in the nationally televised film, "The Chemical People." A major goal of this group of parents, citizens, students and school staff is to coordinate a community wide effort of drug and alcohol awareness, education, prevention and intervention. A specific task of the group is to publish a bi-monthly newsletter. The Task Force has received a wide range of support from local organizations, churches, law enforcement and town officials. Meetings are open to the public. All citizens of Mendon and Upton are encouraged to "Come and bring a friend."

As we get ready to move into a new year, there is hope that from adversity will come a pulling together to preserve the best of the Mendon-Upton Public Schools for which so many have labored and toiled for so many years.

As budgeting decisions will seemingly be the continual focus of the School Committee's discussion for many months to come, we shall hope that the children of Mendon and Upton will continue to be viewed as the assets of the communities rather than as its liabilities.


The continual commitment of School Committee members, staff, parents, and citizens to retaining the quality of Mendon-Upton Public Schools is promising.


