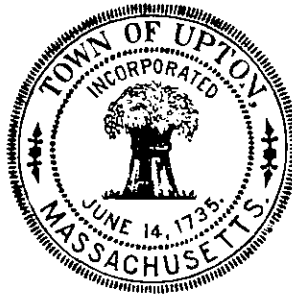

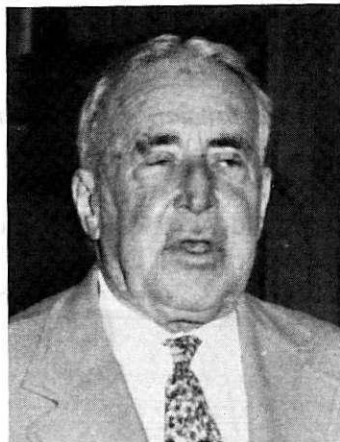

WARRANT FOR SPECIAL TOWN MEETING

February 6, 1984

To either of the Constables of the Town of Upton in the County of Worcester,

Greeting:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Upton Town Hall in said Upton on Monday, the sixth day of February next, at seven thirty o'clock in the evening, then and there to act on the following articles:

ARTICLE 1: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of One Thousand, Eight Hundred and Eighty Dollars, (\$1,880.00) for professional services rendered by Attorney Philip M. Cronin with respect to the action brought by James J. Janson against the Town of Upton, or to take any other action relative thereto.

ARTICLE 2: To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of Two Thousand, Three Hundred and Seventy Dollars and Sixty-one cents (\$2,370.61) for professional services rendered by Attorney Philip M. Cronin with respect to the action brought by Thomas E. Barnicle against the Town of Upton, or, to take any other action relative thereto.

ARTICLE 3: To see if the Town will vote to transfer the sum of Five Thousand and Twenty Dollars (\$5,020.00) from the Fence-Pratt Hill Standpipe Account to the Fence-Glen Avenue Pumping Station Account, or, to take any other action relative thereto.

ARTICLE 4: To see if the Town will vote to transfer the sum of Seven Hundred and Ninety Dollars (\$790.00) from the Clean-Flush Well Field Account to the Treatment Plant Maintenance Account, or, to take any other action relative thereto.

ARTICLE 5: To see if the Town will vote to transfer the sum of Five Thousand, Five Hundred Dollars (\$5,500.00) from the Clean-Flush Well Field Account to the Treatment Plant Maintenance Account, or, to take any other action relative thereto.

ARTICLE 6: To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to sell at Public Auction or private sale, the property formerly owned by Charles Marble until about 1953 and now the property of the Town of Upton, said property being located behind the Ronald H. Hixon property at 108 Main Street, West Upton, or, to take any other action relative thereto.

ARTICLE 7: To see if the Town will vote to transfer from available unappropriated funds in the Town Treasury or from Benefit Payment Account the sum of Eight Hundred Dollars (\$800.00) to the Veterans' Expense Account, or, to take any other action relative thereto.

ARTICLE 8. To see if the Town will vote to accept the provisions of Chapter 597, Acts of 1982, an act which gives an excise tax exemption to ex-POW's of all wars on one pleasure vehicle of which they are the principal operator, or, to take any other action relative thereto.

ARTICLE 9. To see if the Town will vote to raise and appropriate or appropriate from available unappropriated funds in the Treasury the sum of Four Thousand Dollars (\$4,000.00) to pay the Water Extension Loan #2, or, to take any other action relative thereto.

PROCEEDINGS OF SPECIAL TOWN MEETING

February 6, 1984

The meeting was called to order at 7:30 p.m. by Moderator George W. Burnham. With a quorum present, the moderator read the call and constable's return. The moderator announced that the non-voters seated on the main floor were Eileen Vigliante of the Milford Daily News, Catherine Bavosi and William Fitzgerald. Barbara E. Burke and Nancy E. Kennedy checked sixty-six voters into the hall during the meeting.

ARTICLE 1: Voted: Unanimously that the Town appropriate from available unappropriated funds in the Treasury, the sum of \$1,880.00 for professional

services rendered by Attorney Philip M. Cronin with respect to the action brought by James J. Janson against the Town of Upton.

ARTICLE 2: Voted: Unanimously that the Town appropriate from available unappropriated funds in the Treasury the sum of \$2,370.61 for professional services rendered by Attorney Philip M. Cronin with respect to the action brought by Thomas E. Barnicle against the Town of Upton.

ARTICLE 3: Voted: Unanimously that the Town transfer the sum of \$5,020.00 from the Fence-Pratt Hill Standpipe Account to the Fence-Glen Avenue Pumping Station Account.

ARTICLE 4: Voted: Unanimously that the Town transfer the sum of \$790.00 from the Clean-Flush Well Field Account to the Treatment Plant Maintenance Account.

ARTICLE 5: Voted: Unanimously that the Town transfer the sum of \$5,500.00 from the Clean-Flush Well Field Account to the Treatment Plant Maintenance Account.

ARTICLE 6: Voted: Unanimously that, pursuant to the G.L. Chap. 40, Section 3, the Town authorize the Selectmen to sell, at private sale or by such other means as they shall deem appropriate and for such consideration as to them shall seem proper, all right, title and interest that the Town has or may have under a deed dated December 10, 1952, signed by Charles H. Marble, Ruth E. Marble, and Estella (Eastella) H. Williams purporting to convey the same premises conveyed to Mary A. Marble by William Knowlton and Sons Co., dated October 19, 1926 and recorded in the Worcester District Registry of Deeds, Book 2419, Page 457.

ARTICLE 7: Voted: Unanimously that the Town appropriate from available funds in the Treasury the sum of \$800.00 to the Veterans' Expense Account.

ARTICLE 8: Voted: That the Town accept the provisions of Chap. 597, Acts of 1982, an act providing for the issuance without payment of a fee of distinctive license plates to former prisoners of war, Sections 1, 2, and 3; Section 3 states, "No fee shall be exacted for the registration of one pleasure passenger vehicle owned and principally used by a former prisoner of war who is entitled to display thereon the distinctive number plates authorized by section two."

ARTICLE 9: Voted: Unanimously that the Town appropriate from available funds in the treasury, the sum of \$4,000.00 to pay the Water Extension Loan #2.

It was moved and seconded to dissolve the warrant and to adjourn this meeting. This meeting adjourned at 7:55 p.m.

REPORT OF BOARD OF SELECTMEN

During 1984, the Board of Selectmen was privileged to participate in preparations honoring Upton's history, to successfully address current town business, and to seek and examine means of coping with the demands of effective town government for the future.

Upton was incorporated as a town in 1735. In commemoration, the rededication of the Town Hall in September presented the first of several planned activities and celebrations. In a ceremony patterned after the original, those attending were provided a thoroughly enjoyable and interesting glimpse into our past. In October, Board members accepted the first copies of **UPTON'S HERITAGE** from Nancy Beatty, Historical Society President. The Board offers its admiration and thanks to author Donald B. Johnson and to members of the Historical Commission and the Historical Society. Hours of labor and cooperation combined to provide our citizens a fascinating chronicle of the past and a treasure for the future.

The Board appointed Norman E. Walker of Brooks Street as the Chairman of the 250th Anniversary Committee.

The resignation of Road Commissioner, Henry J. Poirier, was reluctantly accepted by the Board of Selectmen, effective November 19, 1984. We offer our sincere appreciation for his thirty years of outstanding service devoted to the Town. William S. Evans, Jr., was appointed to fill this position for the duration of the term.

Henry J. Poirier, Jr., resigned as Fire Chief after many years of attention and service to the Town. Richard J. Henderson was subsequently appointed as Fire Chief. Upton is most fortunate to have persons of this caliber willing to fill these positions so important to the effective functioning of the town. We owe much to these people and extend to them our heartfelt thanks.

During the year, several lawsuits from months past were resolved. This required numerous hours of attention from the Board as have the ongoing negotiations with representatives from the labor union of the Police Department.

The position of Circuit Rider, filled by James Purcell, has proven to be of immense aid to the Board. Labor negotiations, fulfilling state and Federal requirements, and association with the various Town Boards and elected officials demand increasing hours from the Board of Selectmen. The Circuit Rider has advised and worked with the Board to untangle and to resolve this complexity of demands.

In an effort to explore means of managing Town government in a productive and cost efficient manner, the Board is attending meetings with representatives from the neighboring towns of Hopedale, Mendon, Millville, and Exbridge to discuss the feasibility of a regional dispatching and lockup system. A steering committee comprised of Chairpersons from the Boards of Selectmen, or a designee, meet regularly as does a technical subcommittee comprised of public safety officers.

Our history is an elaborate tapestry of human endeavor and success.
We are rich in promise and we welcome the future!

REPORT OF COUNCIL ON AGING

Council on Aging services and programs assist Upton's elders to maintain a quality of life that allows them to remain in their homes as long as possible. This is done by ensuring that our clients receive nutritious meals, nursing services, respite care, medical transportation, fuel assistance, outreach services, transportation to grocery shopping, government surplus food, income tax assistance, personal counseling and information and referral to other agencies when indicated. These services are coordinated by our Director, Joan Hoel and emanate from the Senior Center in West Upton.

RESPITE CARE

In conjunction with our efforts to keep our senior population independent, the emphasis this year has been on instituting respite relief for people caring for invalid family members in their homes and expanding transportation services to our clients. Both were accomplished at no cost to the town.

Respite care is now a reality through Tri Valley Elder Services in cooperation with the Council. Trained volunteers are making this possible.

TRANSPORTATION

A \$4,000 State Grant, augmented by an intensive fund raising effort by the seniors themselves, has permitted us to implement a transportation service for weekly grocery shopping and trips to Senior Center activities. Currently, 35 individuals have taken advantage of the van service giving them more independent access to the community.

Medical transportation continues to be supplied on a demand-response basis. Two hundred eighty-one medical trips were provided by eleven volunteer drivers with forty-four elders receiving the service.

NUTRITION

Our congregate meal site celebrated its first anniversary in June. Through Tri Valley Elder Services and 50 of our own volunteers nutritious noon meals are served 5 days a week for 50 to 60 people. Barbara Thompson, our meal site manager, brings people together in a congenial family atmosphere making the program a catalyst for attracting new participants to the Center.

The home delivered, Meals on Wheels program has expanded to 15 participants with Elizabeth Aldrich succeeding Alvin Nichols in delivering hot meals Monday through Friday. The Council would like to recognize and thank Nelson Mosso who was our meals driver for the first five years of the program.

OUTREACH

Outreach visits provide a vital link between clients and the services they need. Funded by a State Grant, Claire Healy is making our home visits. Outreach information is also dispensed by Elder Service Corps worker, Henry Smith.

THE HOURGLASS, a bi-monthly newsletter is a massive outreach effort. Planned, written and edited by a staff of seniors, it is distributed to every senior household in Upton. Lucille Gilbert's business machines class at Nipmuck High School, in cooperation with THE HOURGLASS staff, runs off the newsletter.

HEALTH AND FITNESS

With the national focus on fitness and the realization of its importance in total health, health and fitness programs have dominated the scene at Upton's Senior Center this past year. Some one hundred Upton residents attended a Multiphasic health clinic sponsored by the Council on Aging and the Upton Health Service. HEALTHWORKS, a national health screening organization, provided needed materials for the clinic and the Upton Women's Club and Bloomer Girls provided funding. Volunteer medical personnel and local doctors furnished health screening and information. Monthly blood pressure clinics continue to be provided at the Senior Center by the Upton Health Service. The Council recognizes the vital contribution of Town Nurse, Sheila Porter in helping to coordinate health services to Upton's elders.

The Upton meal site won a Health Hike award from Tri Valley Elder Services for its high level of participation in a program encouraging seniors to put exercise into their lives. Upton's seniors also won an award for their spirited participation in the Governor's Walk For Fitness held in Boston for people age forty and over.

As a result of general health concerns and in cooperation with the Domestic Policy Association and Worcester State College, the Council hosted a forum for discussion on rising health care costs.

A monthly podiatry clinic conducted by Dr. Michael Biancamano of Whitinsville, is held at the Senior Center in order to make access to this service easier.

Increased use of the Senior Center has made daily maintenance a necessity. This service is being provided by Francis Aldrich, again at no cost to the town, under the Green Thumb program.

The Friends of Upton Elders continued to be a mainstay for monetary, material and volunteer support again this year. In addition to their annual Fall Fair which has become an "Event", they added a community pancake breakfast to their fund raising activities. The efforts of these dedicated people have made programming and capital purchases possible at a great saving to the town. Annually, they donate innumerable volunteer hours along with many dollars toward staffing and materials. We recognize and are grateful for their efforts.

Two energetic secretaries, Elizabeth Nichols and volunteer Stanton Baker, keep the Center office humming. Ad Hoc Council member, Edward Prentiss contributes information on legislation affecting the elderly and provides advocacy for elders under a Department of Elder Affairs Program. Grace and Henry Smith, who open the building daily are among the many volunteers who collectively contribute between 7,000 and 8,000 hours annually. The Center is open Monday through Friday from 8:30 a.m. to 4:00 p.m. and on Saturday morning from 9:00 a.m. to 12 noon. Office hours are from 9:00 a.m. to 5 p.m. Monday through Friday.

In an effort to make the Senior Center a community focal point and to integrate all ages with common interests, we make our facility available for meetings, special community celebrations and educational programs. This year our facility was used by the town to welcome Dr. Crisafulli, our new Regional School Superintendent, Elder Network Professionals met to share ideas, the Stroke Club for its meetings and by the Council to sponsor a Candidate's Night.

The initiation and expansion of present programming and services for Upton's senior citizens is largely due to the cooperative efforts of the Council with local boards, state, county and federal agencies and the townspeople of Upton. We look forward to continuing this cooperative endeavor.

REPORT OF CONSERVATION COMMISSION

During 1984, the Commission was involved in a wide variety of activities. Throughout the year, eighteen specific actions were taken, including investigation of six complaints filed by residents and seven public hearings. The result of these activities has been a broader recognition of the Commission throughout the town and respect from the new developers in the community.

In June and July we completed our weed control program with chemical treatment of Pratt Pond, Mill Pond, Taft Pond and Lake Wildwood. Due to a continuing concern over the use of chemicals in our wetland areas, the Commission is investigating other weed control methods for use in 1985. Don Taft has contacted several experts in vegetation control for advice. The long term effect of chemical treatment in our ponds is a major concern for our board.

The town woodcutting program was completed in 1984 with the sale of our last lot. Over the past two years this program has not only brought in several thousand dollars of revenue, but also provided firewood for many town residents. We have begun identifying areas in town where we can implement another successful program during 1985.

Several meetings during 1984 were devoted to the onslaught of Gypsy Moths in the area. Several areas in town were impacted during 1984 and a

visual survey by members of the board has revealed that the impact in 1985 may be worse. Late in 1984 we began to put together a plan to educate Upton residents about what can be done with the Gypsy Moth situation.

In the beginning of the year, the Commission accepted, with regret, the resignation of Donna Moore, previously our Chairman. By the end of the year we had the Commission back to full strength with the addition of several new members. The board now has a well rounded base of expertise in both environmental concerns and town areas with the addition of Tony Charrette, Harriett Fougere, Sandy Lajoie and John Bill. Several members have taken active interest in environmental activities outside the town including acid rain and MACC seminars.

In the coming year, the Commission will be actively involved in the Town's largest residential development to date on South Street. This project along with the normal Wetland Protection activities will keep the Commission very busy.

REPORT OF THE DEPARTMENT OF EMERGENCY MEDICAL SERVICES

This is the first year that the Department of Emergency Medical Services (EMS) has been in existence. In previous years, the ambulance report has been incorporated as part of the Fire Department's annual report. While the change will not be noticeable to the townspeople, the creation of the new department allows the town to be more responsive to the rapidly changing field of emergency prehospital care.

The Department presently consists of 18 men and women who are certified Emergency Medical Technicians (EMTs). These EMTs respond to medical emergencies on a volunteer basis any time, day or night. The time and effort these EMTs give to the town is invaluable as many townspeople can attest to.

During the past calendar year the Department answered 296 calls. June was the busiest month with 40 calls while March and November were tied for the slowest month with 15 calls.

The past year has seen a number of changes including the formation of the EMS Department and the need for a moratorium on non-emergency transfer calls. We believe that the major issue for the coming year will be whether the

Department will be required to charge for calls in order to support its budget.

In conclusion, we wish to express our thanks to the Fire and Police Departments. Without their help we could not function properly. We would also like to thank a number of individuals who were instrumental in getting the new department started. The Board of Selectmen who saw the need to create a new department, Nancy Poirier for being the first Director, and Marguerite Henderson. Marguerite, as Training Officer, has worked very hard to provide the EMTs with quality training courses.

We look forward to providing the townspeople with the best prehospital care possible and we welcome individuals who are interested in becoming EMTs and joining the Department.

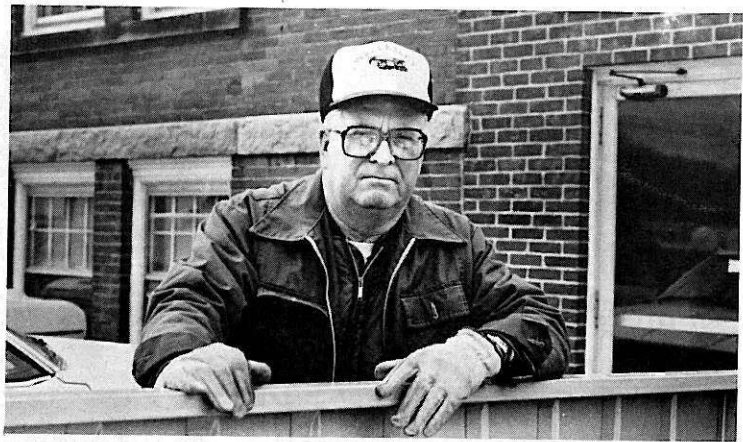

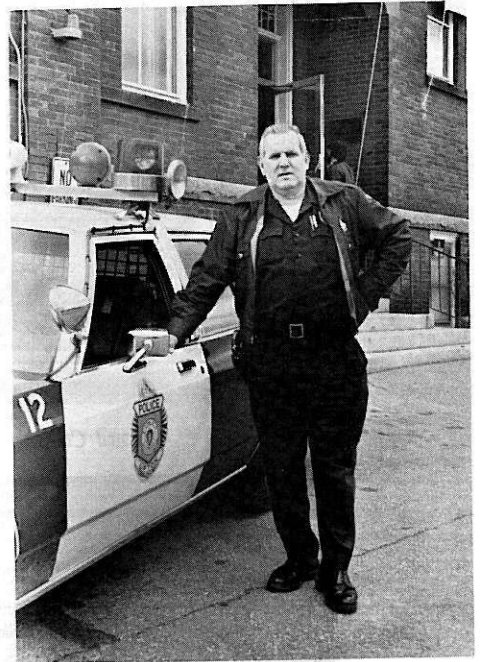

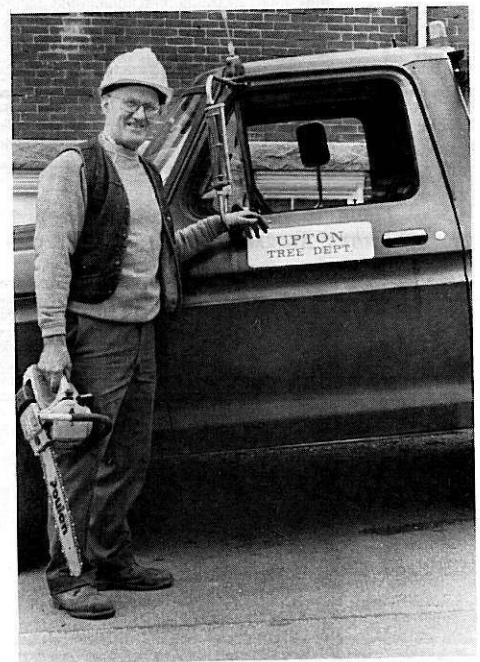

The Town Nurse and the Health Service Committee respectfully submit this 1984 annual report to the town.

In response to rising health care costs, Medicare has again changed its regulations for service to homebound elders. These changes have resulted in earlier discharge for patients from acute care facilities, shorter stays in nursing homes, and fewer home care services covered by Medicare payments. All these things plus similar changes in insurance payments and Health Maintenance Organizations increased the workload of the Upton Health Service.

The town nurse provides care to any Upton resident without third (3rd) party payment for a certain service. Such care includes physical assessment, monitoring of vital signs, dressing changes, newborn assessment and referrals to other agencies.

In 1984, the town nurse made an average of 75 home visits per month, 10 office visits, and conducted 3 clinics per month. Clinics provide blood pressure and pulse checks, influenza vaccine, childhood immunizations for DPT, MMR, polio and Mantoux tests for the detection of TB.

The Upton Health Service works with the Council on Aging under the direction of Joan Hoel, the VNA, Kathie Allen, R.N. and Tri-Valley Elder Services to provide comprehensive home care for Upton's large elderly population. Such cooperation has allowed these agencies to avoid having clients "lost in beaurocracy." With many agencies working together, there is more efficient use of services and fewer people falling through the cracks of our social service system.

Healthworks, a preventative health screening clinic, was presented in April of 1984. Services available were eye screening, dentistry, podiatry,

diabetes screening, hypertension screening, and various blood tests. All services were free with the exception of lab work which provided comprehensive blood screening for \$17.00 per person. The fair was a success and the Health Service and Senior Center hope to make this an annual event.

Health education is another service offered by this agency. Seminars, talks, and training sessions have been run for the Tri-Valley Elder Services Meal Site Program, for the Upton Woman's Club, the Council on Aging, and the EMT's. Hopefully, through such programs, residents will be encouraged to take an active part in their own health care, a necessity in this day of specializations.

The town nurse gratefully acknowledges the assistance of the many volunteers taking part "Healthworks", Flu Clinics and Blood Pressure Clinics throughout the year, especially Henry Smith.

**REPORT OF THE LOCAL SUPERINTENDENT
OF INSECT AND PEST CONTROL**

During 1984, twenty (20) Dutch Elm diseased trees, and eight (8) diseased maple trees and eight (8) pine trees that were dead because of the Gypsy moth infestation of 1981, were removed.

Twenty-eight (28) stumps were removed that were dangerous to the public way.

The 1984 Gypsy moth infestation was bigger than the state maps indicated, but only one call was received for assistance. The egg masses found on the trees in Upton this fall show that we will be hit harder this coming spring. The home owner should check for egg masses around their yards and near by woods. Paint the masses with creosote, or scrape them into a can of kerosene or soapy water. If anyone is having their yard sprayed, it should be done between the middle of May and middle of June.

I wish to thank public officials, state and district supervisors and the townspeople for their help and cooperation in 1984.

REPORT OF THE PLANNING BOARD

There was considerable activity regarding residential development in Upton in 1984, and the Board expects the pressure for further development to increase in the next few years.

The Planning Board approved plans for a twenty-two (22) lot development by Norman Hill (later conveyed to Casa Builders) located off Forest Street, to be known as Thayer Street and Stearns Road. Also approved were an eleven (11) lot development by Brookside Farms Realty Partnership on the west side of South Street, to be known as Sadler Road, and a five (5) lot development by Doak Martin off Mendon Street, to be known as Pease Road.

Brookside Farms Realty Partnership has submitted another definitive plan for a thirty-seven (37) lot development on the east side of South Street, which is still under consideration as of this writing in January 1985. The same group submitted a preliminary plan for a development of approximately fifteen (15) lots off West River Street.

The condominium development proposed by Casa Corporation for land off Williams Street was reviewed extensively by the Planning Board and the Board of Appeals. The Board of Appeals denied the developer's application for a special permit. A new application must be made and approved before the development can be proceed.

The Planning Board expects that Oak Knoll Land, a development by the Upton Development Co. of approximately ten (10) lots off Grafton Road, will be completed this year.

Revisions to the Upton Subdivision Control Rules and Regulations were enacted regarding filing fees, road grade, minor streets and condominiums. Further revisions are being considered.

The case of *Upton Planning Board v. Upton Zoning Board of Appeals, et al.* (Worcester Superior Court, Civil Action No. 26524), regarding the grant of a variance for a lot lacking the required frontage, was dismissed at the request of the parties, and the applicant's request for a variance was withdrawn.

The Planning Board welcomed new member Stedman Briggs, Jr. following his election in May, 1984. Also welcomed was Dennis Kuhns who

was appointed to replace John Robertson upon Mr. Robertson's resignation in July, 1984.

REPORT OF THE TREE WARDEN

In 1984, 148 trees were removed in the Town of Upton. Thirty-two (32) of these trees were dead, forty-one (41) were dangerous to the public way or removed for the improvement of street drainage. Seventy-five (75) were blown over or split off in heavy winds and wet snow in the big storm in March.

I would like to thank all the people who worked from 6:00 A.M. until midnight to open up the streets of Upton. The heavy wet snow made the job more difficult for the crews. The help of Police, Fire Department and Road Commissioner Henry J. Poirier (retired) made the job of cleaning the streets a faster and more efficient operation.

Thirty-two (32) shade or flowering trees were planted along the town roadsides during 1984. Fifty-two (52) stumps were chipped down below the ground along the town roadsides. The Upton Tree Department had twenty-one (21) emergency calls during the year.

I would like to thank Deputy Tree Warden Leo L. Morin, public officials the Massachusetts Electric Company and the townspeople for their assistance during 1984.

REPORT OF THE BOARD OF WATER AND SEWER COMMISSIONERS

1984 A year of finishing projects:

We received the 1984 Chevrolet pickup from Oste Chevrolet of Boston March 5, 1984. The pickup truck, we feel, is working for our needs extremely well.

We continued to press and we succeeded for the closeout of the Sewerage Extension Project with the State Department of Environmental Quality Engineering, which represents both the State and Federal E.P.A.

The Division of Water Pollution Control determined that the final eligible cost was \$1,482,203 and final state payment was received - \$33,462.

The Massachusetts Division of Water Pollution Control for the Federal Grand Eligible cost of \$1,482,203. The Grant was increased by \$14,852 from \$1,096,800 to \$1,111,652. Final payment was processed and received - \$68,752.

Total water pumped in 1984 at the Glen Avenue Pumping Station - 52,136,200 gallons and West River Pumping Station - 42,365,000 gallons.

We installed new water services to thirteen homes.

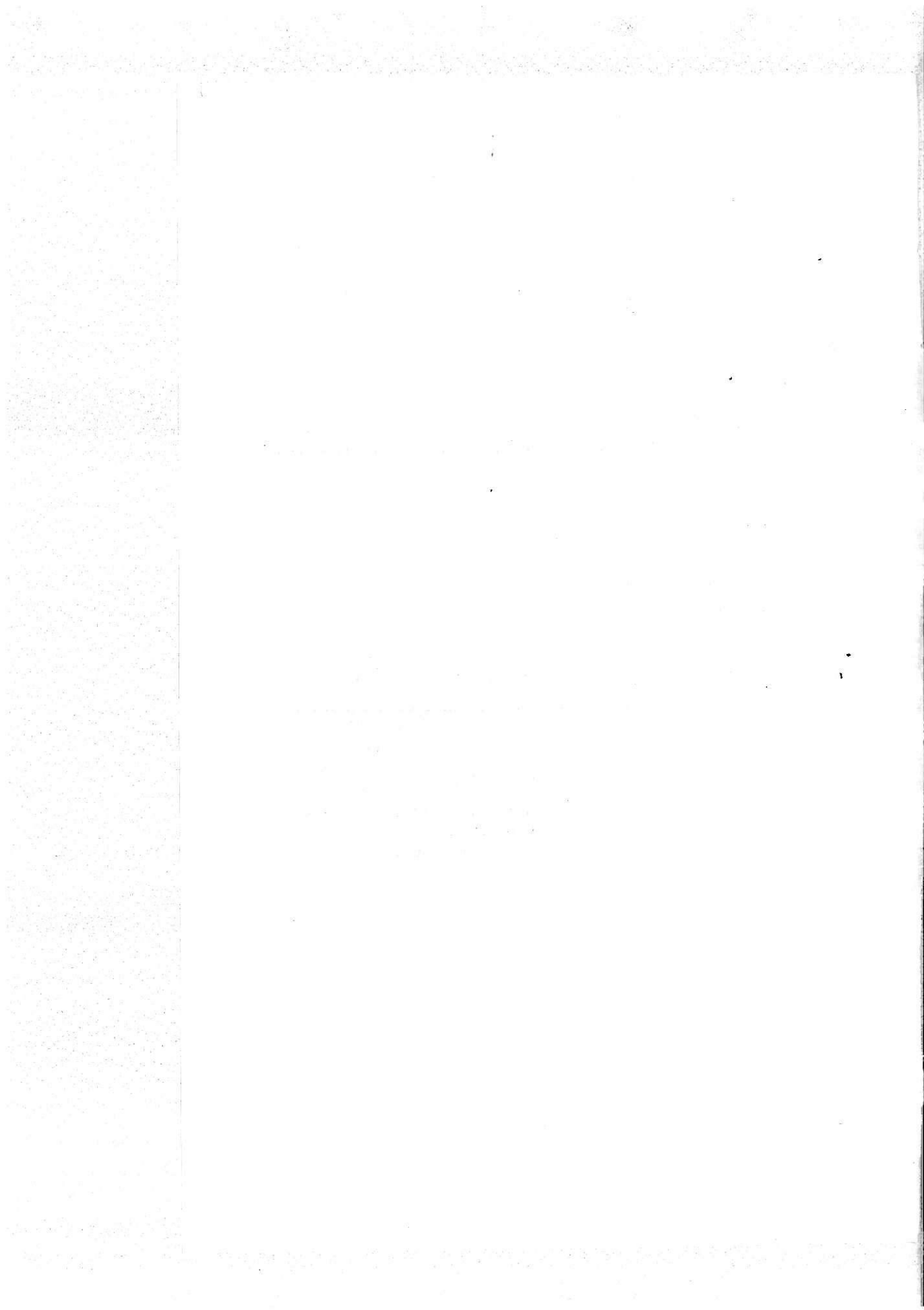
Raw sewerage pumped at the Maple Ave. Waste Water Treatment Plant 61,520,550 gallons.

Regular School Committee meetings are held at the Blackstone Valley Regional Vocational Technical High School, Pleasant Street, Upton, MA on the third Thursday of each month in the school's Conference Room at 7:30 P.M.

DAY SCHOOL

1. Classes for day school students opened August 23, 1983 and concluded June 13, 1984. One hundred and eighty (180) school days were completed. Regular educational/vocational programs were conducted five and one-half (5½) hours per school day. Student progress reports were issued at the end of each Trimester (November, March and June). The dual program of academic study and specific occupational training was accomplished by alternating two-week cycles.
2. Sixteen (16) distinct vocational/technical programs, designed to prepare young people for gainful employment, were conducted. They were: Air Conditioning/Refrigeration, Auto Body, Auto Technology, Carpentry, Culinary Arts/Baking, Computerized Information Processing, Machine Drafting, Electrical, Electronics, Graphic Arts, Health Services, Machine Shop, Metal Fabrication/Sheet Metal, Painting/Decorating, Plant Maintenance, and Plumbing.

3. Special Education services for **one hundred and six** (106) young men and women were provided as prescribed by Individual Education Plans. A very successful program (prototype 502.4), identified as Building and Grounds Maintenance, trained twelve (12) young people for gainful employment.
4. Extra-curricular activities in which male and female students participated included:

Other Activities: Class Officers, Yearbook, Jr./Sr. Prom, Cheerleading, and Red Cross Blood Drive were experienced.

During the week of May 18, 1984, Seniors were treated and honored with a class banquet and a Recognition Night. Distinguished graduates were publicly recognized with scholarships and awards for their educational/vocational performances.

The English Department sponsored a very creative and successful magazine of student writings called "Beaver Tales". The publication was very well received by the School Committee as evidence of the comprehensiveness of the total educational program.

5. A Cooperative Education Program provided one hundred and twenty-two (122) seniors with actual work-experience during the school year. This program has been in place for sixteen (16) years and continues to prove that young people who are educationally and vocationally prepared possess the background for a variety of options upon graduation. Employers have shown great interest and cooperation in this partnership effort for which students are paid for their work at a site.
6. Continuing the practice of serving district towns, a major renovation and construction project was undertaken in the town of Northbridge. Students and instructors of the Carpentry, Electrical, Plumbing, Heating/Ventilation/Air Conditioning, and Painting/Decorating programs began work/training at the old Plummer School in November 1983. The former elementary school was transferred to the Northbridge Council on Aging. The three-story building will be converted into a major center for the elderly containing office space, examination rooms, kitchen facilities, dining room and recreation rooms. The entire building will be retrofitted for energy conservation and for handicapped persons. The project is scheduled to be completed for occupancy in March of 1985.

8. Graduation exercises were held in the James S. Mullaney Gymnasium on Friday evening, May 25, 1984. One hundred and eighty-eight (188) seniors received diplomas and vocational certificates. There were one hundred and fifty-nine (159) male and twenty-nine (29) female graduates. Chairman Anthony F. Rando (Milford) presented the diplomas. Gregory Cofsky (M.A. in Business) a graduate of the Class of 1975, addressed the Class of 1984. Class officers were: Sharon LeBoeuf (Douglas), President; Kim Collamati (Bellingham), Vice-President; Denise Lomartire (Millbury), Secretary; Lynn Brooks (Douglas), Treasurer.

ADULT TRAINING

1. Evening School Programs were conducted in the fall (September to November, 1983) and spring (March to May, 1984). Between the two sessions, two hundred and sixteen (216) adults (175 men and 41 women) paid a tuition to receive training in the following programs: Air Conditioning, Auto Body, Carpentry, Computers, Electrical, Electronics, Machine Shop and Welding. The self-supporting adult training program was offered Tuesday and Wednesday evenings from 6:30 PM to 9:30 PM for sixteen (16) nights each semester.
2. The Basic Electronic Assembler Program, supported entirely with a federal grant, trained eighteen (18) men and women for entry level employment in local electronics companies. The program was conducted from 8:00 AM to 3:00 PM daily during October through March. Age of trainees ranged from 18 years to 59 years. Fourteen (14) of the trainees were gainfully employed after the 500 hours of intensive job preparation. Another program was begun in June of 1984.

PERSONNEL & OTHER

1. Three categories of personnel were employed by the Regional Vocational School District to deliver educational/vocational services. Staffing patterns and numbers of personnel are as follows:

2. The day school population was transported to and from school throughout the thirteen-town district with twenty-two (22) bus routes each school day. In addition, supplemental transportation was provided on Tuesday and Thursday afternoons for students who were detained for a variety of reasons.

CONCLUSION

The school year 1983-84, from all perspectives, was successful. Citizens shared with students in the use of the facilities and program offerings. The Three Seasons Restaurant was used, on a regular basis, from September, to June between the hours of 11 AM to 1 PM, by the public and various organizations for luncheons. The automotive programs were utilized totally as were the graphic arts, metal and construction programs.

The Vocational Regional School District "passed-through" \$744,893 of Chapter 70 (School Aid) funds to the towns of the district as required by the Commonwealth. Approximately 85% of the school's graduates were employed upon completion of the training programs. Approximately 12% of the graduates were accepted at institutions of higher learning (colleges, universities, community colleges and specialized schools).

Long delayed repairs to the facility were begun. The School Committee commissioned the preparation of a codified manual of its school district policies. The Administration inaugurated a study of the school's Program of Studies scheduled for completion in the school year 1984-85.

The School Committee, Administration, Faculty, Advisory Committees, Students and Support Staff express their genuine thanks to all the citizens of the Blackstone Valley Vocational Regional School District for their help and support throughout the past school year.

ANNUAL REPORT MENDON-UPTON REGIONAL SCHOOL DISTRICT

To the Citizens of Mendon and Upton:

A major responsibility of the Mendon-Upton Regional School District is to create a sound educational program for students. This year great emphasis has been placed on the obtainment of this goal. A cooperative spirit between administration, staff, students, and parents has emerged. A basic premise of raising the educational standard has served as the motivational theme improving our quality of education. Organizational, administrative, and instructional objectives have been formulated. The district has embarked on energetic programs to achieve these goals. The programs initiated encompass improvements in the areas of instruction, plant facilities, student support activities, as well as other school related activities.

The improvement of the school curriculum on a K-12 basis is of high priority. Curriculum teams have been formulated to assess curriculum programs and materials for each discipline area. The need to expose students to computer instruction is being surveyed by the staff and a Computer Task Force. Progress in the purchasing of more comprehensive computer hardware has been facilitated by the donation of a sixteen (16) pupil micro-computer laboratory by Data General Corporation to our district.

The gifted and talented program received a boost in the form of grant funds from the State Department of Education. The formation of a Student Intervention Team was established. This team assists students, identified by staff, having behavioral, academic, or school adjustment problems. The professional team concept explores various learning alternatives and strategies to overcome specific student problems.

The development of a School Skills Program has been introduced in the Middle School. This program has helped middle school students make the school educational adjustments essential for academic success.

Various behavioral standards have been raised by the implementation and upgrading of the Student Discipline Code. The Nipmuc Regional High School and Miscoe Hill Middle School staffs are striving to increase student motivation in order to get students to achieve their maximum potential.

The district has taken a firm stand on the use of drugs and alcohol. In-service programs have been implemented to assist staff and students to better understand the effect of drug and alcohol abuse.

Teacher evaluation practices and philosophy have been updated. Greater emphasis has been placed on the importance of teacher evaluation and effective teaching in raising the educational standards of the school district. The district has formed several community based task forces. Included, are the Computer, Building Utilization, Grade Placements and Resource and Advisory. These committees facilitate exchange of ideas between staff and parents. They have proven to be extremely beneficial and reflect the collaborative educational spirit between schools and community necessary in developing a challenging educational system.

The maintenance and improvement of plant facilities is, as always, an important and costly part of the school budget. This year, repairs on the roof at Henry P. Clough School in Mendon and Memorial School in Upton were completed. Grants have been submitted to the Massachusetts Department of Education for partial reimbursement toward the costs of the repairs. The heating system at Henry P. Clough School has been improved, thus creating greater fuel efficiency and savings. An energy study of the two schools has been completed and specific energy related repairs suggested. Planning is underway for the renovation of Nipmuc Regional High School gymnasium floor. State aid is being sought to assist in the cost of the floor replacement.

Administrative reorganization of the schools hot lunch program has improved the financial status and the quality of the food. Last year, the program finished in the red. This year, the customizing of the menu and management changes have enabled the program to repay its debt to the school district and still finish in the black.

The Mendon-Upton Regional School program is, quite obviously, in transition. Higher academic and motivational standards for students are paramount goals. Further organization, administrative, and facility changes are planned to promote a positive teaching/learning environment. New goals and expectations are constantly being developed. Planning for next year is already underway and we look forward to meeting the challenge in the pursuit of improving quality education in the Mendon-Upton Regional School District.

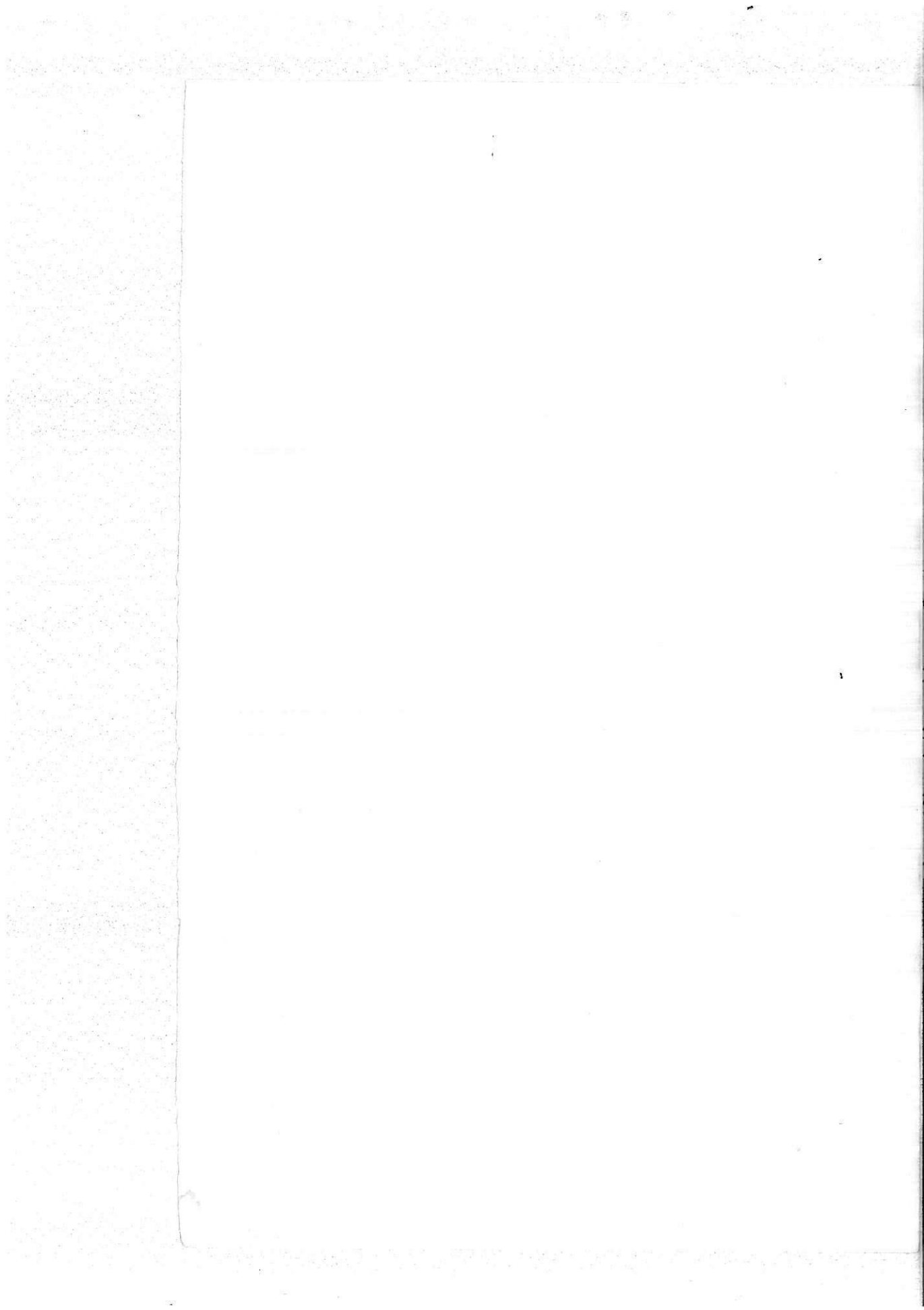
