Eagle Candidate, Sean Hurley

The Selectmen approved the construction of three kiosks to be built by Sean Hurley for his Eagle Scout project. The three kiosks that will be put at the beginning of hiking trails in Upton. Two of the kiosks will be placed on Warren St., and one of them will be placed on Fowler St. Sean told the Board by November of this year.

ADA Transition Plan Presentation CMRPC

Connor Robichaud, CMRPC presented the Plan. The Center for Living & Working, Inc. in partnership with James M. Mazik, AICP – Consulting Services has prepared this Self-evaluation and Transition Plan (“Accessibility Plan” hereafter) on behalf of the Town of Upton to determine its level of compliance under the Americans with Disability Act (ADA) of 1991, as amended in 2008 and 2010.

Economic Development Plan - Dave Ross (approval and adoption)

40 The Economic Development Committee (EDC) Chair Dave Ross presented the Selectmen with a
41 draft of a new Economic Development Plan, using public feedback to restructure the plan after
42 coming before the Upton Board of Selectmen in February. The resulting changes led the Board
43 to pass the plan, with the caveat that any outdated information would be updated to reflect the
44 most recent data available.

51 Economic Development Committee Update - Dave Ross

52 • Route 140 TIP Expansion

53 The state is proposing to work on Route 140 from Williams Street, down through Brook Street.
54 The EDC would like support from the BoS to get the tip project extended a quarter mile. This
55 would bring sidewalks, not only Prospect streets, so it opens safe travel from anybody on
56 Prospect Street coming down and closer to Governor's Landing in terms of sidewalks.

57
58 The Town Manager will reach out to Senator Moore and Rep Muradian to identify a source of
59 funding to help expand this project to beyond what it is today.

61 • Town Center RFP Timing /Future of Risteen Building

62 The discussion on the future of the Risteen building is not around its disposal. The EDC will need
63 to re-issue the RFP for downtown. They had heard that the project was too small of a project,
64 therefore by expanding to include 6 Main Street along with the Church and the parking lots it
65 may be more attractive.

67 Ms. Dwinnell asked for a copy of the previous renovation analysis on the Risteen building and
68 will consider having a workshop with the disability commission, the historical commission to
69 arrive at a consensus.
