43 In a [letter](#) to the Selectmen from the Library Board of Trustees a request was made that the
44 Board of Selectmen investigate access via a ramp to the first floor of the building. Mr. John
45 Roberts, Chair of the Library Trustees gave an historical perspective and the many scenarios to
46 expand the library and make it accessible. Lyn Haggarty and Michelle Antinarelli requested the
47 Selectmen consider two options they have designed to access the Risteen and pursue any
48 available grant funding for access improvements, in particular any opportunity for the Disability
49 Commission to apply for a state grant. It was suggested that this issue be discussed with the
50 Disability Commission as well.
