- Problems with detention basin. No hay bales or any erosion control. Discharging into wetlands.

- CS received a phone call from Upton Police. A collection of shot animals in a pile on left side of Mendon St. They want to know if Con Comm issued a permit – Con Comm did not. It looks like it was used as a dumping ground.

- Con Comm would like to wait on decision to see what NH has to say. M. Penko will draft a letter through e-mail addressing Con Comms's concerns to Natural Heritage.

8:35 Discussion Mendon St. church present: Bob with G&H

- Road is in. Some of parking lot is within the 100' buffer. Everything else is outside the 100'
- Church currently not interested in selling front of property for house lots or ball fields.

- 20 parking spaces go into 30' buffer
- CS concerned about 1) sequencing of events and 2) where would snow be removed to.

- Fill is less than ½ foot to 2'. Change in elevation
- Trucks will be taking tree stumps (chips vs. stock pile)
- MP asked if anyone considered if any replanting of trees. They said its heavily wooded and there are no plans to replant.
- Sandy L. asked if they know who the contractor is yet.
- Con Comm agreed there was no need for a site visit.
- CS closed the hearing – will issue an OOC.

- KP updated UCC 1) Natural rock next to jetty, 2) set of trees to be planted (Black Gum).
- Updates are in the letter from Mark Allen
- Wheelchair access to deck (one) near the entrance to cemetery.

- Precast blocks on crushed stone.
