9 Classification with the Upton Board of Assessors on November 15, 2022, at 7:00 pm.

12 about whether the town should adopt different rates for the different classes of property.
13 Taxpayers are welcome to participate and present their views orally or in writing. Written
14 requests must be received prior to the meeting no later than November 1, 2022, by 4:00 p.m.
15 Any person interested or wishing to be heard should call or sign into the remote meeting.

17 Upton has four classes of property in the town and one tax rate. The classes are residential,
18 commercial, industrial, and personal. Assessors are planning to recommend a single rate for all
19 four classes of property. If you have any questions, please feel free to contact the Assessor's
20 Office at 508-529-1002.
