News, Events and Information from Town Departments

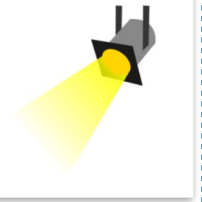
Board and Committees:

This month we are highlighting a few committees that have current openings:

Planning Board -

The Planning Board focuses on a long term commitment to economic vitality, environmental integrity, and development design through the highest quality planning, implementation and development. *Meetings are held on 2nd & 4th Tuesdays of every month*



Lakes, Ponds & Streams -

The Lakes, Ponds & Streams Committee develop policy & implement actions to preserve the healthy ecology of the bodies of water in town. *Meeting are held once per month*

Community Preservation -

The Community Preservation Committee is responsible for evaluating requests to use Community Preservation Acts Funds, for open space, historical preservation, community housing and recreational purposes. *Meetings are the 1st Wednesday of every month*

Land Use and Inspectional Services:

On August 6, 2024 the Governor signed into law the Affordable Home Act. Part of the Act included a provision to allow **Accessory Dwelling Units (ADUs)**



by-right in every residential zoning district in the State, enabling homeowners to take advantage of the new use. The Upton Department of Land Use and Inspectional Services has created a resource about ADUs.
